## Title: Surplus Land Conveyance, Route 624, Richmond County

**WHEREAS**, in connection with Route 624, State Highway Project 0624-079-148, RW-201, the Commonwealth acquired certain land from Jesse M. Dustin and Jacqueline C. Dustin, Trustees of the Jesse M. and Jacqueline C. Dustin Revocable Trust, by Deed dated October 12, 2005, recorded as Instrument Number 0501487, in the Office of the Clerk of the Circuit Court of Richmond County, Virginia; and

WHEREAS, the Acting Commonwealth Transportation Commissioner has certified in writing that the land containing 0.329 acre, more or less, as shown on the plans for State Highway Project 0624-079-148, RW-201, and lying northeast of and adjacent to the northeast revised proposed right of way line of Route 624 from a point 29.54 feet opposite Station 26+32.96 (Relocated Route 624 centerline) to a point 40 feet opposite Station 27+60.00 (Relocated Route 624 centerline) was acquired incidental to the construction, reconstruction, alteration, maintenance and repair of Route 624 and does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the Secondary System of State Highways; and

**WHEREAS**, this conveyance is to be made in accordance and compliance with the provisions and notice requirements of Sections 33.1-154 and 33.1-223.2:2 of the *Code of Virginia* (1950), as amended; and

**WHEREAS**, the adjacent landowner has requested that the surplus land be conveyed.

**NOW, THEREFORE, BE IT RESOLVED**, in accordance and compliance with the provisions and notice requirements of Sections 33.1-154 and 33.1-223.2:2 of the *Code of*
