### RESOLUTION OF THE COMMONWEALTH TRANSPORTATION BOARD

October 20, 2010

#### MOTION

#### **Title: Arlington County Maintenance Payments FY 2010-2011**

**WHEREAS**, the Commonwealth Transportation Board approved the transfer of Columbia Pike, State Route 244 located in Arlington County from the primary system of state highways to Arlington County's local road system effective October 1, 2010 pursuant to §33.1-35 of the *Code of Virginia*, 1950, as amended, upon which time the roads shall cease to be a part of the primary system of state highways and will be included in the local system maintained by Arlington County which shall receive payment for this route in accordance with §33.1-23.5:1; and

**WHEREAS**, Section 33.1-23.5:1 of the *Code of Virginia*, as amended, provides for calculating annual maintenance payments to counties which have withdrawn from the secondary system of state highways and the method by which payment of these allocations are to be made; and

**WHEREAS**, Arlington County has withdrawn from the secondary system of state highways; and

**WHEREAS**, one of the factors on which maintenance payments shall be based is the number of lane-miles of such roads or streets accepted for maintenance by the local governing body; and

**WHEREAS**, the rate of payment for these lane-miles is set forth in Section 33.1-23.5:1 of the *Code of Virginia*; and

**WHEREAS**, Item 455 of Chapter 874 of the 2010 Acts of Assembly includes a provision authorizing the Commonwealth Transportation Board to adjust payments to localities; and

**WHEREAS**, the CTB previously approved payment rates for FY 2010-2011, however, the mileage added to Arlington County's local road system requires that the payment now be adjusted; and

**WHEREAS**, no payment shall be made without the approval of the CTB.

**NOW, THEREFORE, BE IT RESOLVED**, that total payment and quarterly payments for the remainder of Fiscal Year 2010-2011 to Arlington County is revised, beginning on the effective date of the transfer, as stated on the attached tabulation (Attachment A).

**BE IT FURTHER RESOLVED**, that \$159,600 is transferred from the Northern Virginia District's FY 2011 share of the Primary System Maintenance Program (Program 60402) to Financial Assistance for Localities County Maintenance Program (Program 60702) to provide for the increased Financial Assistance for County Road Maintenance payment for Arlington County, as detailed on the attached schedule (Attachment B).

**BE IT FURTHER RESOLVED**, that the quarterly amount for Arlington County is hereby approved for payment as indicated on the attached tabulation.
