Title: Revenue Sharing Reallocation
County of Wise

WHEREAS, Section 33.1-23.05 of the *Code of Virginia* (1950), as amended (“Code”) prescribes that from funds made available by the General Assembly, the Commonwealth Transportation Board (CTB) may make an equivalent matching allocation to any locality for the improvement, construction, or reconstruction of the highway systems within such locality; and,

WHEREAS, the governing body of the County of Wise elected to participate in this program for Fiscal Year 2008, and, with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and,

WHEREAS, the governing body of the County of Wise has, by appropriate resolution, requested Jaybird Branch Road, Route 663 (UPC 94646), Creek Hill Road, Route 651 (UPC 94648), and East Stone Gap, Route 613 (UPC 56766) to be established as a revenue sharing projects; and,

WHEREAS the governing body of the County of Wise has, by appropriate resolution requested that the funds set forth herein be transferred to Jaybird Branch Road, Route 663 (UPC 94646), Creek Hill Road, Route 651 (UPC 94648), and East Stone Gap, Route 613 (UPC 56766) for specific eligible items of work, as indicated herein; and,

WHEREAS, these items of work fall within the intent of Section 33.1-23.05 of the *Code*, and comply with VDOT’s guidelines for the use of such funds.
