**Title: Revenue Sharing Reallocation  
County of Buchanan**

**WHEREAS**, Section 33.1-23.05 of the *Code of Virginia* (1950), as amended (“Code”) prescribes that from funds made available by the General Assembly, the Commonwealth Transportation Board (CTB) may make an equivalent matching allocation to any locality for the improvement, construction, or reconstruction of the highway systems within such locality; and

**WHEREAS**, the governing body of the County of Buchanan elected to participate in this program for Fiscal Year 2012, and, with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and,

**WHEREAS**, the governing body of the County of Buchanan has, by appropriate [resolution](#), requested Route 744 (UPC 102692), to be established as a revenue sharing project,

**WHEREAS** the governing body of the County of Buchanan has, by appropriate resolution requested that the funds set forth herein be transferred to Route 744 (UPC 102692) for specific eligible items of work, as indicated herein; and,

**WHEREAS**, these items of work fall within the intent of Section 33.1-23.05 of the *Code*, and comply with VDOT’s guidelines for the use of such funds.
