RESOLUTION

AMENDING THE WISE COUNTY 2012-2013 THROUGH 2017-2018 SECONDARY SIX YEAR IMPROVEMENT PLAN TO ADD THE FOLLOWING PROJECT:

UPC 94647; Proj.: 0651-097-T21 – Bull Hill Rd. – Fr.: 2.55 Mi. N. Rte. Alt. 58, To: 2.65 Mi. N. Rte. Alt. 58; .10 mi.

AND REQUESTING THE FOLLOWING PROJECT BE DESIGNATED AS AN ELIGIBLE REVENUE SHARING PROJECT:

UPC 94647; Proj.: 0651-097-T21 – Bull Hill Rd. – Fr.: 2.55 Mi. N. Rte. Alt. 58, To: 2.65 Mi. N. Rte. Alt. 58; .10 mi.

WHEREAS, the Wise County Board of Supervisors (Board) developed Project 0651-097-T21 UPC 94647 as a Coal Severance Fund project, and,

WHEREAS, the Virginia Department of Transportation, working with the Board had developed Coal Severance Fund Project 0651-097-T22 UPC 94648 – Creek Hill Road located in the Sandy Ridge area – Fr.: 1.00 Mi. N. Rte. 654, To: 1.50 Mi. N. Rte. 654: .50 Mi. which was later designated as a Revenue Sharing Project and Revenue Sharing funds were transferred to it, and now due to the fact that donated right of way will not be able to be secured for the project the Board no longer wishes to pursue that project, leaving a balance of Revenue Sharing funds, and,

WHEREAS, the Board wishes to use some of those available surplus funds to maintain the advertisement of the aforementioned project 0651-097-T21 UPC 94647, and,

WHEREAS, Project 0651-097-T21 UPC 94647 is not currently on the Wise County 2012-2013 through 2017 - 2018 Secondary Six Year Improvement Plan, and,

WHEREAS, the Board wishes to amend their 2012-2013 through 2017-2018 Secondary Six Year Improvement Plan to include Project 0651-097-T21 UPC 94647, and,

WHEREAS, the Board dedicated monies to Revenue Sharing Project 0651-097-T22 UPC 94648, and that project is no longer going to be pursued, leaving a balance of funds, and,

WHEREAS, the following two active projects in Wise County need additional funds in order to meet current advertisement dates: Project 0651-097-T21 UPC 94647 and Project 0613-097-502 UPC 56766, and,

WHEREAS, Project 0613-097-502 UPC 56766, Route 613 in East Stone Gap. was previously designated as a Revenue Sharing project, and the Board wishes to have project 0651-097-T21 UPC 94647 considered and designated as a Revenue Sharing Project, and,

WHEREAS, Project 0613-097-502 UPC 56766 is currently on the Wise County 2012-2013 through 2017-2018 Secondary Six Year Improvement Plan, and Project 0651-097-T21 UPC 94647 is being added to the same by amending said Secondary Six Year Improvement Plan by this Resolution,


NOW, THEREFORE BE IT RESOLVED, by Board that the Wise County 2012-2013 through 2017-2018 Secondary Six Year Improvement Plan be amended to included Project 0651-097-T21 UPC 94647.

BE IT FURTHER RESOLVED, by the Board that the following project be considered and designated as a Revenue Sharing Project: Project 0651-097-T21 UPC 94647; and that the following amounts be transferred from Project 0651-087-T22 UPC 94648: \$374,759.00 to Project 0651-097-T21 UPC 94647 and \$189,588 (or any remaining balance) to Project 0613-097-502 UPC 56766; and that these actions be placed on the agenda of the next meeting of the Commonwealth Transportation Board for their approval of this Resolution adopted by the Wise County Board of Supervisors.


BE IT FURTHER RESOLVED, that a certified copy of this Resolution be forwarded to the Residency Administrator for the Virginia Department of Transportation.
