**Title: Revenue Sharing Reallocation  
County of Chesterfield**

**WHEREAS**, Section 33.1-23.05 of the *Code of Virginia* (1950), as amended, prescribes that from funds made available by the General Assembly, the Commonwealth Transportation Board (CTB) may make an equivalent matching allocation to any locality for the improvement, construction, or reconstruction of the highway systems within such locality; and

**WHEREAS**, the governing body of the County of Chesterfield elected to participate in this program for Fiscal Year 2009, and, with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and,

**WHEREAS**, the governing body of the County of Chesterfield has, by appropriate resolution, requested a secondary road project, E. River Road (UPC 104083), to be established as a revenue sharing project; and,

**WHEREAS** the governing body of the County of Chesterfield has, by appropriate resolution requested that the funds set forth herein be transferred to E. River Road (UPC 104083) for specific eligible items of work, as indicated herein; and,

**WHEREAS**, these items of work fall within the intent of Section 33.1-23.05 of the *Code*, of Virginia and comply with VDOT's guidelines for the use of such funds.
