RESOLUTION R 38/14

A RESOLUTION TO REQUEST THE COMMONWEALTH TRANSPORTATION BOARD TO DESIGNATE THE IMPROVEMENTS ON RTE 639 LADYSMITH ROAD, UPC 106670 AS A REVENUE SHARING PROJECT, TRANSFER SURPLUS REVENUE SHARING FUNDS TO ACCELERATE DEVELOPMENT OF THE PROJECT, AND REQUEST TO AMEND THE FY2015-2020 SSYP TO INCLUDE THE IMPROVEMENTS ON RTE 639 LADYSMITH ROAD, UPC 106670 AS A SECONDARY ROADWAY PRIORITY.

WHEREAS, the Caroline County Board of Supervisors held its regular meeting on December 9, 2014, at the Caroline County Community Services Center, and

WHEREAS, Section 33.2-357 of the Code of Virginia outlines how the CTB shall allocate funds to and manage the Revenue Sharing Program; and

WHEREAS, Section 33.2-331 of the Code of Virginia outlines the procedures for updates to the six year plan for secondary highways in each county; and

WHEREAS, UPC 78621 – Reconstruction of Ladysmith Road is a current project in the VDOT Six Year Improvement Program (SYIP) and is a priority on Caroline County's Secondary Six Year Plan (SSYP); and

WHEREAS, UPC 78621 – Reconstruction of Ladysmith Road received FY2006 and FY2008 Revenue Sharing program funds to aid in the financing of the construction phase of the project; and

WHEREAS, UPC 78621 – Reconstruction of Ladysmith Road received favorable bids for construction that have resulted in a surplus of Revenue Sharing Funds being identified on the project; and

WHEREAS, Caroline County has applied for FY2016 Revenue Sharing for an additional project for improvements on Rte 639 Ladysmith Road, UPC 106670, and wishes to accelerate the project development of this project; and

WHEREAS, Caroline County, in coordination with staff from the Virginia Department of Transportation – Fredericksburg District, is requesting to transfer \$550,000 in surplus Revenue Sharing funds (\$275,000 County match paid to VDOT) from UPC 78621 – Reconstruction of Ladysmith Road to the next proposed improvements on Rte 639 – Ladysmith Road, UPC 106670, to fund the current Preliminary Engineering phase estimate for that project; and

WHEREAS, Caroline County has deemed the improvements on Rte 639 – Ladysmith Road, UPC 106670 as its next Secondary Roadway Priority and intends to fully fund the project with Revenue Sharing program funds; and

WHEREAS, the County recognizes that current preliminary cost estimates for the improvements on Rte 639 – Ladysmith Road, UPC 106670, provided by the Virginia Department of Transportation are subject to change as project development progresses; and

WHEREAS, Caroline County intends to request that VDOT administer the proposed improvements on Rte 639 – Ladysmith Road, UPC 106670, and that this action will not disrupt existing funding commitments on VDOT's 24 month advertisement schedule;

NOW THEREFORE BE IT RESOLVED, the Caroline County Board of Supervisors does go on record as requesting the Commonwealth Transportation Board to designate the improvements on Rte 639 – Ladysmith Road, UPC 106670, as a Revenue Sharing Project, to approve the transfer of surplus Revenue Sharing funds from an existing project as previously described, and requests to amend the approved FY2015-2020 SSYP for Caroline County to include the proposed improvements on Rte 639 – Ladysmith Road, UPC 106670, as a Secondary Roadway Priority.
