**WHEREAS**, William H. Fralin, Jr., has served on the Commonwealth Transportation Board (Board) since 2013, representing the Salem Construction District, having been appointed by Governor Robert F. McDonnell; and

**WHEREAS**, Mr. Fralin has fulfilled his duties with leadership, dedication, forthrightness and commitment; and

**WHEREAS**, prior to his Board service, Mr. Fralin represented the 17<sup>th</sup> District as a member of the Virginia House of Delegates from 2004 – 2010, where he served on the Courts of Justice, Transportation, Education, Privileges and Elections, and General Laws Committees; and

**WHEREAS**, Mr. Fralin supplemented his legislative experience on the House standing committees with service on a variety of bodies whose purpose was to assess and improve the quality and competitiveness of the Commonwealth's transportation network, including the Joint Subcommittee to Study Virginia's Future Transportation Needs, and the Interstate Transportation Compact Commission; and

**WHEREAS**, after leaving the General Assembly, he also served as Chairman of the Virginia Port Authority, where he worked with the state legislature to strengthen the port's economic development capabilities; and

## CTB Decision Brief

### Commending William H. Fralin, Jr.

**Issue:** William H. Fralin, Jr., who has served on the Commonwealth Transportation Board (Board) since 2013, representing the Salem Construction District, has stated his intention to limit his Board service to one term, which expires on June 30, 2017. The Board traditionally commemorates departing members by approving a resolution memorializing their service to the Commonwealth.

**Facts:** Mr. Fralin's tenure on the Board continued a long record of public service. Prior to his Board membership, Mr. Fralin represented the 17<sup>th</sup> District as a member of the Virginia House of Delegates from 2004 – 2010. During his six years in office, he served on the Courts of Justice, Transportation, Education, Privileges and Elections, and General Laws Committees. Mr. Fralin supplemented his legislative experience on these standing committees with service on a number of transportation-related bodies, such as the Joint Subcommittee to Study Virginia's Future Transportation Needs, the Interstate Transportation Compact Commission. After leaving the General Assembly, he also served as Chairman of the Virginia Port Authority, where he worked with the state legislature to strengthen the port's economic development capabilities.

Mr. Fralin's public service has not been restricted to transportation issues; he has served on a variety of bodies whose purpose is to improve the quality of life for Virginia's citizens, including the Virginia Commission on Youth, the Board of the Roanoke Higher Education Authority, and the Virginia Recreational Facilities Board.
