<u>Title: Location Approval for the Redbud Road (Route 661) Relocation</u>

Frederick County

WHEREAS, State Highway Project 0661-034-801 (UPC 101435) will relocate Redbud Road (Route 661) to a new alignment. The relocated road will be named Norman Drive (the "Project") and will be on a new alignment from the Redbud Road/Milburn Road intersection to approximately 2,000-feet to the north to tie in with Snowden Bridge Boulevard. The project is being developed in preparation for future interchange modifications at Interstate 81, Exit 317, at Route 11 (Martinsburg Pike) in Frederick County.

WHEREAS, in accordance with Va. Code § 33.2-208 and the policies and regulations of the Commonwealth Transportation Board (CTB), including 24 VAC 30-380-10, a combined location and design public hearing (the "Hearing") was held in Frederick County, Virginia, on October 2, 2024, at Millbrook High School, 251 First Woods Drive, in the City of Winchester, for the purpose of considering the location of the Project, as shown on Attachment A; and

WHEREAS, proper notice of the Hearing and the proposed Project were given in advance, and all those present were given a full opportunity to express their opinions and recommendations on the Project, and their statements have been duly recorded; and

WHEREAS, the economic, social and environmental effects of the Project have been examined and given proper consideration and this evidence, along with all other relevant evidence has been carefully reviewed; and

WHEREAS, the Virginia Department of Transportation's Staunton District Environmental Office has performed environmental reviews and coordination to obtain information about environmental resources in the project vicinity; to provide natural and historic resource agencies an opportunity to review and comment on the project during its development; and to identify opportunities for avoidance, minimization and mitigation of potential environmental impacts; and

WHEREAS, the Project is not programmed with any federal funding and is therefore exempt from the National Environmental Policy Act; and

WHEREAS, the County Administrator for Frederick County provided a letter of support on February 10, 2025; and

WHEREAS, review of all data resulted in VDOT's recommendation that the location of the Project as presented at the Hearing be approved.

NOW, THEREFORE, BE IT RESOLVED, that, in accordance with Va. Code § 33.2-208, the CTB hereby approves the location of the Project as proposed and presented at the October 2, 2024, Hearing.

Commonwealth Transportation Board (CTB) Decision Brief <u>Location Approval</u> <u>Redbud Road (Route 661) Roadway Relocation Project</u> <u>Frederick County</u>

Issue: Under Va. Code § 33.2-208, the CTB is required to locate and establish the routes to be followed by the highways comprising the systems of state highways.

Facts:

- The purpose of the Project is to relocate Redbud Road (Route 661) to a new alignment. The relocated road will be named Norman Drive (the "Project") and will be on a new alignment from the Redbud Road/Milburn Road intersection to approximately 2,000 feet to the north to tie in with Snowden Bridge Boulevard. The project is being developed in preparation for future interchange modifications at Interstate 81, Exit 317, at Route 11 (Martinsburg Pike) in Frederick County.
- In accordance with Va. Code § 33.2-208 and the policies and regulations of the CTB, including 24 VAC 30-380-10, a combined location and design public hearing was held in Frederick County, Virginia, on October 2, 2024, at Millbrook High School, 251 First Woods Drive, in the City of Winchester, for the purpose of considering the location of the Project, as shown on Attachment A.
- Virginia Department of Transportation's Staunton District Environmental Office has performed environmental reviews and coordination to obtain information about environmental resources in the project vicinity; to provide natural and historic resource agencies an opportunity to review and comment on the project during its development; and to identify opportunities for avoidance, minimization and mitigation of potential environmental impacts. The Project is not programmed with any federal funding and is therefore exempt from the National Environmental Policy Act.
- On February 10, 2025, the Frederick County Administrator provided a letter of support for the proposed alignment location of Route 661 (Redbud Road) Roadway Relocation Project proposed and presented at the public hearing. See attached

Recommendations: The Virginia Department of Transportation recommends approval of the proposed alignment for the location of the Project as proposed and presented at the Location Public Hearing and shown on the attached exhibit.

Action Required by CTB: Section § 33.2-208 of the *Code of Virginia*, requires the majority vote of the CTB to locate and establish the routes to be followed by the roads comprising systems of state highways between points designated in the establishment of such systems.

Result, if Approved: If approved by the CTB, the Project will move forward to the design phase.

Options: Approve, Deny or Defer

Public Comments/Reaction: Frederick County held a Location and Design Public Hearing on October 2, 2024. Citizens were able to view displays and plan sets, provide written comments, and submitted emails with comments.



PROJECT PURPOSE - The project will relocate a portion of Route 661 (Redbud Road) in preparation for future interchange modifications at Interstate 81, exit 317 at Route 11 (Martinsburg Pike) in Frederick County. The relocated road will be named Norman Drive and will be on a new alignment from the Redbud Road / Milburn Road intersection to approximately 2,000-feet to the north to tie in with Snowden Bridge Boulevard. The design will include the following major design features:

- Two 12-foot travel lanes in each direction with 4-foot paved shoulders in the typical roadway section
- A new T-intersection at existing Milburn Road
- A new cul-de-sac on the western end of existing Redbud Road approximately 0.33 miles south of Martinsburg Pike that will eliminate the existing Redbud Road intersection with Route 11
- Stormwater management facilities




Figure 1 - Typical Sections - Public Hearing Display




Figure 2 - Typical Sections - Plan Set - Norman Drive




Figure 3 - Typical Section - Plan Set - Milburn Road

ADVERTISEMENT – Construction is anticipated to begin in Late 2025

RIGHT OF WAY – The construction of the project will not require the displacement of any families, businesses or non-profit organizations.

As we further develop and finalize the development of this project, additional easements for utility relocation may be required beyond the proposed right of way shown on the public hearing

plans. The property owners will be informed of the exact location of the easements during the right of way acquisition process and prior to construction.

TRAFFIC DATA – In 2024 Route 661 (Redbud Road) had an average daily traffic count of 3,900 vehicles per day. By the design year 2048 the estimated average daily traffic volume will be 8,018 vehicles per day.

WHEREAS, Section 33.2-214(B) of the *Code of Virginia* requires the Commonwealth Transportation Board (Board) to adopt by July 1st of each year a Six-Year Improvement Program (Program) of anticipated projects and programs. After due consideration, the Board adopted a Fiscal Years 2025-2030 Program on June 18, 2024; and

WHEREAS, the Board authorized the Commissioner, or his designee, to make transfers of allocations programmed to projects in the Six-Year Improvement Program of projects and programs for Fiscal Years 2025 through 2030 to release funds no longer needed for the delivery of the projects and to provide additional allocations to support the delivery of eligible projects in the Six-Year Improvement Program of projects and programs for Fiscal Years 2025 through 2030 consistent with Commonwealth Transportation Board priorities for programming funds, federal/state eligibility requirements, and according to the following thresholds based on the recipient project; and

WHEREAS, the Board directed that (a) the Commissioner shall notify the Board on a monthly basis should such transfers or allocations be made; and (b) the Commissioner shall bring

requests for transfers of allocations exceeding the established thresholds to the Board on a monthly basis for its approval prior to taking any action to record or award such action; and

WHEREAS, the Board is being presented a list of the transfers exceeding the established thresholds attached to this resolution and agrees that the transfers are appropriate.

NOW THEREFORE, BE IT RESOLVED, by the Commonwealth Transportation Board, that the attached list of transfer requests exceeding the established thresholds is approved and the specified funds shall be transferred to the recipient project(s) as set forth in the attached list to meet the Board's statutory requirements and policy goals.

CTB Decision Brief

FY2025-2030 Six-Year Improvement Program Transfers January 11, 2025 through February 14, 2025

Issue: Each year the Commonwealth Transportation Board (CTB) must adopt a Six-Year Improvement Program (Program) in accordance with statutes and federal regulations. Throughout the year, it may become necessary to transfer funds between projects to have allocations available to continue and/or initiate projects and programs adopted in the Program.

Facts: On June 18, 2024, the CTB granted authority to the Commissioner of Highways (Commissioner), or his designee, to make transfers of allocations programmed to projects in the approved Six-Year Improvement Program of projects and programs for Fiscal Years 2025 through 2030 (the Program) to release funds no longer needed for the delivery of the projects and to provide additional allocations to support the delivery of eligible projects in the Program consistent with Commonwealth Transportation Board priorities for programming funds, federal/state eligibility requirements, and according to the following thresholds based on the recipient project:

Total Cost Estimate	Threshold
<\$5 million	up to a 20% increase in total allocations
\$5 million to \$10 million	up to a \$1 million increase in total allocations
>\$10 million	up to a 10% increase in total allocations up to a
	maximum of \$5 million increase in total allocations

In addition, the CTB resolved that the Commissioner should bring requests for transfers of allocations exceeding the established thresholds to the CTB on a monthly basis for its approval prior to taking any action to record or award such action.

The CTB will be presented with a resolution for formal vote to approve the transfer of funds exceeding the established thresholds. The list of transfers from January 11, 2025 through February 14, 2025 is attached.

Recommendations: VDOT recommends the approval of the transfers exceeding the established thresholds from donor projects to projects that meet the CTB's statutory requirements and policy goals.

Action Required by CTB: The CTB will be presented with a resolution for a formal vote to adopt changes to the Program that include transfers of allocated funds exceeding the established thresholds from donor projects to projects that meet the CTB's statutory requirements and policy goals.

Result, if Approved: If approved, the funds will be transferred from the donor projects to projects that meet the CTB's statutory requirements and policy goals.

WHEREAS, Section 33.2-1600 of the *Code of Virginia* declares it to be in the public interest that access railroad tracks and facilities be constructed to certain industrial commercial sites where rail freight service is or may be needed by new or substantially expanded industry; and

WHEREAS, The DeLong Co., Inc. applied for RIA grant funds in the amount of \$750,000 to rehabilitate 4,200 feet of track and construct 3,200 feet of new track to serve its facility in the City of Portsmouth, Virginia; (Project) and

WHEREAS, the Department of Rail and Public Transportation (DRPT) evaluated the Project in accordance with the Commonwealth Transportation Board's (Board) Rail Industrial Access Policy and, because the Project scored 50 or more points, has recommended its approval; and

WHEREAS, the City of Portsmouth, Virginia has, by resolution dated January 14, 2025, shown support for the application for RIA funds by The DeLong Co., Inc. for use at its facility located in the City of Portsmouth; and

WHEREAS, CSX Transportation, by letter dated October 22, 2024, has indicated its support for The DeLong Co., Inc. Project and has agreed to serve the facility; and

WHEREAS, the funding request falls within the intent of Section 33.2-1600 of the *Code of Virginia*, and because the Project is in accordance with the provisions of the Board's Policy on the use of Industrial Access Railroad Track funds, funding may be allocated to this Project; and

WHEREAS, the Board believes that this Project is for the common good of a region of the Commonwealth and serves a public purpose.

NOW THEREFORE, BE IT RESOLVED, that the Board hereby approves that \$750,000 of the RIA Fund be provided to The DeLong Co., Inc. to rehabilitate 4,200 feet of track and construct 3,200 feet of new track subject to the following requirements:

- 1. All necessary right of way and utility adjustments must be provided at no cost to the Commonwealth;
- 2. All costs above the \$750,000 RIA grant must be borne by The DeLong Co., Inc. or sources other than those administered by DRPT;
- 3. Execution of an agreement acceptable to the Director of DRPT; and
- 4. Execution of a contractual commitment by The DeLong Co., Inc. to maintain the track and make repayment of any costs related to the future relocation or removal of such track and facilities, in form acceptable to the Director of DRPT.

CTB Decision Brief Rail Industrial Access Applicant Location: City of Portsmouth, Virginia The DeLong Co., Inc.

Summary: The DeLong Co., Inc., is a Wisconsin-based company that specializes in containerized agricultural exports. DeLong currently operates transload facilities in Illinois, Kansas, Nebraska, Ohio, and New Jersey. The Portsmouth, Virginia, location will be its newest transload facility. The purpose of this process is to aid in the movement of procuring, processing, and globally distributing grains, oilseeds, and byproducts such as dried distiller grains and soybean meals. DeLong has applied for Rail Industrial Access grant funds in the amount of \$750,000 to rehabilitate 4,200 feet of track and construct 3,200 feet of new track to serve its investment in the City of Portsmouth, Virginia.

DRPT has evaluated the Project in accordance with the CTB's Rail Industrial Access policy. The Project scores 54 points. Proposed Projects must reach a 50-point threshold to receive a recommendation by DRPT staff. For this project:

- The Applicant plans 3,000 new rail cars annually.
- The minimum threshold for carloads is 301 carloads annually.
- The Applicant commits to 12 new jobs.
- The Applicant's new and rehabilitated rail spur will divert approximately 10,200 trucks from Virginia highways per year.
- The total capital investment in the facility is estimated at \$26.8M.
- The total railroad track rehabilitation and construction cost is estimated at \$2.2M.
- There will be a claw-back provision in the grant Agreement for failure to meet performance requirements based on the CTB adopted program performance policies.

Source of State Funds: FY 2025 Industrial, Airport, and Rail Access Fund

Recommendation: In accordance with the CTB Rail Industrial Access policy, DRPT recommends the Board approve the project.

Action Required by CTB: CTB policy for Rail Industrial Access requires Board action on the resolution.

Title: Action to Approve the Locations Selected for Study in the Project Pipeline Program

WHEREAS, § 2.2-229 of the Code of Virginia establishes the Office of Intermodal Planning and Investment (OIPI) within the Office of the Secretary of Transportation, and charges OIPI to assist the Commonwealth Transportation Board (Board) in the development of a comprehensive, multimodal transportation policy, which may be developed as part of the Statewide Transportation Plan pursuant to § 33.2-353; and

WHEREAS, § 2.2-229 also establishes OIPI's responsibility to undertake, identify, coordinate, and oversee studies of potential highway, transit, rail, and other improvements or strategies, to help address needs identified in the Statewide Transportation Plan pursuant to § 33.2-353; and

WHEREAS, a policy framework for the VTrans Multimodal Project Development Pipeline (hereafter referred to as the Project Pipeline) was presented to the Board on May 20, 2020 (VTrans Multimodal Project Development Pipeline) and February 17, 2021 (VTrans Multimodal Project Pipeline), and relies on the prioritized VTrans Mid-term Needs to optimize the return on investments and ensure transparency, accountability, and efficient delivery of transportation programs, while also promoting performance-based planning and programming per the VTrans Guiding Principles; and

WHEREAS, the Board, pursuant to its action on March 17, 2021, requires that VDOT and DRPT funds for corridor or facility planning and advance activities, relating to concepts addressing a capacity need of the surface transportation network shall be limited to the Statewide

and Construction District Priority 1 Locations established per the Policy to Identify and Prioritize VTrans Mid-term Needs; and,

WHEREAS, each Board member, pursuant to the same action, may also select one VTrans Mid-term Need for the purposes of study that addresses corridor or facility planning and advanced activities; and,

WHEREAS, the Board, pursuant to its action on December 8, 2021, expanded eligibility of planning and advance activities for the Project Pipeline Program to include Statewide and Construction District Priority 2 Locations; and,

WHEREAS, OIPI briefed the Board on December 4, 2024 on the Project Pipeline study locations, and in coordination with VDOT and DRPT staff, subsequently met with each Board member to discuss the identified locations and have made adjustments based on feedback; and,

NOW THEREFORE BE IT RESOLVED, the Board hereby approves the proposed list of Project Pipeline Study Locations in Attachment A.

BE IT FURTHER RESOLVED, by the Commonwealth Transportation Board, that the projects shown in the Attachment A are added to the Six-Year Improvement Program of projects and programs for Fiscal Years 2025 through 2030 and the transfers of allocations necessary to fully fund them are approved.

BE IT FURTHER RESOLVED, OIPI shall utilize the State funding set-aside by the Board to support the Project Pipeline Program to conduct studies at these locations and to support expenses related to the OIPI's oversight and management of the Project Pipeline program.

BE IT FURTHER RESOLVED, that OIPI, in coordination with VDOT and DRPT staff, will update Board members at key milestones as studies progress.

Commonwealth Transportation Board (CTB) Decision Brief

Title: Action to Approve the Locations Selected for Study in the Project Pipeline Program

Issue: To secure Board approval of studies to be conducted under the Project Pipeline study program. The Board initiated the Project Pipeline study program in May 2020. OIPI has led two rounds of Pipeline studies thus far and is ready to begin the next round. OIPI has met with each Board member individually to discuss candidate study locations that were identified in collaboration between OIPI, VDOT and DRPT staff. Board members were afforded opportunity to propose changes and modifications to the list of proposed study locations.

Facts: The *Code of Virginia* § 2.2-229 establishes the Office of Intermodal Planning and Investment (OIPI) within the Office of the Secretary of Transportation, and establishes the following responsibilities:

- Develop multimodal transportation policy
- Undertake, identify, coordinate, and oversee studies of potential highway, transit, rail, and other improvements or strategies
- Provide technical assistance to local governments and regional entities
- Oversee and coordinate with the Department of Transportation and the Department of Rail and Public Transportation the development of, for the Commonwealth Transportation Board's approval, the annual budget and the six-year financial plan for the Commonwealth Transportation Fund

The *Code of Virginia* § 33.2-353, directs OIPI to conduct a comprehensive review of statewide transportation needs in a Statewide Transportation Plan setting forth assessment of capacity needs for all Corridors of Statewide Significance (CoSS), Regional Networks (RN), and improvements to promote Urban Development Areas established pursuant to § 15.22223.1 (UDAs).

Action taken by the Board on March 17, 2021, requires that VDOT and DRPT funds for corridor or facility planning and advance activities relating to concepts addressing a capacity need of the surface transportation network shall be limited to the Statewide and Construction District Priority 1 Locations established per the Policy to Identify and Priority VTrans Mid-term Needs. On December 8, 2021, the Board expanded eligibility of planning and advance activities for the Project Pipeline Program to include Statewide and Construction District Priority 2 Locations. In the initial round of Project Pipeline, the Secretary of Transportation included a provision allowing each Board member to propose up to one study that does not address a Statewide and/or Construction District Priority 1 or 2 Location but that still has a VTrans Mid-term Need. This provision has been carried forward each successive round.

Recommendations: OIPI recommends the approval of the proposed Project Pipeline study locations outlined in Appendix A.

Action Required by CTB: The Board will be presented with a resolution for a formal vote to approve the proposed Project Pipeline study locations outlined in Appendix A.

Result, if Approved: If approved, the studies in Appendix A will be added to the Six-Year Improvement Program of projects and programs for Fiscal Years 2025 through 2030 and the transfers of allocations necessary to fully fund the studies will be approved.

Options: Approve, Deny, or Defer.
