# **MOTION**

## Title: Statewide Abandonment and Transfers in the Primary System of State Highways

WHEREAS, elements of the Primary System, including the Interstate System, may be abandoned, thereby extinguishing the road as a public way and facilitating the conveyance of the title to the right of way by the Board or the local government, whichever owns the fee, when:

- The road is no longer necessary as a public road, because a new road has been constructed (a) that serves the same citizens as were served by the old roadway alignment (§33.1-148, Code of Virginia); or
- (b) Following a public involvement process, initiated by the Commissioner or by a request of an interested landowner, the Department determines that a road is no longer necessary for the purposes for which highways are established (§33.1-145, Code of Virginia).

WHEREAS, elements of the Primary System and the Interstate Frontage Road System may be transferred to the secondary system of state highways (§33.1-35, Code of Virginia) when:

- (a) The roadway no longer satisfies criteria for a road to be part of the State Highway System, usually as a result of a highway relocation project causing a new road to be built in lieu of the original road alignment but the old road remains necessary for public transportation purposes; or
- (b) The local governing body has requested, or has otherwise been notified of, a transfer of a road to the county's secondary system of state highways, provided the road considered is not necessary for the purposes of or qualifies to be a part of the State Highway System or the Interstate Frontage Road System.
