**Title: Revenue Sharing Reallocation  
Augusta County**

**WHEREAS**, Section 33.1-23.05 of the *Code of Virginia* prescribes the annual allocation of state funds to provide an equivalent matching allocation for certain local funds designated by the governing body to be placed in a special fund account; and,

**WHEREAS**, the governing body of Augusta County elected to participate in this program for Fiscal Years 1997 through 2005, with the Virginia Department of Transportation (VDOT), and identified specific eligible items of work to be financed from the special fund account; and,

**WHEREAS**, the governing body of Augusta County has, by appropriate resolution, requested funds to be reallocated to three projects on Route 694, two projects on Route 652 and one project on Route 659 for specific eligible items of work, as indicated herein; and,

**WHEREAS**, these items of work fall within the intent of Section 33.1-23.05 of the *Code of Virginia*, and comply with VDOT's guidelines for the use of such funds.

**NOW, THEREFORE, BE IT RESOLVED**, that the Commonwealth Transportation Board hereby approves the reallocation of these funds as set forth and indicated herein.
