#### **Definitions of Maintenance and Operations**

Ordinary Maintenance—Keeping physical assets functioning.

Examples: cleaning ditches, pothole patching, mowing, preventative equipment maintenance.

Maintenance Rehabilitation—Repairing an asset to extend its life or replacing it.

Examples: pavement milling and overlay, bridge superstructure rehabilitation, drainage pipe replacement.

Maintenance Reconstruction—Restoring an asset to its original condition after its useful life has been exhausted.

Examples: bridge replacements; large scale bridge deck replacements; complete reconstruction of major sections of pavement. (These types are projects are increasingly funded from the construction program).

Operations—Moving traffic efficiently and improving safety.

Examples: incident management, traveler information, signal optimization, and operating the tunnels, ferries and rest areas.

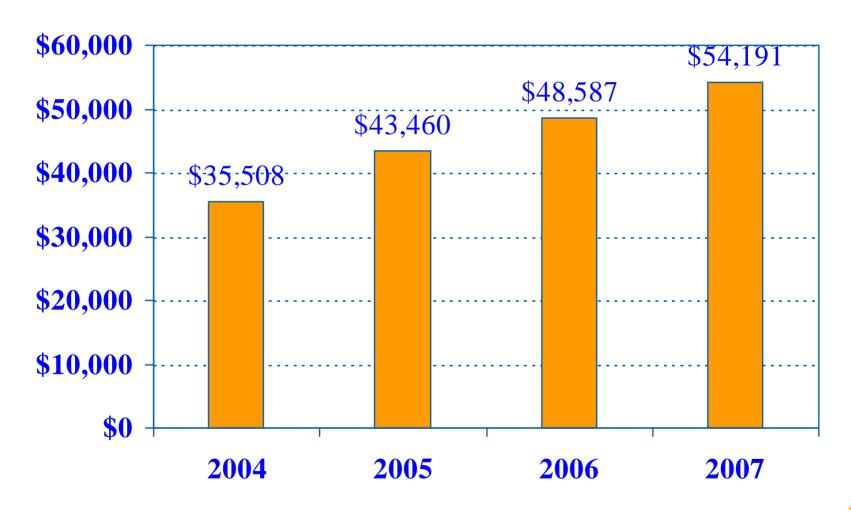


## Operating In An Environment Of Declining Purchasing Power
