The monthly meeting of the Commonwealth Transportation Board was held in the Central Auditorium of the Department of Transportation in Richmond, Virginia on November 21, 2002. The Chairman, Whittington W. Clement, presided. The Chairman called the meeting to order at 9:02 a.m.

### **Agenda Item 1:** Public Comment:

(A) Vice Chairman Shucet addressed the members regarding the Richmond Times Dispatch article of November 21<sup>st</sup> concerning the "bridge fund" presentation made at the November 20<sup>th</sup> workshop. He clarified some misinterpretations in the article and distributed a Federal Bridge Funding fact sheet [attached]. He also stated that the current "informal" funding policy is outdated and needs to be revised.
