

Minutes of the Meeting of the State Highway
Commission of Virginia, Held in
Richmond, January 13, 1938.

On the morning of January 13th, 1938, the State Highway Commission, consisting of Messrs. H. G. Shirley, Wm. H. East, G. W. Rawls and J. F. Wyszor, (Mr. Wade H. Massie, Secretary, not present) met in their office, State Office Building, Richmond, Virginia.

The meeting was called to order by the Chairman.

Mr. Charles S. Smith, Jr., Mr. Callis, Mr. Lewis Jones, Dr. Hopkins and two other gentlemen appeared before the Commission concerning the road through the property of Mr. Frank Moore, Mr. Davis, and some colored people, relative to right of way condemnation proceedings on Route 30, Project 682D, Urbanna Creek-Saluda.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that Colonel Branch Spalding, of the National Park Service, Fredericksburg, Va., be advised that the State Highway Commission will approve the relocation of Route 24 around Old Appomattox provided the Park Service will pay for the relocation and put the road in as good shape as the present road. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the State Highway Commission feel they are not in a position to lease the property requested by Taylor and Caldwell, of Walkerton, Va., on Route 629, Project 1108, in King and Queen County, and the matter will have to be worked out as an exchange. Motion carried.

Moved by Mr. East, seconded by Mr. Rawls, that in accordance with Chapter 212, Section 1, Act approved March 19, 1926, and upon recommendation of the Chairman, section 1 of State Highway Route 260 in Albemarle County, as shown on plat dated December 22nd, 1937, Project 105 AB2, is no longer necessary for use as a State highway and the same be abandoned upon opening of the new section in lieu thereof, but left open as a private entrance. That section 2 shown on the plat above referred to be abandoned. Motion carried.

Mr. Thos. P. Thompson, City Manager of Norfolk, appeared before the Commission and ask for additional funds towards the elimination of the EAW Grade Crossing on the Hampton Boulevard in Norfolk. The Commission previously agreed to pay one third of the cost of the project and reaffirmed their offer.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the road between Madisonville and Cullen, Route 59, be built as recommended by the Chief Engineer in his letter of January 8th, at or near Madisonville. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the claim of Charles W. Johnson for remuneration of medical expense amounting to \$73.60, be not approved. Motion carried.

Moved by Mr. Rawls, seconded by Mr. East, that the request of the Town of Abingdon to use a portion of the right of way of Route 68 in the Town as an entrance to the Dixie Tobacco Warehouse, be not granted. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the question of a short route south referred to by the Southern Short-Way Association of Lakeland, Florida, be tabled. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the question of building sidewalks adjacent to highways having been carefully considered, that the Commission is of the opinion that the State should not pay more than 50 % of the total cost of the improvement, and that the property owner and county pay the other 50 %. Motion carried.

There being no further business, the meeting adjourned, subject to the call of the Chairman.
