## Minutes of the Mesting of the State Highway Commission of Virginia, Held in Richmond, January 12, 1940.

On the morning of January 12, 1940, the State Highway Commission, consisting of Messre. H. G. Shirley, Wade H. Masele, Secretary, S. W. Rawle, J. P. Wysor and Kenneth N. Gilpin, met in their office, Hichmond, Virginia.

The meeting was called to order by the Chairman.

Moved by Mr. Mawls, seconded by Mr. Wysor, that the minutes of the meeting of December 19th, 1989, be approved. Motion carried.

Moved by Mr. Wysor, seconded by Mr. Rawle, that the permits issued from December 19th to January 12th inclusive, be approved as recorded in the Auditing Division. Notion carried.

Mr. J. P. Andrews, formerly with the U. S. Forest Service, appeared before the Countselon relative to roads in the Recreational Areas of Buckingham, Campbell, Cumberland and Prince Edward Counties, asking the Countselon to take over 38.5 miles for maintenance.

Moved by Mr. Massie, seconded by Mr. Gilpin, that necessary legislation be requested to take over the roads requested by Mr. J. P. Andrews, and the Chairman authorised to take the matter up with the Conservation Commission and Forest Service to this end. Motion carried.

Moved by Mr. Wysor, seconded by Mr. Gilpin, that the Commission award contract for the construction of Project 8 1185 B2, Route 8, Wellway Suspension Bridge over New River at Marrows, to the low bidder, Bastern Supply Company, Richand, Va., at their bid of \$12,867,00, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of exproximately \$13,600,00 chargeable to this project. Motion carried.

Moved by Mr. Wysor, seconded by Mr. Massie, that the Commission award contract for the construction of Project FAS 1818 K, Route 628, Intersection Route 8 M. Cruses Store-2.4 Mi. E. Intersection Route 8, Patrick County, to the low bidder, Battershill-Jones and Company, Virgilina, Va., at their bid of \$18,962.02, and that 10% additional be set aside to cover the cost of engineering and additional, work, making a total of approximately \$20,800.00 chargeable to this project. Motion carried.

Moved by Mr. Gilpin, seconded by Mr. Rawls, that the Commission award contract for the construction of Project 8 728 C2, Route 260, 0.69 Ml. W. Melson-Albemarle County Line—0.35 Ml. W. Melson-Albemarle County Line, to the low bidder, Ralph R. Mills, Co., Inc., Rosnoke, Va., at their bid of \$15,969.71, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$17,500.00 chargeable to this project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that the Commission award contract for the construction of Project S 531 VI, Route 211, 1.8 Mi. W. Rosslyn-3.9 Mi. E. Broad Street in Falls Church (Thru Cherrydale) to the low bidder, Rastern Supply Company, Richmond, Va., at their bid of \$12,982.65, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$14,180.00 chargeable to this project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Wysor, that the Commission sward contract for the construction of Project PAS 403 CB1, Route 40, Intersection Route 35-At Homeville P.C.-2.4 Miles East, to the low bidder, Perkins-Barnes Construction Co., Inc., and Carrett, Moon and Pool, Blackstone, Va., at their bid of \$27,081.55, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$29,780.00 chargeable to this project. Mution carried.

Moved by Mr. Wysor, seconded by Mr. Rawls, that the Commission award contract for the construction of Project FA 132 DR1, ER1, Route 11, 2.6 Mi. W. Shawaville-4.2 Mi. E. Christiansburg, to the low bidder, Terry Bross, Wytheville, Va., and Sutton Company, Inc., Radford, Va., at their bid of \$104,289.00, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$114,700.00 chargeable to this project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Gilpin, that the Commission award contract for the construction of Project PAS 1119 C, Route 16, 3.6 Mi. W. Intersection Route 15, Madicon County, to the low bidder, Ralph M. Mills, Inc., Rosnoke, Va., at their bid of \$40,558.51, and that 10% additional be set aside to cover the sost of engineering and additional work, making a total of approximately \$44,500,00 chargeeble to this project. Motion carried.

Moved by Mr. Wysor, seconded by Mr. Rawls, that permit No. 14407, Route 29, Madison County, issued March 19, 1936, to B. L. Deniel, Shelby, Yas, be cancelled as requested by the District Engineer. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Massie, that paralt No. 11636, Routes 7 and 50, Fairfax County, issued May 20, 1939, to Dr. Claude Moore, Washington, D.C., be cencelled as requested by the District Engineer. Notion carried.

Moved by Mr. Mysor, sedended by Mr. Rewls, that the following permits issued to the Virginia Electric and Power Company, Richmond, Va., be cancelled as recommended by the District Engineer:

Moved by Mr. Massie, seconded by Mr. Mysor, that as provided by Chapter 415, Act approved March 81, 1952, and upon recommendation of the Commissioner, the following sections of reads in Albertarle County being no longer necessary for uses as a highway, the same be abundaned, due to the construction of Route 250: Section 1. Route 731 and section 2. Route 722, as shown on plat dated December 18, 1953. Project 556 MMB5. That section 3 also shown be added to the system and the overhead crossing of the C&O Railway on abandoned section at RR M.P. 178.25 be closed. Motion carried.

Moved by Mr. Gilpin, seconded by Mr. Rawls, that as provided by Chapter 415, Act approved March 31, 1952, and upon recommendation of the Commissioner, the following section of Route 744 in Augusta County being no longer necessary for uses as a highway, the same be abandoned upon opening of new section in lieu thereof: Section 1 as shown on plat dated December 15, 1939 That section 2 also shown on the plat be added to the system as new location. As provided by Chapter 415, Act approved March 31, 1982, section 8 also shown on the plat referred to be added to the secondary system as a commention. Notion carried.

Moved by Mr. Wyeor, seconded by Mr. Hawle, that as provided by Chapter 212, Section 1, Act approved March 19, 1928, and upon recommendation of the Commissioner, the following section of Route 11 in Pulaski County being no longer necessary for uses as a highway the same be abandoned upon opening of new section in lieu thereof: Section 1 as shown on plat dated December 19, 1989, Project 151 ERL. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wysor, that as provided by Chapter 415, Act approved March 51, 1932, and upon recommendation of the Commissioner, the following sections of Route 600 in Northampton County being no longer necessary for uses as a highway the same be abandoned upon opening of new sections in lieu thereof: Sections 1 and 2 as shown on plat dated December 15, 1939, Project 1359 K. That sections 3 and 4 shown on the plat he added to the secondary system in lieu of abandoned sections. Motion carried.

Moved by Wr. Nysor, seconded by Mr. Massie, that as provided by Chapter 212, Section 1, Act approved March 19, 1926, and upon recommendation of the Commissioner, the following sections of Route 11 in Wythe County being no longer necessary for uses as a highway the same be abandoned upon opening of new sections in lieu thereof: Sections 1 and 8 as shown on plat fasted December 15, 1989, Project 161 CR1. That section 2 also shown be abandoned as a part of the primary system and revert to the secondary system. Culpeper Station, from Route 15 to the radio tower, 750 feet; Appointtox Station, from Route 613 to the tower, 250 feet, or 0.19 mile approximately. Motion omaried.

Moved by Mr. Massie, seconded by Mr. Rawls, that the Chairman be authorized to sign agreement with Legh R. Powell, Fr. and Henry W. Anderson, as Receivers of the Seeboard Air Line Railway Company, relative to right of way for the location of Route 1 at Dewitt, Dinwiddle County, our Project FA 420 CW1, 2. Motion carried.

Moved by Mr. Wysor, seconded by Mr. Massie, that the Commission allocate the \$600.00 per mile construction funds for the year 1939-1940 to the City of Radford, to be used for raising and widening approach grade at south and of the New River Bridge, Route 11. Motion carried.

Moved by Mr. Rawle, seconded by Mr. Shirley, that the Commission designate Alternate Route 60 in the City of Newport News over Virginia Avenue, between 34th and 25th Streets, and 25th Street between Virginia and Jefferson Avenues, but that no funds be approved for expenditure thereon. Motion carried.

Senator Aubrey G. Weaver and Senator Burr P. Harrison, appeared before the Commission acking that the convict samp be continued on Route 55 in the Staumton District.

Moved by Mr. Gilpin, seconded by Mr. Wysor, that the Commission will agree to join West Virginia on Route 55 at the State line and make appropriation for constructing the gap on the Virginia side if West Virginia will build their road to the Virginia line. Metion carried.

Moved by Mr. Shirley, seconded by Mr. Rawls, that additional State Highway mileags in the City of Fredericksburg be approved for maintenance due to annexation, as follows:
