## Himmes of Meeting of the State Highway Commission of Virginia, Held in Richmond Japany 8, 1959.

Moved by Mr. Rawls, seconded by Mr. Barrow, that, as provided under Section 53-75.5 of the Code of Virginia of 1950, as amended, Sections 1 and 2 of the old location of Moute 211 in Reppshannock County be abandoned to the extent of alteration, a total of 0.49 mile as shown in blue on plat dated December 12, 1967, Project 1776-05. Motion carried.

Hoved by Mr. Rawls, seconded by Mr. Barrow, that, as provided under Section 55-27 of the Gode of Virginia of 1950, as amended, the following Sections of old location of Route 17 in Fauquier County be transferred from the Primary System to the Secondary System of Highways: Sections 2, 5, 6B and 7B totaling 0.54 mile as shown in red on plat dated August 28, 1957, Project 2050-10-15-14; That as provided under Section 55-76.1 of the Code of Virginia of 1950, as amended, Section 7 of old location of Route 17 being no longer necessary for uses of the State Highway System be discontinued as such, 0.22 mile as shown in yellow on the plat and project referred to; Further, that as provided under Section 55-76.5 of the Code of Virginia of 1950, as amended, Sections 1, 4, 5, 8A, 7A, 8 and 9 of old location of Route 17 be abandoned to the extent of the alteration, 1.07 miles as shown in blue on the plat and project referred to. Motion carried.

Moved by Mr. Carper, accorded by Mr. Solater, that, WHEREAS, by proper resolutions the various Boards of Supervisors have requested the discontinuance of certain roads in the Secondary System, and whereas, the Resident Engineers representing the Commission, did post notices and hold hearings in the respective counties to ascertain whether or not such roads should be discontinued, the proposed discontinuances meeting no valid opposition; now, therefore, be it resolved, that the following roads he discontinued as parts of the Secondary System as provided under Section 35-78,7 of the Gode of Virginia of 1950, as assended; effective this date:
PAUGITER COUNTY - Old location of Route 612, Project 1850-15, MISS Section 5, from Sta. 629/50 looping northerly to Sta. 641/00 ... 0.22 RUSSELL COUNTY - Old location of Route 684, Project 1865-20: Section 1, from Sta. 105/50 northeast to Sta. 110/90 . . . . . . 0.07 Section 4, from Sta. 212/40 northeast to Intersection of Route 68C 0.08 Motion carried.

WHENEAS, Section 55-27 of the Code of Virginia of 1950, as amended by the 1955 General Assembly of Virginia, authorises the State Highway Countesion to transfer from the Primary System of State highways to the Secondary System of State bighways not more that 150 miles of highway during any one year; AND wHEREAS, the foun Council of the Town of account by its resolution adopted at its meeting held on March 12, 1958, requested the Virginia Department of Highways to transfer State Primary Route 177, from D. S.Route 15 in the Town of Account to State Primary Soute 516 at Greenbuch to the State Secondary System of roads; AND MERITAS, the Associatek County Board of Supervisors et its meeting on March 26, 1958, passed a similar resolution; AND WHEREAS, studies by the Virginia Department of Highways show that such a transfer is feasible and desirable; now, therefore, be it resolved, that the Righway Commission hereby transfers State Primary Boute 177 from its intersection with U. S. Acute 15 in Accomed to its intersection with State Route 316 at Greenbush to the State Secondary System of roads effective this date.

Hoved by Mr. Rawle, seconded by Mr. Carper, that, MHEREAS, request is made by the trustees of the Jemestown Foundation that the approach roads in front of the Festival Park, between Route 51 and the Colonial Parkway, be taken over as a part of the Primary System of Highways; the proposed addition having been constructed to conform with design standards; now, therefore, be it resolved, that under authority of Section 55-26 of the Code of Virginia of 1950, as smended, the approach roads of the Pestival Park leading from Route 51 southerly including the circular driveway to the north right of way of the Colonial Parkway, a distance of 0.27 mile as indicated on the layout sketch dated December 18, 1966, be added to the Primary System of Highways, and designated as Route 559. Motion carried.

Miscellaneous comments.

Senator Melson made comment on the use of the State owned automobiles, suggesting that those used by the personnel of the Highway Department be distinguished in some way from those used by other State Departments. Mr. Rawle suggested that such care be marked "Highway Department".

Mr. Barrow was interested in problems of the Toun of Lawrenceville as indicated by its resolution adopted recently.

Mr. Sclater requested the Commissioner to take up the problem of trucks parking on the shoulders and dangerously near the paved portion of the highways in the Bristol District. Discussion revealed that suthority is vested in the Resident Engineers to post signs covering the infringement and to protect the highway right of way.

Hr. Hawls is interested in the completion date of approaches on the Hampton side of the Hampton Roads Bridge-Tunnel project. He was advised it would be late 1980.

Mr. Flythe is interested in the possibility of bringing secondary roads up to weight standards so that industry now being served could get out on the highways; and the Chief Engineer was requested to explore the possibility of setting up a fund comparable to that for roads to new industries.

The financial problems of the Department were fully and thoroughly discussed, the need for additional funds being evident and the possibility of an Extra Session of the General Assembly at which time the request may be made for an additional gas tax. The Commission determined the only alternative is to allocate the available funds as provided by statute to the Secondary System, to neet Federal Aid, etc. and then distribute to construction projects in the eight construction districts under the regular formula.

Reference was made to the latter of January 5th sent to the Commission with attachments relative to finances of the Department, and Mr. Eure gave the Commission a clear and concise report on the present situation regarding funds.

Mr. Fugate gave the Commission a full report on the present conditions regarding Interstate Routes 64, 66 and 77. A list of those to whom a copy of the report on Route 64 should be mailed was also discussed, and the possibility of the report being ready by the latter part of the month. The time and place for a public hearing before the Commission on Route 64 will be decided by the Commissioner and a meeting called for that purpose.

There being no further business before the Commission it was moved by Mr. Rawls and seconded by Senator Welson that the meeting be adjourned. The motion carried. The Commission and some of the Department's engineers went to Byran's for lunch.
