#### MEETING OF STATE HIGHWAY AND TRANSPORTATION BOARD

Richmond, Virginia

January 16, 1986

The monthly meeting of the State Highway and Transportation Board was held in the Central Office in Richmond, Virginia, on January 16, 1986, at 10:00 a.m. The chairman, Mr. Ray D. Pethtel, presided.

Present: Messrs. Pethtel, Bacon, Davidson, Guiffre, Howlette, Humphreys, Malbon, Musselwhite, Quicke and Smalley and Mrs. Kincheloe.

Absent: Mr. Smith.

Mr. Ray D. Pethtel, appointed to the position of Commissioner of the Department of Highways and Transportation by Governor Gerald L. Baliles effective January 11, 1986, called the meeting to order.

Commissioner Pethtel introduced Mrs. Vivian E. Watts, newly appointed Secretary of Transportation and Public Safety.

Mrs. Watts spoke enthusiastically about Governor Baliles' strong commitment to transportation as outlined in his State of the Commonwealth address on January 13, 1986.

Mrs. Watts stated she shared the Governor's commitment to prepare the Commonwealth's transportation system for the 21st century. As part of her contribution, she indicated her desire to make sure whatever policy changes might evolve would be "nailed down" in every detail by involving those people who will carry out the policies and looking at all technical areas involved.

A discussion followed on the Governor's proposed Commission on Virginia's Transportation Needs in the Twenty-First Century. Commissioner Pethtel indicated that the Board planned to take a very active role in the work of the Commission and the Board was encouraged by Secretary Watts to submit names of potential members to the Governor for consideration and to share its other ideas with the Commission.

This being the first meeting of the Board following Mr. Pethtel's appointment, he stated to those present the following goals: (1) to carefully orient himself to the people, programs, and environment of the Board and the Department, (2) to maintain existing work processes, but with an attitude of self-appraisal and evaluation and (3) to ensure the Department is in a position to provide aggressive leadership for the Governor's transportation goals and policies.

On motion of Mr. Quicke, seconded by Mr. Smalley, permits issued from December 19, 1985, to January 15, 1986, inclusive, as shown by the records of the Department, were approved.

NOM, THEREFORE, BE IT RESOLVED, that the location and major design features of this project be approved in accordance with the plan as proposed and presented at the said Location and Besign Public Hearing by the Department's Engineers, amended to adjust the alignment sufficiently to avoid or minimize encroachment on the septic system left of Station 72+00 and still maintain a 40 mile-per-hour design speed.

WHEREAS, in order to more fully develop the property, the owner of the adjacent lands has requested that the excess right of way, so acquired, be conveyed to him; and

WHEREAS, the State Highway and Transportation Commissioner has certified in writing that the right of way comprising approximately 0.52 acre, more or less, and lying southeast of the southeast normal right of way limits of Route 645, from a point approximately 40 feet opposite approximate Station 32+00 (Route 645 centerline) to a point approximately 40 feet opposite approximate Station 34+80 (Route 645 centerline) does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the Secondary System of State Highways.

NOW, THEREFORE, the conveyance of the said parcel of land, so certified, in accordance with the provisions of Section 33.1-154 of the Code of Virginia (1950), as amended, is approved and the State Highway and Transportation Commissioner is hereby authorized to execute in the name of the Commonwealth a deed without warranty conveying same to the adjoining landowner of record for a consideration satisfactory to the State Right of Way Engineer, subject to such restrictions as may be deemed requisite.

WHEREAS, in order to more fully develop the adjacent lands, the adjoining landowner has requested that the excess lands, so acquired, lying adjacent to his property be conveyed to him; and

WHEREAS, the State Highway and Transportation Commissioner has certified in writing that the lands containing 2.55 acres, more or less, and lying south of and adjacent to the south normal right of way limits of Route 13, from a point approximately 70 feet opposite approximate Station 2206+10 (Route 13 NBL centerline) to a point approximately 90 feet opposite approximate Station 2208+90 (Route 13 NBL centerline) does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the State Highway System.

NOW, THEREFORE, in accordance with the provisions of Section 33.1-149 of the Code of Virginia (1950), as amended, the conveyance of the lands, so certified, is hereby approved and the State Highway and Transportation Commissioner is authorized to execute in the name of the Commonwealth a deed conveying same, without warranty, to the adjoining landowner of record for a consideration satisfactory to the State Right of Way Engineer, subject to such restrictions as may be deemed requisite.

Both instruments

are recorded in the Office of the Clerk of the Circuit Court of Arlington County; and

MHEREAS, in order to more fully develop the adjacent lands, the adjoining landowner has requested that certain excess land, so acquired, be conveyed; and

WHEREAS, the State Highway and Transportation Commissioner has certified in writing that the land containing 1,871 square feet, more or less, and lying north of and adjacent to the north normal right of way limits of Ramp "L", from a point approximately 65.5 feet opposite approximate Station 3+07.5 (baseline Ramp "L") to a point approximately 50 feet opposite approximate Station 6+00 (baseline Ramp "L") does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the State Highway System.

MHEREAS, at a meeting of the Board of Supervisors of Fairfax County held on December 9, 1985, a resolution was passed abandoning a section of Keene Mill Road (Old Route 644); and

MHEREAS, the General Assembly amended and reenacted Section 33.1-75.1 at the 1985 session to allow the use of Revenue Sharing Funds on the Primary System; and

MHEREAS, the Board of Supervisors of James City County has, by Resolution, authorized \$248,730.00 of its Revenue Sharing Funds, to be matched by an equal amount from the Virginia Department of Highways and Transportation, to be allocated to Route 199 between Route 5 and Route 60;

WHEREAS, Route 199 between Route 5 and Route 60 in James City County is not included in the approved Six-Year Improvement Program, and, further, with the present revenue and the estimated cost of the project, it does not appear that it can be included in the Program;

MHEREAS, it is the intent of the General Assembly that Revenue Sharing Funds be used where the Funds can be spent in an expeditious manner;

WHEREAS, the Patrick County Board of Supervisors has, by resolution, requested Industrial Access Funds to serve L. E. Hutchens, Inc. within the Patrick County Industrial Park located within Patrick County, and said access is estimated to cost \$154,800; and

MHEREAS, it appears that this request falls within the intent of Section 33.1-221 and has complied with the provisions of the Highway and Transportation Board's policy on the use of Industrial Access Funds.

NOW, THEREFORE, BE IT RESOLVED, that \$89,905 of the Industrial Access Fund be allocated to provide adequate access to the proposed facility of L. E. Hutchens, Inc. located in the Patrick County Industrial Park by improving 0.13 mile of Route 743 and constructing Route 1025 for a distance of 0.17 mile in Patrick County, Projects 0743-070-165, C501, and 1025-070-166, C501, contingent upon:

- all necessary right of way and utility adjustments being provided at no cost to the Industrial Access Fund;
- documentary evidence that the industry has or will spend \$899,045 to establish the industrial facility;
- no more than 40% of the road costs over \$89,905 being paid by the Secondary Improvement fund with the remaining cost being paid by Patrick County; and
- 4. an escrow account in the name of the Virginia Department of Highways and Transportation being established prior to the award of the contract covering the bid cost for which Patrick County is responsible.

WHEREAS, Section 33.1-221 of the Code of Virginia provides a fund to "... be expended by the Board for constructing, reconstructing, maintaining or improving access roads within counties, cities and towns to industrial sites on which manufacturing, processing or other establishments will be built under firm contract or are already constructed to publicly owned airports; ...."; and

WHEREAS, the Highway and Transportation Board did, on July 16, 1981, allocate \$75,000 to the Fredericksburg Industrial Park near Berea in Stafford County to the proposed facility of Massaponax Sand and Gravel, Inc., Project 0762-089-186, M501; and

WHEREAS, the Massaponax Sand and Gravel, Inc. is not operating facilities at this location, and there is no other industry as defined by adopted Board policy existing along this road.

NOW, THEREFORE, BE IT RESOLVED, that the Highway and Transportation Board action of July 16, 1981, is herewith rescinded without prejudice and the allocation of \$75,000 is hereby returned to the Industrial Access Fund and is subject to the future actions of this Board.
