

Minutes of the Meeting of the State  
Highway Commission of Virginia, Held in Richmond  
February 24, 1937.

On the morning of February 24, 1937, the State Highway Commission, consisting of Messrs. H. G. Shirley, Wm. H. East, S. W. Rawls and J. F. Wycor, met in their office, State Office Building, Richmond, Virginia.

The meeting was called to order by the Chairman.

Moved by Mr. Wycor, seconded by Mr. Rawls, that the minutes of the meeting of January 4th be approved. Motion carried.

Moved by Mr. Wycor, seconded by Mr. Rawls, that the Commission confirm award of contract for the construction of Project MEM 1032 F1,2, Route 501, Park Avenue-Fort Avenue on Forest Avenue, City of Lynchburg, to the low bidder, J. E. Ford and Company, Inc., Lynchburg, Va., at their bid of \$2,276.10 and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$2,500.00 chargeable to this project. Motion carried.

Moved by Mr. Rawls, seconded by Mr. East, that the Commission confirm award of contract for the construction of Project WPSO 1556 A1,2,4,C1, 2A,2A,D1, Routes 652, 2201, 2,4,1804,5 and 6, Streets in Ingleside, Estabrook, Craddock, Norfolk County, to the low bidder, Robert Martin Co., Salem, Va., at their bid of \$13,125.00 and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$15,000.00 chargeable to this project. Motion carried.

Moved by Mr. East, seconded by Mr. Shirley, that the Commission confirm award of contract for the construction of Project WPSO 1568 K1,2,31, Routes 508-667, 0.31 Mi. S. Int. Route C-567-0.45 Mi. E. Int. Route C-667, 0.56 Mi. E. Int. Route C-508-Int. Route C-508, to the low bidder Perkins-Barnes Construction Company, Inc., Blackstone, Va., at their bid of \$15,665.75, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$18,000.00 chargeable to this project. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Wycor, that the Commission confirm award of contract for the construction of Project FA 569 DW1, Route 1, 1.786 Mi. S. Felling Creek-0.787 Mi. S. Kingsland Creek, to the low bidder, W. H. Armstrong and Company, Washington, D.C., at their bid of \$16,967.40, that 10% additional be set aside to cover the cost of engineering and additional work and \$33.00 for pole lines, making a total of approximately \$18,000.00 chargeable to this project. Motion carried.

Moved by Mr. Wycor, seconded by Mr. East, that the Commission confirm award of contract for the construction of Project FA 685 C1,3, Route 11, West Virginia Line-1.73 Mi. N. ECL Winchester, to the low bidder, R. W. Moore and Company and Echols Bros, Inc., Staunton, Va., at their bid of \$194,832.62, that 10% additional be set aside to cover the cost of engineering and additional work and \$3,511.89 for pole lines, making a total of approximately \$218,000.00 chargeable to this project. Motion carried.

Moved by Mr. East, seconded by Mr. Rawls, that the Commission confirm award of contract for the construction of Project FA 504 A51, 98 D61, 163 A51, Routes 15 and 360, 2.64 Mi. W. Jones Store-Wylliamsburg, to the low bidder, E.C. Brasben Construction Company, Burkeville, Va., at their bid of \$92,196.22, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$102,000.00 chargeable to this project. Motion carried.

Moved by Mr. Wycor, seconded by Mr. East, that the Commission confirm award of contract for the construction of Project FA 558 C51, D61, F51, Route 31, Bland County Line-4.7 Mi. S. Bland County Line, to the low bidder, W. N. Jackson, Roanoke, Va., at his bid of \$57,272.53, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$63,000.00 chargeable to this project. Motion carried.

Moved by Mr. East, seconded by Mr. Rawls, that the Commission confirm award of contract for the construction of Project FA 1116 B1, Route 299, Bridge over Southern Branch of Elisabeth River at Gilmerton, to the low bidder, Carpenter Construction Corporation, Norfolk, Va., at their bid of \$448,504.79, and that 5% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$471,000.00 chargeable to this project, Norfolk City agreeing to put up the difference of \$60,000.00. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wycor, that the Commission confirm award of contract for the construction of Project WPMH 1157 M1, Route 220, Approaches to CAO Overpass and Jackson River Bridge in Clifton Forge, to the low bidder, G. G. Waugh and Company, Culpeper, Va., at their bid of \$15,579.54, and that 10% additional be set aside to cover the cost of engineering and additional work; transferring the following to make up the difference needed-

making a total of approximately \$17,000.00 chargeable to this project. Motion carried.

Halifax, to the low bidder, D. M. Bouser, Stony Creek, Va., at his bid of \$16,685.94, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$19,000.00 chargeable to this project. Motion carried.

Mr. E.T. Graham of Norfolk, Va., appeared before the Commission concerning the use of a Universal Crane No. 3 to be mounted on a truck chassis, in connection with his hauling business in the State. The Commission agreed to give Mr. Graham twelve trip permits per year on request to operate this crane. The necessity for additional permits to be taken up with the Commission.

Moved by Mr. Rawls, seconded by Mr. Shirley, that the Japanese Beetle Stations operating in the State, be instructed to suspend operations on Saturday after 12:00 o'clock noon and Sundays, on Routes 211, 1 and 2. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the minimum wage rate of \$6½ per hour be established for the metropolitan zones around cities having more than the 20,000 population for a radius of five miles, as suggested by the Bureau of Public Roads, and when the major portion of a contract is within the zone paying the maximum rate it carry that rate; if the major portion of the contract is outside of the maximum rate zone it shall carry the rate outside. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that whereas Route 665 beginning at No. 667 and extending to the tracks of the R.F. & P. Railroad Company, has been added to the secondary system of highways in Hanover County, with the understanding that a 30 ft. right of way would be furnished; and whereas the records show that this is an old county road but does not show it is 30 ft. in width although indications are that it is of that width; and whereas the property holders are willing to sign a deed for a 30 ft. right of way from Route 667 to the R.F. & P. Railroad tracks, releasing their claims to the county of any rights in this road that they may have within the 30 ft. right of way, their being two infant children unable to sign the deed, who own interest in the Walton Vaughan estate, it is moved that if the guardian of these infants will sign for the infants and the other land owners sign, that the deed be accepted without condemnation proceedings. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the agreement entered into by the Commission and the City of Norfolk, whereby the City of Norfolk will pay \$80,000.00 towards construction of the Gilmeron Bridge over Southern Branch of Elizabeth River on Route 299, be approved and award of contract be confirmed; and that application for maintenance and construction funds to this project for 1936-37 amounting to \$42,863.76, as set forth in letter of February 15th from the City Manager of Norfolk, be also approved. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Rawls, that whereas the Board of Supervisors of Princess Anne County have agreed to maintain and operate at all times pumps and a drainage system for relieving the flooding on State Route 60 near Virginia Beach, and will relieve the State from any future responsibility as to the flooding of this section of road, the Commission agrees to contribute \$2500.00 towards such project under the stipulations set out above. Motion carried.

Moved by Mr. East, seconded by Mr. Rawls, that the Commission rescind resolution of September 29, 1936, awarding contract on Project WPGH 513 CD6, Route 23, Approaches and Underpass L&N RR at Appalachia in Wise County, as it was impossible to obtain the right of way necessary. Motion carried.

Moved by Mr. Rawls, seconded by Mr. East, that so far as the State Highway Commission is concerned, certain portions of old Route 12 in Page County, noted as sections 1, 2, 5, 8 and 10 on sketch dated January 6, 1937, revert to the secondary system of highways and remain open for the benefit of secondary roads 655, 654, 653, 611, 632 and 615; that sections 2, 4, 6, 7, 11, 12 and 13 be turned back to the Board of Supervisors with request that they be abandoned and dropped from the system and also a section of Route 663 between the old road and the new route be abandoned. Motion carried.

Moved by Mr. East, seconded by Mr. Wycor, that the State Highway Commission hereby abandon a portion of Route 50 in King William County from near the intersection of Route 604 east approximately 0.86 mile. That the same be turned back to the county as a secondary road; that from this point east, being section No. 2, 0.65 mile of road be also abandoned and turned back to the secondary system and the Board requested to take proper action to close it. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wycor, that due to relocation of Route 49 in Mecklenburg County to avoid two grade crossings of the Southern Railway Company, that 1.3 miles of old 49, beginning where it leaves the new location on the east and running westward 1.3 miles, be abandoned and turned back to the secondary system, and the Board of Supervisors requested to close the same; along with the portion of 37 between the new location and the old location, 0.07 mile, and Route 733 from Route 734 to the old location of 49 a distance of 0.25 mile. That portion of old 49 from intersection of new location on the west, eastward for 0.6 mile to be reverted to the secondary system. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Wycor, that the location of old Route 40 in Halifax County from Gody-East to Route 126 be abandoned so far as the State Highway Commission is concerned, and turned back to the Board of Supervisors with the request that they take action to accept it. Motion carried.

Moved by Mr. Rawls, seconded by Mr. East, that in relocating Route 501 in Campbell County, that the following sections of old road be abandoned so far as the State Highway Commission is concerned, and turned back to the Board of Supervisors with the request that they be closed - sections 2, 3 and 4, as shown on sketch dated February 11, 1937. Section 1 to be abandoned as a part of the primary system and revert to the secondary system and adopted as a secondary road; that section of No. 2 for 0.06 mile being an extension of secondary road No. 630, be added to the secondary system to connect with new 501 and the Board of Supervisors take the necessary action. Motion carried.

Moved by Mr. Rawls, seconded by Mr. East, that whereas the underpass crossing of the Southern Railroad on Route 58, Project WPGH 160 EB4, east of Franklin, has been constructed and opened to traffic, that the grade crossing at this point be closed and public notice given thereof. Motion carried.

Moved by Mr. Wycor, seconded by Mr. Rawls, that whereas the overhead crossing of the Seaboard Air Line Railway on Route 58 in the village of Carverville, has been constructed and opened to traffic, that the grade crossing at this point be closed and public notice given thereof. Motion carried.

Moved by Mr. East, seconded by Mr. Wyszor, that whereas there has been constructed and opened to traffic an overhead bridge over the Southern Railway on Route 55 in Warren County east of Strasburg, at M.P. 59-1580 ft., eliminating the grade crossing of the Southern Railway at M.P. 58-860 ft., east of Strasburg, that the grade crossing be closed and public notice given thereof. Motion carried.

Moved by Mr. East, seconded by Mr. Rawls, that whereas there has been constructed and opened to traffic an undergrade crossing of the Southern Railway on Route 11 in the Town of Strasburg in close proximity to the old road, that the grade crossing over the Southern Railway be closed and the portion of old road affected be closed. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that whereas Route 55 in Fauquier County has been relocated and an overhead crossing put in over the Southern Railway Company's tracks near Goose Creek, that the grade crossing 1047 ft. east of M.P. 57.0 over the Southern Railway be closed and section of old 55 from new 55 over the grade crossing to new 55 again be abandoned. Motion carried.

Moved by Mr. Rawls, seconded by Mr. East, that it will be the policy of the State Highway Commission in securing material from land, or right of way, to inquire whether there is a mortgage on the property and by whom it is held, and no payments be made for the materials or land taken until we have been advised in writing that it is satisfactory to the mortgagor to make payment to the land owner. Otherwise funds will be held. Motion carried.

There being no further business, the meeting adjourned, subject to the call of the Commissioner.
