

Minutes of the Meeting of the State Highway
Commission of Virginia, Held in
Richmond, February 23, 1938.

On the morning of February 23, 1938, the State Highway Commission, consisting of Messrs. H. G. Shirley, Wm. H. East, S. W. Rawls, and J. F. Wycor, met in their office, State Office Building, Richmond, Va.

The meeting was called to order by the Chairman.

Moved by Mr. Rawls, seconded by Mr. Wycor, that the minutes of the meeting of January 15th be approved. Motion carried.

Moved by Mr. East, seconded by Mr. Rawls, that the \$500.00 per mile per year be approved for 1937-38 for the City of Staunton, to be applied to construction of U. S. Route 11 from end of new construction at Hampton Street to the arch bridge at intersection of Route 260. Motion carried.

Moved by Mr. Rawls, seconded by Mr. East, that the \$500.00 per mile per year be approved for 1937-38 for the City of Richmond, to be expended on Route 360 from the city limits to "O" Street, provided a 40 ft. right of way is furnished. Motion carried.

Moved by Mr. Wycor, seconded by Mr. Rawls, that the \$500.00 per mile per year for the City of Lynchburg, for 1938-39 be approved, to be expended on Route 501 in the City; not to be drawn on prior to July first, 1938. Motion carried.

Mr. L. R. Colbert appeared before the Commission in regard to claims on the following projects:

Moved by Mr. Rawls, seconded by Mr. Wycor, that the amounts offered by the Commissioner in his letter of February 7th to Mr. L. R. Colbert on his claims for Projects 1136 A1B1,2; 1069A; WPSO 1108 A1B3; 1116 A2; and 1140 B1, are a fair allowance on these contracts and same be confirmed. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Shirley, that the request of Mr. J. G. Hall to use a part of the landing property on Route 645 in Gloucester County, for erection of shed, be not granted. Motion carried.

Moved by Mr. Wycor, seconded by Mr. Rawls, that the State Highway Commission take into the secondary system a 50 ft. right of way from Route 11 to the Hungry Mother Park, in Smyth County, and maintain the same, provided the Conservation and Development Commission will maintain the right of way outside of the 50 ft. and build the fence; and take up with the Board of Supervisors the securing of \$5,255.00 for surfacing this road and \$2500.00 for making connection with Route 66. Also complete securing the right of way. Motion carried.

There being no further business, the meeting adjourned, subject to the call of the Chairman.
