MEETING OF STATE HIGHWAY COMMUSSION RICHMOND, VIRGINIA FERRUARY 16, 1967

The monthly meeting of the State Highway Commission was held at the Central Highway Office Building in Richmond, Virginia, on February 16, 1967, at 10 A.M. The chairman, Douglas B. Fugate, presided.

Mr. Fugate again discussed with the Commission the withholding of Federal - aid by Presidential decree, which has reduced by 17 1/2% to 25% the allotment to the States. The amount withheld from Virginia is approximately \$20 Million. Now the President has suggested that perhaps an additional \$400 Million would be withheld. This has raised a storm of protest and the Congress will hold a public hearing on March 1 before the Joint Senate and House Roads Committees. Federal highway funds are raised by taxes on the highway user and are pledged to the use of highways. This disruption in the allotment of funds interferes with the orderly planning and construction of highways.

Mr. Landrith inquired about the Recreational Access funds and was told by Mr. Fugate that \$1.5 Million has been set up for this purpose as required by law, but that so far none of it has been apportioned for individual projects. The ros to Gunston Hall is under study. In order to qualify for such funds, a county in which a road is requested must have a zoning ordinance. Mr. Blundon, Secondary Roads Engineer, and Mr. Elbert Cox, Director of Outdoor Recreation, are working together on these roads.

Mr. Fugate Complimented the staff on the 1967 edition of the State Highway Map. Mr. Solater inquired if the districts could be outlined on the map, and Mr. Fugate advised him that this would be looked into.

Mr. McWane wished to know if the establishment of the new Community Colleges would affect the highway budget. He was advised that such roads are built by the individual State institution and must come up to certain standards before they are accepted by the Highway Commission for maintenance.

Mr. Fugate stated that the March meeting will be on the 23rd. The April meeting will be held at Natural Bridge during the Highway Conference, on Thursday, April 20, at 1:00 P.M. Mr. Eure was asked to prepare a summary of the meetings for the next few months.

It was amounced by Mr. Fugate that the opening of the Hopewell Bridge would be on Saturday, April 22, and the sponsors are anxious for the Commission Members to attend the calebration.

The meeting was adjourned at 10:45 A.M.
