MINUTES OF THE MEETING OF THE STATE HIGHWAY COM-
 MISSION OF VIRGINIA, HELD LUNENBURG, PETERS-
 BURG AND RICHMOND, MARCH 15 AND 16, 1928.

On the morning of March 15th, Commissioners Shirley and Massie proceeded from Richmond to Petersburg by auto where they were joined by Commissioners Gilmer and Truxton, then continued to Lunenburg Court House where a public hearing was given on the elimination of grade crossing of the Virginian Railway near Victoria, on Route 223.

After the hearing the Commission returned to Petersburg where a business meeting was held and the following business transacted.

The minutes of the meeting of January 17th, 1928, were read and it was moved by Mr. Truxton, seconded by Mr. Gilmer, that they be approved. Motion carried.

Moved by Mr. Spraul, seconded by Mr. Gilmer, that the contract for the construction of 4.875 miles 18' bituminous macadam road, Route 14, Project F-42622, Lexington-4.875 Miles West, be awarded to the low bidder, Robert Martin Company, Salem, Virginia, at their bid of \$76,356.24 and that 10% additional be set aside to cover the cost of engineering and additional work and \$1,000.00 for detours, making a total of approximately \$85,000.00 chargeable to this project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Truxton, that the contract for the construction of 3.76 miles 18' bituminous macadam road, Route 14, Project F-395222, Rockbridge-Allaghany County Line - 3.76 Miles West, be awarded to the low bidder, Carpenter-Major Brothers and Company, Inc, Clifton Forge, Virginia, at their bid of \$69,812.60 and that 10% additional be set aside to cover the cost of engineering and additional work and \$500.00

for detours, making a total of approximately \$78,000.00 chargeable to this Project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Gilmer, that the contract for the construction of 3.891 Miles bituminous macadam road, Route 14, Project F-43622, 4.878 Miles West of Lexington - 5.12 Miles East of Alleghany County Line, be awarded to the low bidder, G. P. Clay, Richmond, Virginia, at his bid of \$99,309.70, setting aside 10% additional to cover the cost of engineering and additional work and \$1,000.00 for detours, making a total of approximately \$111,000.00 chargeable to this Project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Gilmer, that the contract for the construction of Project S-45828, Route 23, .718 Miles North of Ridgeway - Ridgeway, 18' concrete road, be awarded to the low bidder Power Paving Company, Winston Salem, North Carolina, at their bid of \$28,203.85, setting aside 10% additional to cover the cost of engineering and additional work and \$400.00 for detours, making a total of approximately \$30,000.00 chargeable to this Project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Gilmer, that the contract for the construction of 2.784 Miles 18' concrete road, Route 101, Project F-4630, West of Lynnhaven Inlet, be awarded to the low bidder, G. Y. Carpenter, Chester, Virginia, at his bid of \$106,852.72, setting aside 10% additional to cover the cost of engineering and additional work, making a total of approximately \$118,000.00 chargeable to this Project, subject to securing a satisfactory right of way along the north side of the Norfolk and Southern tracks, and in view of the following letter received from the low bidder - "In regard to my low bid on the Lynnhaven Inlet-Norfolk Road, Project 101, I hereby agree that you may retain my certified check for ninety days from date of opening bids, and that my prices named in the low bid above mentioned will obtain for

that period of time". Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Masnie, that the Commission confirm the award of contract for the construction of 4.776 Miles 18' bituminous macadam, Route 11, Project F-308A, .1 Mile West of Tacoma to East Corporate Limits of Norton, to the low bidder, Norton Construction Company, Norton, Virginia, at their bid of \$360,457.28, setting aside 10% additional to cover the cost of engineering and additional work and \$4150.00 for detours, making a total of approximately \$225,000.00 chargeable to this project. Motion carried.

Moved by Mr. Truxtun, seconded by Mr. Gilmer, that the Commission confirm the award of contract for the construction of Project G-833A, Route 39L, Yorktown - 1.87 Miles South, to the low bidder, G. Y. Carpenter, Chester, Virginia, at his bid of \$52,441.24, setting aside 10% additional to cover the cost of engineering and additional work and \$1400.00 for detours, making a total of approximately \$60,000.00 chargeable to this project, this contract is awarded with the understanding that the Commission will change the location of the road so as not to interfere in any way with the foundation of the old Nelson House, provided this is set aside as an historical point in futurity and marked. Motion carried.

Moved by Mr. Masnie, seconded by Mr. Truxtun, that the Commission confirm the award of contract for the grading and drainage of Project 392D, Route 14, west end Jackson River Bridge at Covington - 4.14 Miles West, inclusive of bridge over Denlap Creek, to Hall and Mitchell on informal bid submitted in letter dated February 16, 1928, amounting to \$21,724.20, setting aside 10% additional to cover the cost of engineering and additional work, making a total of approximately \$24,000.00 chargeable to this project. Motion carried.

Moved by Mr. Truxton, seconded by Mr. Massie, that the Commission adopt the line as surveyed through Boydton, Routes 12 and 201, unless a careful survey reveals that a better line can be secured. Motion carried.

Moved by Mr. Massie, seconded by Mr. Truxton, that the Commission adopt the proposed change of Route 181, a distance of about one-half mile in Nelson County and grade and drain this short section. Motion carried.

Moved by Mr. Massie, seconded by Mr. Gilmer, that the Commission authorize the use of the State's equipment to oil the section of road through the Government Work House property near Ocoquan down to the Bridge over Ocoquan Creek and maintain up to the Bridge on the Ocoquan side, provided the material and labor are furnished free of cost to the State, the road widened to a proper width, and the Government will maintain the road thereafter. Motion carried.

Moved by Mr. Truxton, seconded by Mr. Massie, that the Commission grant a permit to the Piankittuck River Bridge Company to construct a toll bridge over the Piankittuck River at Twigg's Ferry and to the Wicomico River Bridge Company to construct a toll bridge over the Wicomico River at Tapers, both permits having a recapture clause of five years, the location of said bridges to be approved by the State Highway Commission after being advertised and unless there are objections made in writing by fifty or more free holders, certified to by the Clerk of the Court, within thirty days after such notice. Motion carried.

Moved by Mr. Truxton, seconded by Mr. Shirley, that after careful consideration of the requests for permission to construct a toll bridge over New River at Jackson's Ferry, on State Highway No. 15, the Commission decided not to issue a permit to any company or individual for the construction of such a bridge at this time. Motion carried.

Moved by Mr. Truxtun, seconded by Mr. Gilmer, that Permit #4824 issued to the Carrell and Grayson Telephone Company, Galax, Virginia, December 7, 1927, be cancelled as the work was never done and has been abandoned. Motion carried.

across the James River between Jamestown Island and Scotland Neck landing, Route 592, in accordance with the recent Act passed by the Legislature, carrying a recapture clause of twenty years. Motion carried.

The Commission then adjourned until the next morning, March 16th, and proceeded to Richmond where the business meeting was continued.

Moved by Mr. Gilmer, seconded by Mr. Truxtun, that the Commission furnish the posts and erect the markers at the County lines and towns if the Conservation and Development Commission will furnish the markers and the historical information. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Truxtun, that the request of the Commission under Chapter 222, Acts approved March 14, 1918, for a pass for one of its members to be used on business over the Macdipongo Bridge having been rejected, that said Bridge Company be requested to advise the Commission as to its attitude in regard to issuing passes to the employees of the State Highway Department when the construction of State Highway No. 24 is undertaken. Motion carried.

Moved by Mr. Truxtun, seconded by Mr. Gilmer, that the Commission recommend to the next Legislature that the Toll Bridge Bill, Chapter 222, Acts of 1918, be amended so as to cover all toll roads, bridges and ferries within the State. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Macale, that the Commission accept the offer of the Virginia Military Institute and pay the freight if same is not excessive, on a pontoon bridge, provided the Commission will have the use of said bridge when they deem it necessary or advantageous.
