MEETING OF STATE HIGHWAY AND TRANSPORTATION COMMISSION EAGLE ROCK, VIRGINIA

MARCH 26, 1931

Minutes of the Meeting of the State Highway Commission, held in Eagle Rock, Va., March 26,1931.

On the morning of March 26, 1951, the State Highway Commission, consisting of Messre. H. G. Shirley, Commissioner, Wade H. Massie, Secretary, I. Walke Truxtun, and Wm. H. East, went to Eagle Rock, and gave a hearing in the afternoon in the school house, on the location of Boute 17, there being a large attendance.

After all who wished to be heard had presented their views, the following business was transacted.

Moved by Mr. Truxtun, seconded by Mr. Bast, that the minutes of the meeting of the Commission held on February 16, 1951, be approved. Motion carried.

Moved by Mr. Truxtun, seconded by Mr. East, that the contract on Route 14, Project 592A, 2.26 Miles N. Buena Vista-Lexington, awarded to the Morton Construction Company, Norton, Va., be declared in default as the Morton Construction company were unable to give bond and carry out their contract. Further, that their check for \$1,000.00 be forfeited and the work be given to the next low bidder, K. L. Black & Co., Richmond, Va., at their bid of \$85,115.00, with 10% additional set aside to cover the cost of engineering and additional work, making a total of approximately \$92,000.00 chargeable to this project. Motion carried.

Moved by Mr. Massie, seconded by Mr. East, that the Commission confirm the award of contract on Route 14, Project F597Al, Balcony Falls-Buena Vista, to the low bidder, Hall and Mitchell, Meswick, Va., at their bid of \$25,796.5l, and that 10% additional be set aside to cover the cost of engineering and additional work, and \$12,207.80 for surface treatment, making a total of approximately \$41,000.00 chargeable to this Project. Notice carried.

Moved by Mr. East, seconded by Mr. Massie, that the C commission confirm the award of contract on Route 51, Project 8695, Bridge over Po. River, to the low hidder, Boatwright, Russell and Linton, Manassas, Va., at their bid of \$7,789.52, and that 10% additional he set aside to cover the cost of engineering and additional work, making a total of approximately \$9,000.00 chargeable to this project. Motion carried.

Rosnoke, Va., at their bid of \$45,793.20, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$49,000.00 chargeable to this project. Motion carried.

Boxers, Whiteville, N.C., et his bid of \$6,851.70, and that 10% additional be set eside to cover the cost of engineering and additional work, making a total of approximately \$8,000.00 chargeable to this project. Motion carried.

Moved by Mr. Truntum, seconded by Mr. Massie, that the Commission confirm the award of contract on Route 51, Project F175-E2, Bridge over Proctors Creek, to the low bidder, Fredericksburg Bridge Co., Fredericksburg, Ve., at their bid of \$2,771.00, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$3,000.00 chargeable to this project. Motion carried.

Motion carried.

Moved by Mr. Massie, seconded by Mr. Shirley, that the Commission confirm the award of contract on Route 12, Project P671-CB, Greensville County Line-C.5 Mi. W. Edgerton, to the low bidder J. J. Battershill and son, Buens Vista, Va., at their bid of \$44,079.59, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$49,000.00 chargeable to this project. Motion carried.

Moved by Mr. East, seconded by Mr. Shirley, that the Commission confirm the award of contract on Route 28, Project F693-A, 0.5 Mi. 8. Madison-7.88 Mi. S. Madison, to the low bidder, Perkins-Barnes Construction Co. Inc., Blackstone, Va., at their bid of \$28,545.10, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$52,000.00 chargeable to this project. Motion carried.

Moved by Mr. East, seconded by Mr. Messie, that the Commission confirm the award of contract on Route 39, Project 7641-E, 1.95 Mi. W. of W.C.L. Waynesboro, to the low bidder, Pocahontas Construction Co. Inc., Cass, West Va., at their bid of \$27,505.78, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$51,000.00 chargeable to this project, and that the pavement be reduced in width from 50 ft. to 20 ft.
