WHEREAS, under authority of Section 33-35.4 of the Code of Virginia 1950, as amended, request is made by the City of Charlottesville for mileage adjustments subject to maintenance payments at the rate of \$1,100 per mile annually on additional streets meeting required standards; also for a deletion of street mileage no longer eligible for maintenance payments.

NOW, THEREFORE, BE IT RESOLVED, that quarterly payments at the rate of \$1,100 per mile annually be made to the City of Charlottesville on additional streets, totaling 1,20 miles and meeting required standards; also that 0.29 mile of streets no longer eligible due to urban renewal be deleted effective beginning April 1, 1969 for the quarterly payment due after June 30, 1969.

Mr. Fugate presented a plan for adjustment of the Interstate System in the Hampton Roads area and following discussion the following resolution was adopted:

Moved by Mr. Duckworth, seconded by Judge Weaver that,

WHEREAS, the 1968 Federal-Aid Highway Act, Section 14 (a), adjusted the national interstate system to include an additional 1,500 miles; and

WHEREAS, under this provision the Virginia Highway Commission on October 10, 1968, asked for additional mileage which included that needed to fill a 20.5-mile gap in a Hampton Roads metropolitan area beltway; and

WHEREAS, the U.S. Department of Transportation allocated 9.2 miles of the 20.6 miles requested, and suggested that 11.3 miles be transferred from the currently planned system — on Interstate Route 64 between the Newport News Connector and Ward's Corner, including the planned parallel tube at the existing Hampton Roads Bridge-Tunnel — in order to complete the new facility; and

WHEREAS, neither the Highway Commission nor the six municipalities in the Hampton Roads area believe it is desirable or feasible to delete the 11.3 miles from the currently approved interstate system; and

WHEREAS, as an alternative the Commission would be receptive to using the 9.2 additional miles to provide a facility beginning at the present intersection of Interstate Route 64 and the Newport News Connector and extending southward along the Connector to a point near thelandfill at Cransy Island, and further would be receptive to assuming the responsibility of constructing the section from Cransy Island to the intersection with Interstate Routes 64 and 264 at Bowers Hill to interstate standards with regular highway funds, to assure completion of the beltway; and

WHEREAS, the Commission further agrees that if this plan is carried forward, the segment built with regular funds would become a part of the interstate highway system;

NOW, THEREFORE, he it resolved that the Virginia Highway Commission authorise the State Highway Commissioner to seek approval of this concept by the U.S. Department of Transportation so that planning for these clearly needed facilities may move forward.

WHEREAS, the economic and social effects of the proposed location have been examined and given proper consideration, and this evidence, along with all other, has been carefully reviewed, now therefore

BE IT RESOLVED, that the construction of this project be approved in accordance with the general plan as proposed and presented at the Public Hearing by the Department Engineers. This proposed improvement generally consists of the addition of parallel lanes (24' pavement) on the south side to expand the existing two-lane facility to four lanes.

NOW, THEREFORE, the conveyance of the said land of the said right of way in accordance with the provisions of \$33-76.6 of the 1950 Code of Virginia, as amended, is approved and the State Highway Commissioner is hereby authorized to execute a quitclaim deed conveying any rights of the Commonwealth in said land to the owner or owners of the adjoining land for a consideration satisfactory to this Department.

MOTION CARRIED.

Moved by Mr. Landrith, seconded by Mr. Baughan that,

WHEREAS, the Commonwealth is the apparent owner of the right of way of State Route T-1014 (Beattle Avenue); and

WHEREAS, the construction of Route 107, State Highway Project 0107-086-101, RW-201, relocated a portion of said Route T-1014 (Beattle Avenue) from a point 80 feet opposite approximate Station 10+11. 76 (field revised centerline Route 107) to a point 55 feet opposite approximate Station 12+46 (field revised centerline Route 107) and serves the same citizens as the old location and the new location has been approved by the State Highway Commissioner; and

WHEREAS, at a regular meeting of the Board of Supervisors of Smyth County, held on March 11, 1969, a resolution was passed abandoning as a public road the said section of Route T-1014 (Beattie Avenue); and

WHEREAS, the owner of the adjoining land, in order to more fully develop his property, has requested that the old right of way of Route T-1014 (Beattie Avenue) be conveyed to him; and

WHEREAS, the State Highway Commissioner has certified in writing that the old right of way of Route T-1014 (Beattie Avenue) lying between the new northeast proposed right of way line of Route 107 and the northeast right of way line of Route T-1014 (Beattie Avenue) from a point 80 feet opposite approximate Station 10+11.76 (field revised centerline Route 107) to a point 55 feet opposite approximate Station 12+45 (field revised centerline Route 107) of the above project does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the State Highway System.

NOW, THEREFORE, in accordance with the provisions of Section 33-76.11 of the 1950 Code of Virginia, as amended, the conveyance of said land and right of way, so certified, to the owner of the adjoining land is hereby approved and the State Highway Commissioner is authorized to execute a deed of quitclaim for same, accordingly, for a consideration satisfactory to the State Right of Way Engineer and subject to any restrictions he may deem requisite.

MOTION CARRIED.

Moved by Mr. Landrith, seconded by Mr. Baughan that,

WHEREAS, in connection with Route 297, State Highway Project 0297-015-102, RW-201, the Commonwealth acquired from R. L. Wood, Incorporated, by amended certificate No. C-13764, dated May 13, 1968, as recorded in Deed Book 400, Page 148, in the Office of the Clerk of the Circuit Court of Campbell Co.,

later settled by an Agreement After Certificate, certain lands for the construction of the aforesaid project including the land necessary to relocate a portion of Route 1505; and

WHEREAS, said Route 1505 has been reconstructed under the above project on a new location between survey Station 793+50.50 (centerline EBL Route 297) =10+00 (survey centerline relocated Route 1505) to survey Station 18+50 (and relocated Route 1505) and serves the same citizens as the old location and the new location has been approved by the State Highway Commissioner; and

WHEREAS, at the regular meeting of the Board of Supervisors of Campbell County, held on September 16, 1968, a resolution was passed abandoning as a public road the old section of Route 1505; and

WHEREAS, at the time of execution of the Agreement After Certificate, it was agreed that it would be recommended to the State Highway Commission that the old location of Route 1505 would be conveyed to the adjoining landowner; and

WHEREAS, the State Highway Commissioner has certified, in writing, that the old right of way of Route 1505 lying between the southeast proposed right of way line of Route 297 from a point at approximate survey Station 11+09 (centerline of old location of Route 1505) to a point on the northwest right of way line of relocated Route 1505 at approximate survey Station 15+62 (centerline of old Route 1505) does not constitute a section of the public road and is deemed by him no longer necessary for the use of the State Highway System.

NOW, THEREFORE, the conveyance of said parcel, so certified, to the owner of the adjacent land, in accordance with the provisions of § 33-76.11 of the 1950 Code of Virginia, as amended, is hereby approved and the State Highway Commissioner is authorized to execute in the name of the Commonwealth a quitclaim deed, accordingly.

MOTION CARRIED.

Moved by Mr. Landrith, seconded by Mr. Baughan

WHEREAS, in connection with Route 698, State Highway Project 0698-044-162, C-501, the Commonwealth acquired by Omnibus deed, dated August 10, 1966, as recorded in Deed Book 201, Page 106, in the Office of the Clerk of the Circuit Court of Henry County, certain lands needed for the construction of the captioned project, of which a portion of the land is lying outside of the normal right of way; and

WHEREAS, Route 698 was relocated from a point opposite approximate survey Station 50+20 (centerline Route 698) to a point opposite approximate survey Station 53+40 (centerline Route 698); and the new road serves the same citizens as the old road which was constructed in lieu, thereof, and has been approved by the State Highway Commissioner; and

WHEREAS, the adjoining landowners of the land lying between the new north proposed right of way line and the center of old Route 698, in order to more fully develop their property, have requested that any unneeded land be conveyed to them; and

WHEREAS, the County Board of Supervisors, at their regular meeting held on the 27th day of January. 1969, abandoned the said old section of Route 698; and

WHEREAS, the State Highway Commissioner has certified, in writing, that the land lying north of the new north proposed right of way line from a point 35 feet opposite approximate survey Station 50+20 (centerline Route 698) to a point 35 feet opposite approximate survey Station 53+40 (centerline Route 698) does not constitute a section of the public road and is deemed by him no longer necessary for the use of the State Highway System.

NOW, THEREFORE, in accordance with the provisions of Section 33-76.11 of the 1950 Code of Virginia, as amended, the conveyance of said land and right of way, so certified, to the owner or owners of the adjoining land or to any person satisfactory to the State Right of Way Engineer is hereby approved and the State Highway Commissioner is hereby authorized to execute a deed of quitclaim for same accordingly at a price satisfactory to the State Right of Way Engineer and subject to any restrictions he may deem requisite.

MOTION CARRIED.

Moved by Mr. Landrith, seconded by Mr. Brughan that,

WHEREAS, in connection with Route 892, State Highway Project 0892-020-112, C-501, the Commonwealth acquired from CECO Corporation by Certificate No. C-10149, dated August 16, 1965, as recorded in Deed Book 806, Page 312, in the office of the Clerk of the Circuit Court of Chesterfield County, certain lands for the construction of the said project, including a 20-foot easement for a drain ditch on the right of approximate survey Station 296+46 (centerline proposed westbound lane); and

WHEREAS, during the condemnation case, it was determined that the permanent 20-foot easement was not on the property of CECO Corporation, was not considered as a part of the taking during the condemnation trial, and has been determined no longer necessary; and

WHEREAS, the State Highway Commissioner has certified in writing that the permanent 20-foot easement on the right of approximate survey Station 296+46 (centerline proposed westbound lane) and extending from the northeast proposed right of way line in a northeast direction for a distance of 160 feet does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the State Highway System.

NOW, THEREFORE, the conveyance of said easement, so certified, in accordance with the provisions of § 33-76. If of the 1950 Code of Virginia, as amended, is hereby approved and the State Highway Commissioner is authorized to execute in the name of the Commonwealth a guitolaim deed.

MOTION CARRIED.

Moved by Mr. Fitzpatrick, seconded by Mr. Chilton that.

WHEREAS, Section 33-136.1 of the Code of Virginia provides a fund for fiscal 1968-69 of \$1,500,000 to "...be expended by the Commission for constructing, reconstructing, maintaining or improving access roads within counties, cities and towns to industrial sites on which manufacturing, processing or other establishments will be built under firm contract or are already constructed."; and

WHEREAS, the City Council of the City of Martinsville has by resolution requested the use of industrial access funds to assist in the reconstruction of Rives Road, from the SCL of Martinsville to 0.55 mile north, to serve Nationwide Homes, Incorporated, estimated to cost \$60,000; and

WHEREAS, it appears that this request falls within the intent of Section 33-136.1 and has complied with the provisions of the Highway Commission's policy on the use of industrial access funds.

NOW, THEREFORE, BE IT RESOLVED that \$22,000 from the industrial access fund for 1968-69 be allocated for the purpose of assisting in the reconstruction of Rives Road, from the SCI, of Martinsville north 0.55 mile, Project 9999-120-101, C-501, contingent upon Nationwide Homes, Incorporated entering into a firm contract for the construction of its facility, the necessary rights of way and adjustment of all utilities being provided at no cost to the Commonwealth, and the financing as indicated below:
