MINUTES OF MEETING OF STATE HIGHWAY COMMISSION

Richmond, Virginia

March 15, 1973

The monthly meeting of the State Highway Commission was held at the Central Highway Office in Richmond, Virginia, on March 15, 1973, at 10 a.m. The Chairman, Mr. Douglas B. Fugate, presided.

Present: Messrs. Fugate, Crowe, Fitzpatrick, Glass, Hall, Janney, Landes and Roos.

Absent: Mr. Eakin.

On motion of Mr. Fitzpatrick, seconded by Mr. Glass, minutes of the meeting of February 15, 1973, were approved.

On motion of Mr. Fitzpatrick, seconded by Mr. Glass, permits issued from February 15, 1973, to March 14, 1973, inclusive, as shown by records of the Department, were approved.

Motion was made by Mr. Fitzpatrick, seconded by Mr. Glass, that cancellation of permits from February 15, 1973, to March 14, 1973, inclusive, as shown by records of the Department, be approved. Motion carried.

Mr. Blundon advised that, at a meeting on February 15, 1973, the Albemarle County Board of Supervisors had appointed a committee to study the problem of Albemarle County arranging for their park authority to take over the operation and maintenance of the Warren and Hatton Ferries (which the Highway Commission had proposed discontinuing), or as an alternate that Albemarle County bear the cost of maintenance and operation from their secondary funds. WHEREAS, the economic, social and environmental effects of the proposed project have been examined and given proper consideration, and this evidence, along with all other, has been carefully reviewed.

NOW. THEREFORE, BE IT RESOLVED, that the major design features of this project be approved in accordance with the plan as proposed and presented at the said design public hearing by the Department engineers, and

WHEREAS, proper notice was given in advance and all those present were given a full opportunity to express their opinions and recommendations for or against the proposed project as presented, and their statements being duly recorded, and

WHEREAS, the economic, social and environmental effects of the proposed project have been examined and given proper consideration, and this evidence, along with all other, has been carefully reviewed.

NOW, THEREFORE, BE IT RESOLVED, that the location of this project be approved in accordance with the plan as proposed and presented at the said location public hearing by the Department's engineers, and

BE IT FURTHER RESOLVED, that the relocation from about 0.3 mile north of Indian Creek Road to near Sign Pine Road, and the Great Bridge Bypass from near Kegman Road to the intersection of Route 168 near Oak Grove, including all necessary ramps, connections, etc., be declared a Limited Access Highway in accordance with Article 4, Chapter 1, Title 33.1 of the 1950 Code of Virginia, as amended, and in accordance with Highway Commission policy, and

BE IT ALSO FURTHER RESOLVED, that pursuant to Section 33.1-34 of the 1950 Code of Virginia, as amended, the proposed Great Bridge bypass, a distance of approximately 4.0 miles, be added to the Primary System of Highways.

WHEREAS, under authority of Section 33.1-43 of the Code of Virginia of 1950, as amended, request is made by the Town of Christfansburg for maintenance payments at the rate of \$1,500 per lane mile annually on additional streets meeting required standards.

NOW, THEREFORE, BE IT RESOLVED, that the quarterly payments at the annual rate of \$1,500 per lane mile be made to the Town of Christiansburg on additional streets, totaling 0.86 mile, with a lane mileage of 1.72 miles, and meeting standards required by the aforementioned section of the Code, effective April I, 1973, for the quarterly payments due after June 30, 1973. The additional streets and mileage eligible for payment are described as follows:

These additions, totaling 0.85 mile, increase the total mileage in the Town of Christiansburg from 35.41 miles to 36.27 miles of approved streets, and the lane mileage increases by 1.72 miles, changing the total lane miles from 70.82 to 72.54 miles subject to payment.

that

WHEREAS, under authority of Section 33.1-43 of the Code of Virginia of 1950, as amended, request is made by the City of Harrisonburg for maintenance payments at the rate of \$1,500 per lane mile annually on additional streets meeting required standards, also for deletion of street mileage no longer eligible for maintenance payments.

NOW, THEREFORE, BE IT RESCLVED, that the quarterly payments at the annual rate of \$1,500 per lane mile be made to the City of Harrisonburg on additional streets, totaling 2.07 miles, and deletions of 0.16 mile for a net addition of 1.91 miles, with a lane mileage of 4.58 miles, and meeting standards required by the aforementioned section of the Code, effective October 1, 1972, for the quarterly payments due after December 31, 1972. The additions and deletions subject for payment are described on attached tabulation Sheets No. 1 and 2, dated October 1, 1972.

WHEREAS, in accordance with the statutes of the Commonwealth of Virginia and Highway Commission policies, a location and design public hearing was held in the Circuit Courtroom of the Botetourt County Courthouse on August 8, 1972, at 10:30 a.m., for the purpose of considering the proposed dual laning of Route 220 from 0.951 mile north of the North Corporate Limits of Fincastle to 7.591 miles north of the North Corporate Limits of Fincastle, State Project 0220-011-101, C-503, B-601, and

WHEREAS, proper notice was given in advance and all those present were given a full opportunity to express their opinions and recommendations for or against the proposed project as presented, and their statements being duly recorded, and

WHEREAS, the economic, social and environmental effects of the proposed project have been examined and given proper consideration, and this evidence, along with all other, has been carefully reviewed,

NOW, THEREFORE, BE IT RESOLVED, that the location and major design features of this project be approved in accordance with the plan as proposed and presented at the said location and design public hearing by the Department's engineers.

MOTION CARRIED

Mr. Hall reported for Commission committee composed of himself as chairman, Mr. Glass and Mr. Fitzpatrick, that the committee had met with representatives of the Appalachian Power Company, the American Electric Power Company, and the Department of Highways on March 8, 1973, and after discussion of his report, the Commission adopted the following resolution:

Moved by Mr. Hall, seconded by Mr. Fitzpatrick, that

MHEREAS, the Virginia Department of Highways has been planning for the needed improvements of Route 58 between Independence and Galax since 1956, and

WHEREAS, the Appalachian Electric power Company has been planning their Blue Ridge Project, which would inundate much of this route, since 1962, and

WHEREAS, this has caused unusual delay in making the much needed improvements to a major portion of this route, and

WHEREAS, the Grayson County Board of Supervisors, Galax City Council, and Independence Town Council have recently submitted resolutions requesting the Department to proceed without further delay with the construction of Route 58 between Independence and Galax irrespective of the status of the proposed Blue Ridge Project, and

WHEREAS, the Highway Commissioner appointed a committee consisting of Mr. Leonard R. Hall, Chairman, Mr. Thomas R. Glass and Mr. Earl A. Fitzpatrick to review all factors involved and prepare a report for Commission consideration, and

WHEREAS, this comprehensive report was submitted on March 12, 1973, and has been carefully reviewed.

NOW, THEREFORE, BE IT RESOLVED, that the Virginia Department of Highways will proceed immediately with the necessary planning and development of Route 58 between Independence and Galax along the "Low Line."

MOTION CARRIED

On motion of Mr. Glass, seconded by Mr. Janney. the Commission authorized termination of the construction fund of the Revenue Bond Projects (1954 Series) into the sinking fund, effective May 31, 1973.

Mr. Busser, Management Services Officer, reported on steps being taken in transfer of the Richmond-Petersburg Turnpike and the Elizabeth River Tunnel facilities to the Department of Highways.

Mr. Fugate expressed appreciation to the Commission members for their attendance at pre-allocation hearings being held in each district. He said these meetings had been very well accepted on the part of the citizens and he felt they should be continued each year.

He said allocations to systems would be made in April and to projects in May, with final hearings at Roanoke and Richmond in June.

The meeting was adjourned at 11:35 a.m.
