Mr. King briefed the Commission on the revenue situation. Many people, including Governor Robb, Secretary Fogarty, and members of the legislature, as well as local groups, have devoted much time and effort during the 1982 session of the General Assembly to trying to find a solution. As a result, he said, major assistance is going to be provided.

It is estimated that the tax legislation passed will produce about \$263 million for highways and public transportation in the 1982-84 biennium. This will almost double the funds available for improvement of primary, secondary and urban systems in the coming fiscal year-increasing the total amount for those three systems from about \$113.8 million to \$223.7 million. For the primary system it will mean \$95 million instead of \$40 million ... for the secondary system, \$69 million instead of \$38 million ... and for the urban system, \$60 million instead of \$36 million.

Mr. King stated the Commission would now be given the resources to make many critical improvements it would have been impossible to undertake otherwise, and commended the legislature for its courageous action in providing the funds which will benefit all motorists of the state.

WHEREAS, the State Highway and Transportation Commissioner has certified in writing that the abandoned section of old Route 706 which lies north of relocated Route 706 from a point 25 feet left of approximate Station 12+40 (relocated Route 706 centerline) to a point approximately 45 feet left of approximate Station 16+00 (relocated Route 706 centerline) and containing approximately 0.29 acre, more or less, does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the State Highway System.

NOW, THEREFORE, in accordance with the provisions of Section 33.1-154 of the Code of Virginia (1950), as amended, the conveyance of the said land, so certified, to the adjoining landowner is approved and the State Highway and Transportation Commissioner is hereby authorized to execute in the name of the Commonwealth conveying same by deed of quitclaim for a consideration satisfactory to the State Right of Way Engineer and subject to such restrictions as may be deemed requisite.

Notion carried.

Mr. King indicated that some concern had been voiced regarding the Commission's traditional meeting date of the third Thursday of the month. Some discussion ensued, and it was decided that no change would be made at this point. The members were advised to think about changing the date, possibly to the fourth Thursday, and that the matter would be discussed again next month.

The next Commission meeting will be held April 15, 1982.
