

Minutes of the Meeting of the State Highway Commission
of Virginia, Held in Richmond
April 13, 14, 1933.

On the morning of April 13, 1933, the State Highway Commission of Virginia, consisting of Messrs. H. G. Shirley, Wade H. Massie, Secretary, I. Walke Truxtun, H. G. Gilmer and Wm. H. East, met in their office, State Office Building, Richmond, Virginia.

The meeting was called to order by the Commissioner.

Public hearings were given on the tentative allocation of funds for the primary system for all districts to those who wished to be heard.

After the public hearings the following business was transacted.

Moved by Mr. Massie, seconded by Mr. Gilmer, that insurance covering the State highway property in Lynchburg be given to James A. Scott & Son, Inc., representatives of the Insurance Company of North America, Lynchburg, Virginia, and the old policies be cancelled, due to the agent holding such insurance discontinuing operations. Motion carried.

Moved by Mr. Truxtun, seconded by Mr. Massie, that the minutes of the meeting of March 9th be approved. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Massie, that contracts be awarded on oils to the low bidders in all the districts, except the Fredericksburg. That in the Fredericksburg District 597,900 gallons be awarded to the Standard Oil Company, low bidder. That 597,900 gallons of tar be used in this district for comparative purposes, but not exceed .0835 cents per gallon applied. Motion carried.

Moved by Mr. East, seconded by Mr. Massie, that contracts be awarded to the low bidders, Vane and Garrett, 804 E. Pratt Street, Baltimore, Maryland, for the transportation of 597,900 gallons of bituminous materials for the Fredericksburg District, as recommended by the Chief Engineer on the 13th instant. Motion carried.

Moved by Mr. East, seconded by Mr. Massie, that the Commission award contract for the construction of .322 mile of One Course Macadam on Route 89, Project 8835A, 0.454 Mi. W. Churchville-0.766 Mi. W. Churchville, to the low bidder, R. W. Moore and Company, Staunton, Va., at their bid of \$6,848.59, and that 10% additional be set aside to cover the cost of engineering and additional work; \$400.00 for detours; \$547.00 for guard rail; \$884.00 for surface treatment and \$50.00 for outside slope stakes, making a total of approximately \$10,000.00 chargeable to this project. Motion carried.

Moved by Mr. Truxtun, seconded by Mr. Massie, that the following permits be approved, under the rules and regulations of the Commission.

Appalachian Electric Power Co., Roanoke, Va., to construct one service crossover on Route 33 about one mile southwest of Troutville.

Appalachian Electric Power Co., Bluefield, West Va., to erect distribution power line along Route 10 from Dublin towards Radford.

Appalachian Electric Power Co., Bluefield, West Va., to erect power line along Route 26 at Bland Courthouse, at end near Bastian and between Bastian and towards Bluefield.

Appalachian Electric Power Co., Roanoke, Va., to relocate pole line to new highway from intersection of Route 208 and Route 13 to end of line at intersection of Route 16, and construct new line from this point to Back Creek Orchard.

Appalachian Electric Power Co., Roanoke, Va., to install one primary crossover on Route 33, about half a mile east of Roanoke-Stetson County Line, near Hollins.

Appalachian Electric Power Co., Roanoke, Va., to install one three wire service crossover on Route 33, about 0.58 mile southeast of Roanoke.

Appalachian Electric Power Co., Lynchburg, Va., to erect 2 poles, install 2 guys and construct 8900v distribution line along Route 18 at its intersection with Route 10.

Appalachian Electric Power Co., Roanoke, Va., to install one service crossover on Route 208, five miles north of Roanoke.

Appalachian Electric Power Co., Roanoke, Va., to install one guy anchor on Route 10, about one and a half miles east of Roanoke.

O & P Telephone Co. of Va., Norfolk, Va., to drive 30 ft. of pipe under Route 10, placing cable beneath and across the same, between Norfolk and Virginia Beach.

C & P Telephone Co., Richmond, Va., to erect 3 poles, place 1 anchor guy and one wire crossing on Route 38 at Walker.

Wm. P. Cook & Co. Inc., Richmond, Va., to haul ties to the city dock from East Highland Park, a distance of four miles, to be completed in 7 days. License numbers of trucks TR-7028, TE-1089 and TE-3062.

E. G. Cross, Atlas, Va., to put in double entrance to store and filling station on Route 421, Project 7450.

A. L. Davis, Rocky Mount, Va., to grade entrance to proposed filling station on Route 33, between Boones Mill and Rocky Mount.

Town of Fairfax, Fairfax, Va., to install water service to new Episcopal Church on Route 36.

Town of Fairfax, Fairfax, Va., to tap water main and run connection under Route 36 to tenant house of J. M. Love.

P. S. Ford, Distributor, Gulf Refining Co., Martinsville, Va., to build driveway to garage and filling station at West Fork on Route 18, twelve miles west of Danville.

Newell Gill, Ashmeade Place, Washington, D.C., to operate motor vehicles with license tags 4E-84 and 4E-85 through Virginia for one trip from Washington to North Carolina and return, trip to be made in two days, as provided in Section 111, Chapter 342, Acts of 1932.

Town of Gordonsville, to dig up and repair water main near intersection of Routes 32 and 17 in the Town.

G. H. Grant, Suffolk, Va., to construct entrance to filling station on Route 10 about 500 yards from city limits.

Moved by Mr. East, seconded by Mr. Gilmer, that permit #12573, Hanover County, issued to the Virginia Electric and Power Co., on Route 421, be cancelled as requested. Motion carried.

Moved by Mr. Truxtun, seconded by Mr. Massie, that permit #12564, issued to the Standard Oil Company of New Jersey, on Route 17, in Rockingham County, be cancelled as requested. Motion carried.

Moved by Mr. Massie, seconded by Mr. East, that a permit be granted L. O. Major, Regional Manager, Pennsylvania Greyhound Lines, 1536 New York Avenue, Washington, D.C., to operate a coach for one trip through Virginia, advertising the Chicago World's Fair, weighing approximately 12,000 pounds, 52 ft. 5 1/2 inches in length overall and 110 inches in width overall, between April 16th and 20th. Motion carried.

Moved by Mr. Massie, seconded by Mr. East, that the Conservation and Development Commission be given permission to use the base map of the State highway system to print 100,000 copies of a "Tourist Guide and Map". Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Massie, that the Chairman be instructed to continue the camp on Route 12, Mouth of Wilson towards Troutdale until further orders from the Commission. Motion carried. Mr. Shirley voting nay.

Moved by Mr. Massie, seconded by Mr. East, that public hearings having been given as provided by law, the following allocations to the primary system be confirmed.

Motion carried.

The meeting adjourned to meet on the 14th.

On the morning of the 14th the full Commission reassembled and the following business was transacted.

Moved by Mr. Fraxtum, seconded by Mr. East, that the Commission sell to Mr. W. S. Lively, 507-11 Brewer Street, Norfolk, Virginia, one to two thousand old unused state highway maps, provided that no advertisement be placed on same. Motion carried.

Moved by Mr. Massie, seconded by Mr. Shirley, that no change be in the location of Route 41, and the contract be carried to Shadwell as let. Motion carried.

Moved by Mr. Massie, seconded by Mr. East, that the Highway Commission regrets they cannot give any further hearings on the York River Bridge project. If the Independence Bridge Company fail to comply with requirements by June first the Commission will then give the York River Bridge Corporation another hearing. Motion carried.

Moved by Mr. Massie, seconded by Mr. East, that the Department return to its regular routine of work on July first and abandon the stagger system; also that the rates of wage to be paid be those locally paid, not to exceed 25¢ per hour nor less than 15¢ per hour. Motion carried.

Moved by Mr. Massie, seconded by Mr. Frutkin, that the Chairman be instructed to proceed with condemnation proceedings immediately to take over the Bruce Bridge at West Point, if offer made is not accepted. Motion carried.

Mr. Morton L. Wallerstein, Executive Secretary of the League of Virginia Municipalities, with representatives from most of the cities in the State with population of over 5500 appeared before the Commission concerning the \$500.00 per mile additional for construction.

Mrs. George Howe and Mrs. Ma. Owen, of Washington, D.C., appeared before the Commission with reference to placing a monument at the intersection of Routes 37 and 610, leading to Wakefield.

A public hearing was given on the proposed bridge across the James River at Jamestown. Leslie Hall, Tidewater Automobile Association; Newport News, represented by Mr. J. C. Biggins, City Manager; Mr. Eberwine of Suffolk; Mr. E. F. Dagger of the Newport News Chamber of Commerce; Mr. Sykes of Smithfield; Mr. Stephens of Smithfield, representing the Jamestown Ferry; Mr. P. W. Hiden, representing the Newport News Chamber of Commerce; Mr. A. S. Johnson of Smithfield, representing the James River Bridge Corporation; Mr. Edwards, Clerk of the Board of Supervisors of Isle of Wight County, and Mr. J. M. Bridges of the Richmond Chamber of Commerce.

Moved by Mr. Shirley, seconded by Mr. Massie, that the request of Smyth County Board of Supervisors to make a survey of the road from Slaty Rocks at the intersection of Route 112 to the Rich Valley Road No. 1 at Lyons Gap School House, which is not a part of the secondary system, be not granted. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. East, that the request of the Association of the Preservation of Virginia Antiquities to widen and surface 1200 ft. of road leading to the Rolfe House in Surry County, at a cost of \$700.00 be approved, provided a 50 ft. right of way can be had. Motion carried.

Moved by Mr. East, seconded by Mr. Massie, that the resolution passed by the Commission concerning the width of city streets, be amended as follows - On meritorious and approved projects in cities of more than 5800 population and additional \$500,00 per mile will be granted on all streets where the right of way between the curb lines is 40 ft. or more; where the right of way is 30 ft. and parking is restricted to one side and where the right of way is 20 ft. and parking restricted on both sides, or where the right of way can be widened to 40 ft. That if the City Council will pass an ordinance, approved by the Mayor, agreeing that when in the judgment of the State Highway Commission the volume of traffic demands the above width of street it will be provided; or where traffic can be directed over two streets in opposite direction the width of the two streets will be considered as the width of one street, making up the 40 ft. Motion carried. Mr. Truxtun voting nay.

Mr. G. A. Massenbergh of Hampton appeared before the Commission concerning the maintenance of the Streets of Phoebus, and the construction of same by the Commission.

Moved by Mr. Shirley, seconded by Mr. East, that the Commission concur in the action of the Board of Supervisors of Chesterfield County of April 3rd, in closing a portion of the road in the secondary system leading to the James River, known as the Foxendale Road. Motion carried.

Moved by Mr. Massie, seconded by Mr. East, that the Commissioner be authorized to prepare a bill requesting the congressman from the district to introduce the same into Congress and advocate its passage, to legalize the replacement of the old iron bridge across the Staunton and Dan Rivers at Clarksville, on State Route 32, U. S. Route 16, as approved by the United States' Engineers. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Truxtun, that the former action of the Commission relative to return of two checks to the Brown Paving Company, forfeited on Projects 676E and 676F, Route 33, be reaffirmed. Motion carried.

Moved by Mr. Massie, seconded by Mr. East, that the State Highway Commissioner reports that the receiver for the Washington and Old Dominion Railway Company, Mr. Wilton J. Lambert, Roselyn, Virginia, has failed to make any response to the request of the Commission to join in the construction of an overhead crossing on Route 711 over the W & O D tracks near Fort Buffalo. The State Corporation Commission is requested to reopen this case and determine the most feasible plan for this project. Motion carried.

**Rules and Regulations
of the
State Highway Commission of Virginia
For the State Highway System and the
Secondary System of State Highways**

Section 1. All applications for permits should originate with and be made through the Resident Engineers in their respective territories.

Section 2. The provisions of all permits granted under these rules and regulations shall be construed as regulations and not as a contract and no interest or right of the applicant shall be transferred except by written consent of the State Highway Commission, and in granting permits no right or privilege belonging to the abutting property owner is interfered with or abridged, nor is the State responsible for any damage which may arise between the applicant and the property owner concerning said right of way.

Section 3. Applicants to whom permits are granted shall at all times indemnify and save harmless the State Highway Commission and the commonwealth of Virginia from responsibility for damage or liabilities arising from the construction, maintenance, repair or the operation of pole lines, surface, subsurface, or other structures and agree to move and relocate poles, wires, surface or subsurface structures erected or constructed under the provisions herein granted when ordered to do so by the State Highway Commission or representative.

Section 4. All poles, wires, surface or subsurface structures shall be maintained in good condition at all times so as not to obstruct or become dangerous to the traveling public, and in event of such poles, wires, surface or subsurface structures becoming out of repair or dangerous, the State Highway Commission may give notice to the applicant of its intention to revoke the permission herein granted and that if repairs are not made within three months after mailing said notice, the permit will be revoked and annulled and the poles, wires, surface, or subsurface structures will be removed from the highway. Where these structures obstruct or interfere with traffic or drainage, or create a danger, they must be removed at once.

Section 5. Any permit granted by the State Highway Commission shall be revocable at its pleasure.

Section 6. No telephones, telegraph, electric light, power or other poles or poles shall be planted or erected upon the State highways of this state, until written permission from the State Highway Commission is first obtained. No permits will be required for repairs of lines or replacing poles in same position.

Section 7. No pipes, conduits, sewers, drains or subsurface structures of any description shall be placed in or under the bed or right of way of any State highway, except by special written permission of the State Highway Commission, or its representative.

Section 8. No house or structure shall be moved along or across a State Highway except by special written permission of the State Highway Commission or its representative.

Section 9. No logging road, tram road, railroad, or tracks of any description shall be laid along or across a State highway until permission in writing is given by the State Highway Commission or its representative.

Section 10. No person, or persons, shall dig up or disturb the surface within the right of way of any state highway until a special permit in writing is first obtained from the State Highway Commission or its representative.

Section 11. No private driveway or roadway shall be constructed to intersect any State highway until the drainage structure necessary to carry the cross drainage therefrom shall have been approved by the State Highway Commission. (Also see Section 4.)

Section 12. In granting permits to plant poles or lay pipes or drainage or to erect structures, it must be understood that all poles or other structures, surface or subsurface, must be planted or placed as close to the property line as possible and all pipes, sewers, etc., must be laid either under the gutter or as far from the surface of the highway as is possible to lay same, it being the intent of these regulations that all surface and subsurface structures shall be placed on that portion of the right of way between the gutter and the property line.

Section 13. No logs, lumber, cord wood, other material or produce, shall be placed upon the roadway or shoulders or so placed as to interfere with the use, drainage, or maintenance of any State highway.

Section 14. No fence, building, shed, or other structure shall be erected or placed on the right of way of a State highway.

Section 15. No advertising signs of any description, except the standard direction, caution, danger or traffic control signs of the State Highway Commission, the health and pure water signs created by the State Board of Health, the historical markers erected by the Conservation and Development Commission and the signs erected to establish boundaries of State and National forests, parks and/or monuments, will be allowed within the right of way of any State highway.

Section 16. Mail boxes and newspaper containers shall be placed on posts on the same side of the road so arranged as not to interfere with traffic, maintenance, or drainage of the State highway and situated so that all deliveries will be made on the right hand side of the road, in the direction of traffic. The routing of the mail carriers being determined by the postal authorities, the routing of newspaper deliveries must be made to conform therewith. These shall be relocated or changed at the request of the State Highway Commission or its representative.

Section 17. It is unlawful to remove, injure, tamper with, destroy, break, or deface in any way, signs, bridges, or other structures, or wayside springs, or trees, shrubs, vines, or any other property growing on the right of way or placed there by the State Highway Commission or its representative.

Section 18. All wires strung above State highways shall be not less than eighteen feet above the surface of the highway and shall be so arranged as not to interfere with the convenience and safety of travel and shall be kept in safe repair at all times.

Section 19. No person, firm or corporation, shall pasture or graze, or cause to be pastured or grazed, or allow to run at large on any right of way of any road in the State Highway System, any live stock, unless such animal or animals be securely tied or held by chain or rope, so as to prevent such animal from getting on the traveled portion of the highway; provided, however, that when cattle or animals are driven over the State highway system they shall be attended by a competent flagman, preceding the drove by at least one hundred (100) feet, and one flagman in the rear at least one hundred (100) feet, properly equipped to warn traffic.

Section 20. No person, firm, or corporation, shall cause or permit to stand on the right of way of any road in the State highway system any vehicle, implement, or contrivance for the purpose of taking in gasoline; or on any road in the Secondary system where it would create a traffic hazard.

Section 21. No person, firm, or corporation, shall put or cast, or cause to be put or cast into any road or on any bridge in the State highway system any glass, bottles, glassware, crockery, porcelain, or pieces thereof, or any pieces of iron or hard or sharp metal, or any nails, tacks, or sharp pointed instruments of any kind, or any object or substance of any kind likely in nature to cut or puncture any tire of any vehicle, or injure any animal or person, or any other refuse or material within the right of way.

NOTE: For act of the legislature similar in purport, see Code section 4745.

Section 22. No person, firm, or corporation, shall drag or cause to be dragged along or across a State highway any log, harrow, or other implement or article that would injure the surface of the highway or the shoulders thereof.

The rules and regulations heretofore made by the State Highway Commission November 6, 1924, effective February 1, 1925, are hereby repealed as of the date the rules and regulations hereby adopted become effective.
