

Minutes of the Meeting of the State Highway
Commission of Virginia, Held in
Richmond, April 4, 1939.

On the morning of April 4th, 1939, the State Highway Commission, consisting of Messrs. H. G. Shirley, Wade E. Masnie, Secretary, S. W. Rawls, J. F. Wyszor and Kenneth H. Gilpin, met in their office, State Office Building, Richmond, Virginia.

The meeting was called to order by the Commissioner.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the minutes of the meeting of February 3rd be approved. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Masnie, that the Commission award contract for the construction of five residency offices, Luray, Rocky Mount, Edinburg, Fincastle and Dillwyn, to the low bidder, Taylor Manufacturing Company, Inc., Farmville, Va., on alternate bid for the five buildings in one group at -

Motion carried.

Moved by Mr. Gilpin, seconded by Mr. Rawls, that the Commission construct an underwalk on Route 250 at Fishersville High School. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Shirley, that the question of an actuated light in Wakefield be postponed. Motion carried.

Moved by Mr. Gilpin, seconded by Mr. Shirley, that the request of the City of Danville to place maintenance on Route 29 through the City as soon as Alternate 29 is eliminated, be approved. Motion carried.

RESOLUTION ORDERING THE FILING OF BIDS

WHEREAS, pursuant to advertisement, bids for the construction of the electrical work for the Central Highway Office Building have been filed by the following Bidders:

RESOLUTION AWARING CONTRACT

WHEREAS, Carneal, Johnston & Wright, Consulting Architects and Engineers, pursuant to a Resolution heretofore adopted, have tabulated and considered all bids heretofore received for the construction of electrical work for the Central Highway Office Building, and have duly made their recommendations to this Commission, and it appearing from said recommendations and report that A. L. Greene & Company, Richmond, Virginia, is the lowest and best Bidder for the construction of the electrical work for the Central Highway Office Building, in the sum of \$22,987.00 and Special Provisions - Awarded with option that Alternate Item # 1, \$500.00; Item # 2, \$1,190.00; and Item # 3, \$19,233.00 may be accepted within sixty days; and that this Commission, after considering said report and recommendations and all bids heretofore filed, finds that the bid of A. L. Greene & Company is the lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED BY THE State Highway Commission of Virginia, AS FOLLOWS:

Section 1. That the bid of A. L. Greene & Company for the construction of electrical work for the Central Highway Office Building, in the sum of \$22,987.00 and Special Provisions - Awarded with option that Alternate Item # 1, \$500.00; Item # 2, \$1,190.00; and Item # 3, \$19,233.00 may be accepted within sixty days; is hereby accepted, determined and declared to

be the lowest and best bid, however, this award shall not be effective until the awardee shall have been notified in writing by the Architects of the State Highway Commission of such award. That upon the awardee being so notified in writing a contract for the construction of said work, as heretofore prescribed by the plans, specifications and contract documents, shall be forthwith executed for said construction.
