MINUTES OF MEETING OF STATE HIGHWAY COMMISSION

Charlottesville, Virginia

May 9, 1974

The monthly meeting of the State Highway Commission was held in the Tilton E. Shelburne Research Building at the University of Virginia in Charlottesville, Virginia, on May 9, 1974, at 9:30 a.m. The Chairman, Mr. Douglas 8. Fugate, presided.

Present: Messrs. Fugate, Crowe, Eakin, Fralin, Hall, Glass, Janney, Landes and Roos.

Mr. Fugate said this is the largest budget the Department has ever had; but due to inflation in costs, this money will not go as far in construction of highways as some of the lesser budgets of the past.
