Roos, Hassell and Hooper to serve as an ad hoc committee (with Mr. Roos as Chairman) to make a study as to whether the Commission should employ consultants to study the toll rate structure to determine if it would be feasible to establish a cumuter rate as outlined in a letter received from Senator A. Joe Canada, Jr., of Virginia Beach. The Trust Indenture states that no change in the toll rates can be made without the recommendation of the traffic consultants named in the Indenture, and usually the cost of such studies average around \$25,000 to \$30,000. Mr. Fugate told the committee members that no commitments have ever been made by the Highway and Transportation Commission as to establishment of a commuter rate, and insofar as he was aware, this was the first suggestion that one be considered. He said there are obvious administrative problems in collecting and administering a commuter rate even if the revenue could be lowered. Mr. Busser will act as secretary to the committee.

WHEREAS, the State Highway and Transportation Commission was advised at its meeting held on the 17th day of April, 1975, that there are 193 parcels of surplus property owned by the Department throughout the State; and

WHEREAS, in order to recover our investment, we propose to dispose of these parcels as rapidly as we feel the market will absorb them and recommend that the following procedures be approved:

- Refer each parcel to the District Engineer in whose territory the parce? in question may be located for a review and report as to whether or not the area is needed for present or future highway and transportation needs. If the District Engineer advises the area is needed, he must give specific need and estimated time of need in writing.
- Refer to the various divisions of the Department of Highways and Transportation the parcels proposed for sale and have them certify not needed, or advise in writing the specific need and estimated time of need, if recommendation to retain is made.
- Refer to other State Agencies the parcels to be disposed of and give them thirty (30) days to reply. Also, advise if any agency needs any specific parcel, it can be acquired for appraised value.
- 2. We propose to have the parcels that can be disposed of appraised and reviewed to establish the market value in accordance with the Department's policies and procedures.
- 3. The parcels will be advertised for public sale, either by sealed bids or auction as the Department may deem appropriate in each individual case.
- 4. Sale will be made to the highest bidder, providing the bid is equal to or greater than the appraised value.
- 5. When public bids do not equal the appraised value, we would then attempt to sell by negotiation for the appraised value or adjusted value. If revision in value is deemed advisable.

When the Department is in a position to make final sale, approval of the Commission, if required, will be requested.

NOW, THEREFORE, BE IT RESOLVED, these procedures for the selling of these parcels of land are hereby approved.

#### MOTION CARRIED

Mr. Blundon presented proposed allocations of Interstate, Rural Primary and Urban Construction Funds for the fiscal year 1975-76; and on motion of Mr. Glass, seconded by Mr. Hooper, the allocations as presented were approved.

The projected year's total of \$295 million amounts to some 90% of the total funds that were allocated in fiscal 1974-75. All systems received less monies than were available for the current year, and similarly the combined allocations to each of the several construction districts will indicate a decrease from the 1974-75 level. The Interstate System received some \$12 million less, the Primary System some \$10.8 million less, and the Urban System some \$6.3 million less. The allocations to provide aid to mass transit throughout the Commonwealth amount to \$4,275,000. These are shown in the various district tabulations and do not include the \$11,575,140 which was set aside by Chapter 681 of the Acts of the General Assembly of 1974. Including the funds established by the General Assembly, the total highway funds to mass transit for 1975-76 are \$15,850,140.

It is estimated that approximately 60% of the Primary and Urban allocations will be applied towards work either completed or under construction. Because of this fact, and since the revenues have dropped, the Department has been able to recommend only a handful of initial allocations towards major new projects and has been able to provide allocations that will eventually accomplish approximately 100 safety projects of various types.

Hearings on the allocations to Interstate, Rural Primary and Urban Construction will be held at Roanoke on June 4 for the Bristol, Salem, Lynchburg and Staunton Districts, and at Richmond on June 19 for the Richmond, Suffolk, Fredericksburg and Culpeper Districts.

The June Commission meeting will be held at the Central Office on June 19 following the allocation hearing.

The meeting was adjourned at 10:20 a.m.
