#### MINUTES OF MEETING OF STATE HIGHWAY AND TRANSPORTATION COMMISSION

#### Richmond, Virginia

May 15, 1980

The monthly meeting of the State Highway and Transportation Commission was held at the Central Highway Office in Richmond, Virginia, on May 15, 1980, at 10 a.m. The chairman, Mr. Harold C. King, presided.

Present: Messrs. King, Anderson, Fralin, Hall, Hooper, Landes, Robinson, Roos, and Wrench.

Absent: Messrs. Hassell and Mohr.

On motion of Mr. Hooper, seconded by Mr. Fralin, the minutes of the meeting of April 17, 1980, were approved.

On motion of Mr. Hooper, seconded by Mr. Fralin, permits issued from April 17, 1980, to May 14, 1980, inclusive, as shown by records of the Department, were approved.

Motion was made by Mr. Hooper, seconded by Mr. Fralin, that cancellation of permits from April 17, 1980, to May 14, 1980, inclusive, as shown by records of the Department, be approved. Motion carried.

Moved by Mr. Hooper, seconded by Mr. Fralin, that the Commission approve additions to the Secondary System from April 17, 1980, to May 14, 1980, inclusive, as shown by records of the Department. Motion carried.

Mr. King stated he had asked the Commission's Toll Road Committee, comprised of Messrs. Roos, Hassell, and Hooper, to review the general operations of the Jamestown-Scotland ferry across the James River, as a result of requests made by citizens who attended the Department's preallocation hearing in Suffolk last month.

Mr. Frain stated that some coordination should be made between the number of location and design approvals presented to the Commission each month and anticipated revenues in the coming years. Mr. King stated this would be looked at by the management study currently under way.

Moved by Mr. Hooper, seconded by Mr. Fralin, that the Commission confirm letter ballot action on the following resolution:

WHEREAS, the Highway and Transportation Commission is authorized to make certain payments to cities and towns for street purposes; and

WHEREAS, the Highway and Transportation Commission has selected certain streets within the corporate limits of the Town of Big Stone Gap for such payment; and

WHEREAS, due to annexation by the Town of Big Stone Gap effective January 1, 1978, and through mutual agreement between the Town and the Highway and Transportation Department, the Town will take over maintenance of these streets within the area annexed from Wise County, effective April 1, 1980; and

WHEREAS, the Town of Big Stone Gap has requested that these streets be included with those eligible for maintenance payment;

NOW, THEREFORE, BE IT RESOLVED, that pursuant to Section 33.1-41 of the Code of Virginia, as amended, quarterly payments on 0.38 mile of a primary route extension within the area annexed by the Town of Big Stone Gap be included in the Town's mileage for maintenance payments, effective April 1, 1980, for quarterly payment due after June 30, 1980. The additional mileage of the primary route extension eligible for payment is described as follows:

#### Primary Route Extension

U.S. Route 23 - From Old SCL Big Stone Gap 0.38 mile south to New SCL Big Stone Gap 0.38 mile

This primary extension mileage of 0.38 mile increases the total primary extension mileage in the Town of Big Stone Gap from 2.97 miles to 3.35 miles of approved streets subject to payment; and

BE IT FURTHER RESOLVED, that pursuant to Section 33.1-43 of the Code of Virginia, as amended, quarterly payments be made to the Town of Big Stone Gap on an additional 0.02 mile of "Other Streets" annexed by the Town, which meets standards required by this section of the Code, effective April 1, 1980, for quarterly payment due after June 30, 1980. The additional mileage of "Other Streets" eligible for payment is described as follows:

#### "Other Streets" Addition

State Route 803 - From U.S. Route 23 to 0.02 mile south of U.S. Route 23

0.02 mile

This "Other Streets" addition of 0.02 mile will increase the total "Other Streets" mileage in the Town of Big Stone Gap from 22.29 miles to 22.31 miles of approved streets subject to payment.

#### MOTION CARRIED

Moved by Mr. Hooper, seconded by Mr. Fralin. that the Commission confirm letter ballot action on the following resolution:

WHEREAS, under authority of Section 33.1-43 of the Code of Virginia of 1950, as amended, request is made by the City of Manassas for maintenance payments on additional streets meeting required standards;

NOW, THEREFORE, BE IT RESOLVED, that quarterly payments be made to the City of Manassas on additional streets, totaling 0.63 mile, and meeting required standards under the aforementioned section of the Code, effective April 1, 1980, for quarterly payment due after June 30, 1980. The additional streets and mileage eligible for payments are described as follows:

Confederate Trail	- From Ashton Avenue east to end	0.14 mile
Garnet Court	- From Confederate Trail south to end	0.08 mfle
Greengate Court	- From Confederate Trail north to end	0.18 mile
Placid Street	- From Confederate Trail to Greengate Court	0.14 ø1le
Olden Court	- From Placid Street north to end	0.09 mile

These "Other Streets" additions, totaling 0.63 mile, increase the total "Other Streets" mileage in the City of Manassas from 49.56 miles to 50.19 miles of approved streets subject to payment.

#### MOTION CARRIED

Moved by Mr. Hooper, seconded by Mr. Fralin, that the Commission confirm letter bellot action on the following resolution:

WHEREAS, under authority of Section 33.1-43 of the Code of Virginia of 1950, as amended, request is made by the City of Staunton for an addition and deletions of streets subject to maintenance payments. The deletions are due to the construction of the Inner Löop (Statler Boulevard), the reconstruction of the Greenville Avenue project and one additional deletion requested by the City of Staunton;

NOW, THEREFORE, BE IT RESOLVED, that quarterly payments be made to the City of Staunton on an additional street of 0.66 mile, which meets required standards under the aforementioned section of the Code, effective January 1, 1980, for quarterly payment due after March 30, 1980. The addition and deletions are described on attached tabulation sheets numbered 1 and 2, dated January 1, 1980.

The "Other Streets" addition of 0.66 mile and the "Other Streets" deletions of 0.28 mile, for a net addition of 0.38 mile, will increase the total "Other Streets" mileage in the City of Staunton from 78.25 miles to 78.63 miles of approved streets subject to payment.

WHEREAS, Route 23 in Wise County has been altered and reconstructed as shown on plans for Project 3897-07; and

WHEREAS, one section of the old road is no longer necessary as a public road, the new road serving the same citizens as the old;

NOW, THEREFORE, BE IT RESOLVED, that pursuant to Section 33.1-148 of the Code of Virginia of 1950, as amended, 0.06 mile of old Route 23, shown in blue and designated as Section 1 on the plat dated April 9, 1980, Project 3897-07, be abandoned as a part of the State Highway System.

WHEREAS, Section 33.1-221 of the Code of Virginia provides a fund for fiscal 1979-80 to ". . . be expended by the Commission for constructing, reconstructing, maintaining or improving access roads within counties, cities and towns to industrial sites on which manufacturing, processing or other establishments will be built under firm contract or are already constructed."; and

WHEREAS, the Board of Supervisors of Spotsylvania County has by resolution requested industrial access funds to serve the proposed expansion of General Products Company, Incorporated, located on Route 608 at the intersection of Route 636 near Hamiltons Crossing in Spotsylvania County, estimated to cost \$325,000; and

WHEREAS, it appears that this request falls within the intent of Section 33.1-221 and has complied with the provisions of the Highway Commission's policy on the use of industrial access funds:

NOW, THEREFORE, BE IT RESOLVED, that \$218,000 from the 1979-80 industrial access fund be allocated to assist in providing access to the proposed expanding facility of General Products Company, Incorporated, located on Route 608 at the intersection of Route 636 near Hamiltons Crossing in Spotsylvania County, Project 0608-088-195, C-501, contingent upon (1) the industry's entering into a firm contract for the expansion of its facility, (2) \$68,000 being provided from private sources, (3) the necessary right of way and adjustment of utilities being provided at no cost to the industrial access fund, and (4) all cost involved beyond the amount available from the industrial access fund and private sources being furnished from the regular Secondary construction allocation to Spotsylvania County.

that

WHEREAS, Section 33.1-223 of the Code of Virginia sets forth that the General Assembly of Virginia has found and declared that it is "... in the public interest that access roads and bikeways to public recreational areas and historical sites be provided by using highway funds ..."; provides highway funds for such purpose; and further provides that "The State Highway and Transportation Commission and the Commission of Dutdoor Recreation are hereby authorized to make regulations to carry out the provisions of this section."; and

WHEREAS, the Commission of Outdoor Recreation and the State Highway and Transportation Commission have adopted a joint policy to govern the use of recreational access funds pursuant to Section 33.1-223 of the Code of Yirginia; and

WHEREAS, the City Council of Staunton has by resolution requested the use of recreational access funds to provide adequate access to the Montgomery Hall Park in the City of Staunton, estimated to cost \$400,000; and

WHEREAS, this request has been considered by the Commission of Dutdoor Recreation and has been found to comply fully with the provisions of Section 33.1-223; and

WHEREAS, the Commission of Outdoor Recreation has recommended the construction of the aforementioned access;

NOW, THEREFORE, BE IT RESOLVED, that \$300,000 from the 1979-80 recreational access fund be allocated to assist in providing access to the Montgomery Hall Park in the City of Staunton, Projects 9999-132-240, C-501, and 9999-132-540, F5735, contingent upon (1) the right of way and adjustment of utilities being provided at no cost to the recreational access fund, (2) the city's entering into a suitable agreement regarding the construction and maintenance of this access road, and (3) \$100,000 being provided by the city, which is being matched dollar for dollar with recreational access funds.

that

WHEREAS, in accordance with Department policy, a firm proposal has been received from the consulting firm of American Engineers, Richmond, Virginia, for Stage I (Preliminary Plans and Estimates) and Stage II (Contract Structure Plans and Specifications). This work is identified as:

- B-605 Ramp "J" over Warwick Boulevard, C & O Railway, Ramps "F" and "P" and Route I-664; Ramp "M" over C & O Railway;
- B-606 Ramp "K" over Warwick Boulevard, C & O Reilway, Ramp "P," Reloc. 36th Street and Jefferson Avenue; Ramp "Q" over Reloc. 36th Street; Ramp "N" over 35th Street; Ramp "5" over Route I-664 and Ramps "F" and "P"; and

WHEREAS, we do not have the organization in the Bridge Division necessary to prepare these plans without seriously jeopardizing other scheduled work that is just as important as this project; and

WHEREAS, there is an outstanding Memorandum of Agreement covering this work with 56 percent complete on Stage I preliminary plans and estimates which represents an expenditure of \$58,554.00 with \$406,446.00 remaining in the contract; and

WHEREAS, the City of Newport News requested major changes to the 34th Street interchange affecting these bridges; and

WHEREAS, the Department and the Federal Highway Administration approved these changes; and

WHEREAS, the outstanding Memorandum of Agreement will be cancelled due to major changes in scope of work; and

WHEREAS, compensation for the agreed upon services was on the basis of a lump sum fee of \$452,030.00; and

WHEREAS, careful consideration has been made of the required services and just compensation for same as established and set forth in the Memorandum of Agreement;

NOW, THEREFORE, BE IT RESOLVED, that the Commission authorizes the execution of a Memorandum of Agreement with American Engineers for a lump sum fee of \$452,030.00.

WHEREAS, U.S. Route 460 Bypass, the Blackstone Bypass, in Nottoway County, State Project 7460-067-101, PE-101, RW-201, C-501, was designated as a limited access highway by the State Highway Commission on May 7, 1969; and

WHEREAS. Nottoway County has acquired property for a proposed county landfill near the intersection of the U.S. Route 460 Bypass and Route 614; and

WHEREAS, by letter dated March 28, 1980, the Board of Supervisors of Nottoway County requested that the limited access line and fence on the east side of Route 614 be shortened to permit construction of an entrance road to allow adequate access into the proposed landfill and provide a safe sight distance; and

WHEREAS, by shortening the limited access line and fence approximately 50 feet, this proposed road could connect with Route 614 directly opposite of present Route 625 (Old Route 659); and

WHEREAS, Nottoway County plans to construct the proposed road to Department of Highways and Transportation Road and Design Specifications for a rural addition to the Secondary System;

NOW, THEREFORE, BE IT RESOLVED, that the limited access line and fence on the east side of the Route 614 connection to the Route 460-8ypass, Project 7460-067-101, PE-101, RW-201, C-501, be terminated at Station 27+30 instead of Station 27+88.24, thereby providing for the location and construction of this proposed road in accordance with Nottoway County's recommendation.

WHEREAS, U.S. Route 19/460 Bypass, the Tazewell Bypass, in Tazewell County, State Project 7019-092-101, PE-101, RW-201, C-501, was designated as a limited access highway by the State Highway Commission on May 7, 1969; and

WKEREAS, a request was received from the Tazewell County Industrial Planner for a break in the limited access right of way for an industrial entrance to the property on the south side of Route 19/460, just east of Tazewell; and

WHEREAS, the proposed entrance would provide access into landlocked property being planned for industrial development; and

WHEREAS, the proposed fifty-foot width entrance would be located opposite approximate Station 656, State Project 7019-092-101, PE-101, RW-201, C-501, east of the acceleration lame of Ramp B, which is the on-ramp from the Town of Tazewell; and

WHEREAS, by letter dated January 26, 1976, a previous request to break the limited access right of way near the same location was denied by the Highway Commissioner; and

WHEREAS, the Department of Highways and Transportation duly considered a second request and again determined that access at such a location would not be in the best interest of basic safety engineering practices and would generate potential traffic hazards; and

WHEREAS, on January 17, 1980, this Commission denied the second request to break the limited access right of way for the proposed industrial entrance; and

WHEREAS, the Department of Highways and Transportation has duly considered this latest request and determined that access at the new location would not interfere with traffic movements in the interchange and that a crossover would not be located opposite of the proposed industrial entrance;

NOW, THEREFORE, BE IT RESOLVED, that a break in the limited access right of way be granted for the proposed industrial entrance beginning on the south side of Station 655+75 EBL and ending at Station 656+25 EBL, State Project 7019-092-101, PE-101, PM-201, C-501.

WHEREAS, the Urban Mass Transportation Administration of the U.S. Department of Transportation has approved capital grant project number VA-05-0011 submitted by the Greater Roanoke Transit Company; and

WHEREAS, the eligible state share of project number VA-05-0011 is \$220,000 based upon state participation in 90 percent of the local share of the grant; and

WHEREAS, the Department has authorized all of the \$200,000 allocated directly to the Roanoke area in the 1979-80 State Budget Bill and still requires an additional \$20,000 to provide the full state share of the approved grant; and

WHEREAS, the 1979-80 State Budget Bill contains a discretionary capital allocation for all areas in Virginia, and requires authorization by the Commission before these funds can be utilized:

NOW, THEREFORE, BE IT RESOLVED, that the State Highway and Transportation Commission hereby authorizes the Greater Roanoke Fransit Company to utilize up to \$20,000 in state funds from Chapter 850, Item 621.10 of the Acts of the General Assembly of 1978, as revised, to match federal capital grant VA-05-0011.

#### MOTION CARRIED

Mr. Roos reported that his Toll Road Committee had met to discuss the Department's recommendations on the feasibility of a two-cent toll for car pools and other high-occupancy vehicles carrying three or more persons at the downtown and midtown Elizabeth River Tunnels between Morfolk and Portsmouth. This would involve the selling of ticket books containing 50 tickets for \$1. Vehicles using this fare would be identified by a bumper or windshield sticker. It appears that this plan would have no appreciable effect on redemption of bonds for the facilities, and at the same time would serve to reduce congestion and gasoline usage. Motion was made by Mr. Roos, seconded by Mr. Hooper, that the plan be implemented, hopefully by September 1, 1980. Motion carried.

WHEREAS, in connection with Route 295, State Highway Project 0095-042-106, EV-203, the Commonwealth acquired cortain lands for use as a borrow pit from Roxbury Corporation by dead dated January 5, 1976, and recorded in Deed Book 1665, Page 75 in the Office of the Clerk of the Circuit Court of Henrico County; and

WHEREAS, in accordance with the terms of the option dated December 31, 1975, the Roxbury Corporation was granted the right to acquire all or portious of the property so acquired when the borrow material had been removed; and

WHEREAS, in order to comply with the terms of the option, the land has been offered to the Rozbury Corporation; and

WHEREAS, the County of Henrico and others may be interested in acquiring all or part of the property not acquired by the Roxbury Corporation; and

WHEREAS, it is proposed that the said land be conveyed to the County of Henrico or advertised for public sale; and

WHEREAS, the State Highway and Transportation Commissioner has certified in writing that the 119.06 acres, more or less, land acquired by deed dated January 5, 1976 and recorded in Deed Book 1665, Page 75 does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the State Highway System.

NOW, THEREFORE, in accordance with the provisions of Section 33.1-149 of the Code of Virginia (1950), as emended, the conveyance of the land, so certified, is approved and the State Highway and Transportation Commissioner is hereby authorized to execute a deed or deeds in the name of the Commonwealth conveying all or parts of the land to the Roxbury Corporation, the Board of Supervisors of Henrico County or to any person paying a consideration satisfactory to the State Right of Way Engineer.

Motion carried.

that

WHEREAS, in connection with Route 17, State Highway Project 0017-036-015, RW-I, the Commonwealth acquired a certain drainage essement from Lillian H. James and E. Stewart James by Deed of Essement dated January 20, 1960, as recorded in Deed Book 119, Fage 81 in the Office of the Clerk of the Circuit Court of Gloucester County; and

WHEREAS, the owners of the underlying fee have requested that the 10' x 280' drainage easement lying on the east side of Route 17 opposite approximate Station 232+85 be conveyed in order to allow for the more orderly development of their property; and

WHEREAS, in exchange, the landowners are agreeable to conveying an additional 10' x 480' easement required by the Department; and

WHEREAS, the State Highway and Transportation Commissioner has certified in writing that the 10' x 280' drainage easement lying on the east side of Route 17 opposite approximate Station 252+85 does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the State Highway System.

NOW, THEREFORE, in accordance with the provisions of Section 33.1-149 of the Code of Virginia (1950), as amended, the conveyance of the said drainage exsement, so certified, is approved and the State Highway and Transportation Commissioner is hereby authorized to execute a deed of quittleim accordingly in exchange for a deed to the required essement.

Motion carried.

that

WHEREAS, in connection with Route 23, State Highway Project 6023-097-113, RW-202, the Commonwealth acquired certain lands from Ora Dickenson and Alyonia Dickenson, et al, by deed dated August 19, 1974 as recorded in Deed Book 474, Page 64 in the Office of the Clerk of the Circuit Court of Wise County; and

WHEREAS, the Town of Big Stone Gap has requested that a portion of the right of way limits of Route 23 be conveyed to it for a sewer pumping station; and

WHERFAS, the State Highway and Transportation Commissioner has certified in writing that the land lying north of

the revised proposed right of way line from a point approximately 80 feet opposite approximate Station 225+30 (EBL centerline Route 23) to a point approximately 110 feet opposite approximate Station 10+85 (centerline Route 614) does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the State Highway System; and

NOW, THEREFORE, in accordance with the provisions of Section 33.1-149 of the Code of Virginia (1950), as amended, the conveyance of the land, so certified, is hereby approved and the State Highway and Transportation Commissioner is authorized to execute in the name of the Commonwealth a quitclaim deed to the Town of Pound, its successors or assigns, for a consideration acceptable to the State Right of Way Engineer, and subject to such restrictions as may be deemed requisite.

#### Motion carried.

The chairman briefed the Commission on the present status of federal funds. He had learned that the House-Senate conference committee had approved a supplemental amount of \$1.1 billion, which appears to be sufficient to meet the payments to the states. This will have to go through three Senate resolutions, and has already passed the first. The action could be delayed by the total effect on the budget caused by the elimination of the President's proposed ten-cent tax on a gallon of gasoline, but Mr. King indicated he felt relieved by the availability of the supplemental amount. After the supplement is approved, the Department will probably hear from the Federal Highway Administration regarding the Department's request for funds over the \$58 million previously allocated. He stated he felt certain that Virginia would receive at least \$40-\$60 million additional, which would bring the total program to approximately \$220 million.

Mr. King introduced Mr. John B. Harris, Director, Highway Supportive Services Component, Virginia Office of Minority Business Enterprise, who spoke to the Commission on the bonding requirements for subcontractors. He stated that often the Department's requirements are a deterrent to smaller contractors, many of which are minority firms, in that bonding firms are reluctant to bond companies which have not proven themselves by experience in the construction field. Further, most small contractors could take on subcontracts, which are already covered by the performance bond of the prime contractor. Mr. F. L. Burroughs, Construction Engineer, stated his feeling, based on study by the Department, that bonding of subcontractors could be eliminated for subcontracts up to \$300,000 without any detrimental effects. This would provide a means for prequalified minority contractors to perform as Department-approved subcontractors on projects

and thereby establish the experience record in which the bonding companies have such a genuine interest. The point was made that the prime contractor could require bonding of the subcontractor. Action on this matter will be taken at the next Commission meeting, after the benefit of input from the Virginia Road and Transportation Builders Association and the Joint Cooperative Committee.

Mr. H. R. Perkinson, Jr., Director of Program
Management, presented proposed revised allocations of Interstate,
Primary, and Urban Construction Funds for Fiscal Year 1979-80, and
proposed tentative allocations of Interstate, Primary, and Urban
Construction Funds for Fiscal Year 1980-81, as well as proposed
transfer of Primary Funds in the Suffolk and Culpeper Districts;
and on motion of Mr. Hooper, seconded by Mr. Fralin, the revised
allocations for 1979-80 and the tentative allocations for 1980-81,
were approved. The transfer of certain Primary Funds in the Suffolk
District was approved on motion of Mr. Roos, seconded by Mr. Hooper.
On motion of Mr. Wrench, seconded by Mr. Fralin, the transfer of
certain Primary Funds in the Culpeper District was approved. All
are listed on the attached sheets.

# TRANSFER OF PRIMARY FUNDS SUFFOLK DISTRICT

WHEREAS, after a careful review of the Primary System construction priorities within the Suffolk Construction District, it has been determined that additional funds are critically needed to pursue work on the Bowers Hill Interchange currently under construction, and

WHEREAS, to continue the critically meeded construction of the Franklin Bypass, and

WHEREAS, it has been determined that funds are critically needed to reconstruct the structure approaches to the Nansemond River Bridge drawspan on Route 125 in the City of Suffolk,

# TRANSFER OF PRIMARY FUNDS CULPEPER DISTRICT

MHENEAS, after a careful review of the Primary System construction priorities within the Culpeper Construction District, it has been determined that additional funds are critically needed for the early construction of the proposed interchange on Route 50 with Gallows Road, and

WHEREAS, to continue the critically needed additional construction on Route 123 in Fairfax County, and

WHENEAS, it has been determined that the improvement needed to the Route 6 structure over the Rivanna River in Fluvanna County will not be as extensive as originally anticipated, and

WHERMAS, additional revenues are required to finance the construction now being completed on Route 211 west of Warrenton,

HE IT FURTHER RESOLVED that \$180,000 previously allocated by the Highway and Transportation Countsission to Route 6 in Fluvanna County be transferred to Route 211 from the Town of Warrenton West.


