

Minutes of the Meeting of the State Highway
Commission of Virginia, Held in
Richmond, June 1, 1938.

On the morning of June 1, 1938, the State Highway Commission, consisting of Messrs. H. G. Shirley, Wade H. Massie, Secretary, Wm. H. East, S. W. Rawls and J. F. Wysor, met in their office, State Office Building, Richmond, Virginia.

The meeting was called to order by the Chairman.

Moved by Mr. Rawls, seconded by Mr. Wysor, that the minutes of the meeting of May 3rd be approved. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Massie, that the Commission award contract to the low bidder, Harwood Bros., Inc., Richmond, Va., on approximately 66,000 gallons of lubricating oil for the period of June 15, 1938 to December 15, 1938, at their bid of \$0.2165 per gallon. Motion carried.

Moved by Mr. Wysor, seconded by Mr. Rawls, that the mileage in the Guttenberg Sanatorium grounds be corrected to read 0.9494 mile instead of 0.7677 miles. Motion carried.

Moved by Mr. Wysor, seconded by Mr. Rawls, that the sick leave of H. G. Moyers, Patrolman, be extended 10 days with pay from April 8th to 17th inclusive. Motion carried.

Moved by Mr. Wysor, seconded by Mr. East, that the bill from the Blackwall Engineering and Construction Company on account of claim made by them on Project WPSS 794 DIBL, Route 6, 3.26 Mi. E. Barrett's Ferry-6.66 Mi. E. Barrett's Ferry, be allowed in the amount of \$952.31 as per recommendation of the Chief Engineer. Motion carried.

Moved by Mr. Wysor, seconded by Mr. Rawls, that the request for an extension of time on Project FA 1013 E2, Route 49, Bridge over Rapidan River near Unionville, by G. T. Franklin and Philip L. Baird, of Roanoke, be granted for 29 days and return \$250.00 liquidated damages, as recommended by the Chief Engineer. Motion carried.
