MINUTES OF MEETING OF STATE HIGHWAY COMMISSION

RICHMOND. VIRGINIA

June 8, 1972

Following public hearings on final allocation of Interstate, Rural Primary and Urban construction funds for the fiscal year 1972-73, in Roanoke on June 7, for the Bristol, Salem, Lynchburg and Staunton Districts, and in Richmond on June 8, for the Richmond, Fredericksburg, Culpeper and Suffolk Districts, the State Highway Commission met in the Commission Room at the Central Highway Office in Richmond on June 8, 1972, at 11 a.m., for its regular monthly meeting. The Chairman, Mr. Douglas B. Fugate, presided.

WHEREAS, proper notice was given in advance and all those present were given a full opportunity to express their opinions and recommendations for or against the proposed project as presented, and their statements being duly recorded, and

MHEREAS, the economic, social and environmental effects of the proposed project have been examined and given proper consideration, and this evidence, along with all other, has been carefully reviewed,

NOW, THEREFORE, BE IT RESOLVED, that the location and major design features of this project be approved in accordance with the plan as proposed and presented at the said location and design public hearing by the Department's engineers, amended to extend the project around the curve on the north end.

WHEREAS, Route 24 in Bedford County has been altered and reconstructed as shown on plans for Project 0024-009-102, C-501; and

WHEREAS, three sections of the old road are no longer necessary as a public road, the new road serving the same citizens as the old, and two sections of the old road are no longer necessary for purposes of the State Highway System, and two sections of the old road are to be transferred to the Secondary System;

NOW, THEREFORE, BE IT RESOLVED, that pursuant to Section 33.1-148 of the Code of Virginia of 1950, as amended, 0.20 mile of the old location of Route 24, shown in blue and designated as Sections 2, 4 and 7 on the plat dated March 16, 1972, Project 0024-009-102, C-501, be abandoned as a part of the State Highway System:

BE IT FURTHER RESOLVED, that pursuant to Section 33.1-144 of the Code of Virginia of 1950, as amended, 0.36 mile of old location of Route 24, shown in yellow and designated as Sections 1 and 3 on the plat and project referred to hereinabove, be discontinued as a part of the State Highway System;

BE IT ALSO FURTHER RESOLVED, that pursuant to Section 33.1-35 of the Code of Virginia of 1950, as amended, 2.50 miles of the old location of Route 24, shown in red and designated as Sections 5 and 6 on the plat and project referred to hereinabove, be transferred from the Primary System to the Secondary System of Highways.

MHEREAS, Section 33.1-221 of the Code of Virginia provides a fund for fiscal 1972-73 of \$2,500,000 to " . . . be expended by the Commission for constructing, reconstructing, maintaining or improving access roads within counties, cities and towns to industrial sites on which manufacturing, processing or other establishments will be built under firm contract or are already constructed."; and

WHEREAS, the Board of Supervisors of Fairfax County has by resolution requested the use of industrial access funds to assist in providing access to the new facility of Xerox Corporation, to be located in the West Springfield Research and Industrial Plaza, an extension of Booth Orive (Route 835), estimated to cost \$20,000; and

WHEREAS, it appears that this request falls within the intent of Section 33.1-221 and has complied with the provisions of the Highway Commission's policy on the use of industrial access funds.

NOW, THEREFORE, BE IT RESOLVED, that \$20,000 from the industrial access fund for 1972-73 be allocated to assist in providing access to the new facility of Xerox Corporation, to be located in the West Springfield Research and Industrial Plaza in Fairfax County, Project 0035-029-199, C-502, contingent upon (1) the necessary right of way and adjustment of utilities being provided at no cost to the Commonwealth; (2) the Industrial Plaza developer's providing for the necessary grading, drainage facilities, curb and gutter, and all other construction exclusive of base and surface; and (3) the industry's entering into a firm contract for the occupancy of its facility.

WHEREAS, Section 33.1-288 of the Code of Virginia as amended by the 1972 General Assembly provides that the Commission may, in its discretion, use any part of funds available for the maintenance of State highways in any construction district in which any project authorized for toll revenue bond financing by the State Highway Commission, as described in Section 33.1-258, or by the Richmond-Petersburg Turnpike Authority, as described by Section 33.1-319, or by the Elizabeth River Tunnel Commission, as described by Chapter 130 of the 1942 Acts of Assembly, as amended, and

WHEREAS, the Highway Commission provides limited aid to facilities financed under the Revenue Bond Act of 1954, and

WHEREAS, the Commission desires to provide similar aid to the Richmond-Petersburg Turnpike Authority and the Elizabeth River Tunnel Commission.

NOW, THEREFORE, BE IT RESOLVED, that the Highway Commission will provide aid to the Elizabeth River Tunnel Commission in approximately the same percentage as provided for the facilities included in the Revenue Bond Act of 1954, which is approximately 35% of the total ordinary maintenance budget, and

BE IT FURTHER RESOLVED, that for the Richmond-Petersburg Turnpike Authority, which is generally classified as an urban facility, aid be provided in the amount of \$2,500 per lane-mile as provided for city streets.

MEMORANDUM OF AGREEMENT

The State Highway Commission of Virginia (hereinafter referred to as the "Commission"), the Governing Bodies of the Counties of Arlington and Fairfax, and the Cities of Alexandria, Fairfax and Falls Church (hereinafter referred to as the "Local Governing Bodies"), and the Northern Virginia Transportation Commission (hereinafter referred to as "NVTC") agree as follows:

WHEREAS, Section 33.1-46.1, as amended, by an act of the General Assembly of 1972 (H-665), provides that the Commission may contract with the Local Governing Bodies comprising a transportation district for the accomplishment of a project to which funds have been allocated for highway aid to mass transit facilities and may make such funds available to the contracting governing bodies in annual increments which may be used for other transit purposes until such funds are needed for the project for which allocated; and

WHEREAS, the Local Governing Bodies who are parties to this contract comprise the NVTC, which was created and exists pursuant to the Transportation District Act of 1964, Section 15.1-1342, et seq; and

WHEREAS, the Commission has in its revised ten-year program ("Virginia Roads and Streets 1972-82") expressed its intent to allocate over the ten-year period, \$35 million of this amount for acquisition of right of way for and construction of the parking lots for the WMATA stations of the metro line in Virginia, however, within boundaries of corporate municipalities of over 3500 population Section 33.1-44 will govern.

NOW, THEREFORE, the Local Governing Bodies do contract to accomplish through WMATA the acquisition of the right of way and construction of parking lots in accordance with WMATA plans and specifications with amendment as such amendments may be hereafter adopted insofar as the funds allocated by the Highway Commission will permit.

It is further agreed that the Local Governing Bodies authorize the Commission to pay such annual allocations to NYTC for use for transit purposes as permitted by Section 33.1-46.1, it being further agreed that when such funds are needed for accomplishment of the parking lot projects the Local Governing Bodies will receive reimbursement from NYTC or will provide equivalent funds from other sources. Mhenever advance funds are temporarily used by NYTC for other transit purposes, the Highway Department is to be informed as to such use.

In lieu of bond as provided by Section 33.1-46.1, the Local Governing Bodies agree that the Commission may seek injunctive relief through the appropriate courts to enforce provisions of this contract should the Commission in its judgment determine this action to be necessary and timely. It is further agreed that this will not constitute the sole relief available to the Commission.

Mr. Crowe commented that he had noticed, particularly in the Roanoke hearing, that some people from the last districts to be heard had waited several hours to speak and suggested that the order in which the districts are called might be reversed in alternate years. The chairman stated the present order had been established with the thought that those closest to the hearing location might be heard first, thus allowing those who had a longer distance to travel to be heard later in the morning. However, he said this suggestion would be given consideration.

The meeting was adjourned at 11:30 a.m.

PUBLIC HEARING INTERSTATE, PRIMARY AND URBAN TENTATIVE ALLOCATIONS hotel roandke – Shenandoah room JUNE 7, 1972

The public hearing for the Interstate, Primary and Urban Tentative Allocations was held for the Salem, Bristol, Lynchburg and Staunton Districts on June 7, 1972, at 9 a.m. in the Shanandoah Room of Hotel Roanoke.

Commissioner Douglas B. Fugate called the hearing to order and introduced the members of the Highway Commission. He stated the allocations announced in April are the first step in implementing the 10-Year Plan of Highway Improvement adopted by the 1972 General Assembly. Because the General Assembly increased the State gasoline tax by 2¢, thus providing for the next year an estimated \$52 million in additional funds and over the next 10 years an estimated average of \$65 million, we are able to carry out a great deal more work than before these increases were adopted.

SALEM DISTRICT

Bedford County

W. H. Walton, Jr., president of Bedford County Chamber of Commerce and J. Ray Turner, member of Bedford County Board of Supervisors, expressed thanks for allocation on Route 43. H. M. Nance, Managing Director of Bedford County Chamber of Commerce, asked for grade separation crossing of Norfolk and Western track at Moneta on Route 122; advised that Route 501 between Boomsboro and Smowden bridge has dangerous curves that need straightening; asked that we continue 4-laning of Route 24 from Stewartsville east. John Penn Oliver, member of the Bedford County Board of Supervisors, and Jack Robinson, representing Owens-Illinois (pulp and paper mill at Big Island) spoke concerning bridge on Route 501 in Bedford over Hunting Creak. Mr. Robinson said it is difficult to live within the restricted 15 ton load limit on the bridge and one-way traffic. Recommended that a study be made to expedite this project.

Botetourt County

Mary D. Pauley, member of Botetourt County Board of Supervisors, Mrs. Fred Williamson, Executive Secretary of Botatourt County Chamber of Commerce and B. H. Griffith, Supervisor of Transportation for Botetourt County Schools, expressed appreciation for the allocation for improvement on Route 43 in Botetourt County.

Carroll County, Galax

Jim Williams, representing Great Lakes to Florida Highway Association, made a desperate appeal for work to get under way as soon as possible on I-77 in Carroll County in order to alleviate deaths on Route 52. Enclosed is An Open Letter dated May 4, 1972, to President Richard Mixon and others (submitted by Mr. Williams). Willard Stoneman, director of Great Lakes to Florida Highway Association, introduced the following who made a plea for something to be done on Route 52 south of Hillsville (Fancy Gap Mountain) where 8 people have lost their lives this year on a 3-mile stretch: Joe N. Berry, Chairman of Carroll County Highway Safety Commission; Joe Dixon, member of Carroll County Board of Supervisors; Walter Johnson, member of Carroll County Board of Supervisors; Walter Johnson, member of Carroll County; Ernest Worrall, Superintendent of Carroll County Schools; Warner Tobler, representing Hillsville Business and Professional Mens' Club; Glen Smith, president of PTA at St. Paul Intermediate School; Ralph Quesemberry, citizen who had lost three members of his family on the mountain; Robert Snow, Executive Secretary of Carroll County Board of Supervisors; Delegate Archie Campbell. Mayor Raleigh Cooley of Hillsville asked that a project be set up to furnish curb and sidewalk through the center of town where they already have the right of way. Jack Guynn, Nayor of Galax, presented a resolution (enclosed) and stated when I-77 does go through, they will need a 4-lane highway from Hillsville to Galax. Arthur Gurley, publisher of Galax Gazette, submitted statement (enclosed) concerning I-77 and Route 52 at Fancy Gap Mountain.

Craig County

R. M. Shannon of the Fifth Planning District Commission urged priorities be continued for widening Route 220 north from Cloverdale to Clifton Forge and for action on I-64 through Alleghany County.

Floyd County

William L. Whitlock, chairman of the Board of Supervisors of Floyd County, stated their main interest concerned Route 8 from I-81 south to Stuart in conjunction with Route 58; requested that future allocations be considered in the amount appropriate to bring this road up to date on a modern grade with a 24' surface. Calvin Rorrer, Floyd Ruritan Club, requested reconstruction of Route 8 in Floyd County.

Franklin County

Virgil Goode and Arthur S. Owens, Director of College Support at Ferrum College, spoke concerning Route 40 from Rocky Mount to Ferrum to Endicott to Woolwine; wanted the <u>re</u> taken off the word "reconstruction" for the \$200,000 allocation towards work between Ferrum and Rocky Mount.

Henry County

Senator W. F. Stone echoed Messrs. Goode and Owens' previous statements. He's also interested in reconstruction of Route 58 from Stuart to the top of the mountain.

Patrick County

Delegate Garry DeBruhl spoke in the interest of Routes 58, 103, 346 and 8. (Enclosed is statement made by him).

Roanoke County, City of Salem

Lee Eddy, former Chairman of Roanoke County Board of Supervisors, and member of Fifth Planning District Commission, supported and reinforced what Mr. Shannon said about Route 220. Spoke of allocation on Route 419 linking Route 220 with the Lynchburg Turnpike in Salem. Wanted to know how much physical improvement \$1,950,000 represented. (He will hear from Richmond on this).

BRISTOL DISTRICT

Bland County

Moodrow Bird, speaking as a private citizen, and Jim Williams complimented the work that is being done and will be done on I-77 in Bland County. Dr. Carl E. Stark, Mayor of Wytheville, asked that we keep pushing and get the job done where it is needed.

Buchanan County

Gene Bain from Grundy said about 22 more miles of 4-laning is needed to get into Kentucky. Edward Mattney, Executive Secretary for the Buchanan County Board of Supervisors, said (1) need 4-laning continued on Route 460 to Kentucky line, (2) Route 83 from Dickenson County line needs some kind of construction begun immediately, and (3) asked for additional guardrail on Route 460 (below town of Grundy) to retain safety record; Willard Owens member of the Buchanan County Board of Supervisors, said a road is needed to Breaks Interstate Park.

Dickenson County

Remire Sutherland, from McClure, representing the Cumberland Plateau Planning District Commission, requested that U. S. 460 be completed to the Kentucky border as soon as possible when funds are available; called the Commission's attention to roads that need improvement - Route 63 from St. Paul to Haysi; Route 80 from Haysi to Russell County; Route 72 from George's Fork to Coeburn where it intersects with Route 58.

Grayson County

J. K. M. Fields introduced the following: Don Young, Executive Secretary of Grayson County Board of Supervisors, who asked for improvement to Route 21 north of Independence and to Route 58 west of Independence (resolution enclosed). James A. Carico, chairman of Board of Supervisors of

Grayson County, requested funds for improvement to Routes 16, 58 and 21. Stated that Route 94 will be leading into Route 58 and requested that a study be made of entering into the new 58 junction between Independence and Galax. Fred Adams, Jr., member of the Grayson County Board of Supervisors, urged the Department to consider immediate construction of Route 58 between Independence and Galax. Glen Halsey, president of Grayson County Board of Supervisors, stated that Route 58 from Mouth of Wilson to Independence needs improvement. Jessie Anders, member of the Board of Supervisors of Grayson County, asked for immediate attention to Routes 58 and 21 in the county.

Delegate Archie Campbell spoke for Bland, Grayson, Galax and Wythe. He trusts the Commission will see that an additional contract is let for I-77 from Bastian to Bland so when East River Tunnel is opened that the road will be complete all the way. His primary interest for Galax-Mythe was on I-77 from Ft. Chiswell to Route 58, the road from Hillsville to Galax. Called attention to the southern end of Elk Creek Valley where Il people have been killed in space of three curves, little over 1/4 mile distance. He said the situation is intolerable on Route 58 and Route 21 in Grayson.

Smyth County
Mr. Daniels from Chilhowie said last year it was requested that the section of Route 107 in the town of Chilhowie from Route 11 to the intersection with Route 81 be built; this was taken into the primary system; nothing has been done on it; the road is rough in places. Spoke of resolution to come through from the Board of Supervisors concerning Route 762 being put into the Primary System.

Tazewell County
Ray Dodson asked that future consideration be given to Route 61 from
Tazewell to Rocky Gap. E. P. Greever, Treasurer of Tazewell County,
expressed appreciation to Commission for work being done on Route 460 and
Route 19; endorsed what had been said about completion of I-77.

Wise County, Big Stone Gap, Norton
Roland Rose, from Big Stone Gap, was grateful for the roads being built;
however, concerned about "bottleneck" of Route 23 from Norton to connect
with road coming north. James Manicure, Chairman of Roads Committee of
Wise County Chamber of Commerce, urged that we continue and if possible
accelerate the construction program of Route 23, Alternate 58 and the
Appalachia access road. Evan Norton, Executive Secretary of Wise County,
underscored the remarks of those representing the county. Milas Franks,
City Manager of Norton, presented resolution requesting top priority for
completion of Route 23 (resolution enclosed). Gene Brooks, Town Manager
of Appalachia, pointed out some facts to Justify tentative and future
allocations.

STAUNTON DISTRICT

Alleghany County, Clifton Forge

Ben C. Moomaw, Jr. presented persons from Alleghany County, Rockbridge County, Clifton Forge, Covington and Lexington and he spoke of the need of I-64 between Clifton Forge and Lexington, requesting that the next project on this route be the Lexington bypass. Col. M. A. Barnes, City Manager of Clifton Forge, asked for I-64 between Clifton Forge and Lexington, and that Route 220 be constructed south into Botetourt County. He presented resolutions from Chamber of Commerce of Clifton Forge, City Council of Clifton Forge, and Retail Marchants Association (these enclosed). Charles Vass, member of the Board of Supervisors of Alleghany County, had the same requests as Col. Barnes. Also, he said there's a problem with flooding on Route 311 3/4 mile east of Sweet Chalybeate.

Augusta County, Steunton

Richard A. Farrier, Mayor of Staunton, and authorized representative of the Virginia Municipal League, reminded the Commission that the Virginia Municipal League recently gave full endorsement to the Department's 10-year objectives as presented to the Virginia Advisory Legislative Council and they were actively engaged in supporting important legislation in this connection during the recent session of the Legislature (enclosed is his statement). Marshall Craig, Chairman of the Transportation Committee of the Staunton-Augusta County Chamber of Commerce, read a resolution on behalf of Transportation Committee and Board of Directors. This is anclosed along with similar resolutions from City of Staunton and statement from Augusta County Board of Supervisors endorsing same.

Rockbridge County, Buene Vista

Russell Roby, connected with Southern Seminary Junior College, represented Buena Vista. He asked that the Blue Ridge Parkway be marked from Routes 81 and 60 and asked for signs designating Southern Seminary Junior College; also that work on the Maury River bridge be expedited.

Rockingham County, Harrisonburg

Bob Sterrett, Executive Vice President of Harrisonburg-Rockingham Chamber of Commerce, presented annual Five Point Highway Program (transcriber does not have copy). John Oriver, Assistant City Manager of Harrisonburg, read statement signed by Mayor Roy Erickson (enclosed). Harold Workman, Councilman and Vice Mayor of Town of Elkton, asked for help with congestion on two blocks of Route 340 in the town.

LYNCHBURG DISTRICT

Pittsylvania County

Larry Couch, Town Manager of Chatham, asked for curb and gutter at two locations in the town.

ALLOCATION OF INTERSTATE, PRIMARY AND URBAN CONSTRUCTION FUNDS 1972-1973

Richmond, Suffolk, Fredericksburg, Culpeper Districts

Richmond, Virginia

June 8, 1972

A public hearing on allocation of Interstate, Primary and Urban construction funds for the year 1972-73 for the Richmond, Suffolk, Fredericksburg, and Culpeper Districts was held in the Auditorium of the Highway Office Building in Richmond, Virginia at 9 A. M. on June 8, 1972. Mr. Douglas B. Fugate, Chairman of the State Highway Commission presided.

RICHMOND DISTRICT

Mr. Eugene B. Sydnor, Director of the James River-Kanawaha Parks, Inc., speaking in regard to the proposed I-195 extension, asked that the Commission give consideration to the desirability of an environmental impact study before proceeding with this construction. He left with the Chairman a list of questions in connection with the proposed work.

Mr. Sydnor complimented the Commission on its action in appropriating \$155,000 for circumferential rapid transit system from Parham Road down I-64 and I-95 into downtown Richmond.

Mr. Garland Roberts, representing the City of Richmond, left a prepared statement.

Letter from Mayor Thomas J. Bliley, Jr., was also presented.

Mr. A. T. Dotson, County Engineer, Henriso County, urged that work on Staples Mill Road be accelerated.

Mr. Robert Klepper, County Engineer, Prince George County, presented a resolution requesting widening of all bridges on Route 10 between the Surry County Line and the Hopewell limits.

Senator Elmon Gray stated he and Delegate W. Roy Smith were opposed to the proposed widening of the Richmond-Petersburg Turnpike.

FREDERICKSBURG DISTRICT

Mr. Eugene Campbell, Chairman of the Board of Supervisors of King William County, urged continuation of reconstruction of Route 30 between Central Garage and West Point.

Mr. Edward A. Smith, of the Highway Safety Committee, King William Ruritan Club, asked continued improvement of Route 30 from Route 360 to West Point.

CULPEPER DISTRICT

Mr.Jack Crawford read a statement prepared by Mr. Joseph Alexander, Chairman, Northern Virginia Transportation Commission.

Mr. D. French Slaughter, Member of the House of Delegates, referred to resolutions previously passed by the Chamber of Commerce urging completion of four-laning of Route 29, a nine-mile gap.

Mr. H. L. Wilson, Executive Vice President, Culpeper Chamber of Commerce, Mr. Jas. W. Greene, Jr., of the Chamber of Commerce, the Town : Manager of Orange, and Mr. T. W. Ross, Town of Gordonsville, accompanied Mr. Slaughter.

Mr. Slaughter also said he hoped the four-laning of Route 15 between Gordonsville and Orange might be completed by the end of 1973; that he thought more money would be needed to finance resurfacing and reconstruction of Route 522 in the Town of Orange; called attention to resolution which had been submitted requesting allocations for Route 20 between Barboursville and Somerset; urged that Route 231 be considered for resurfacing, realignment and reconstruction; and urged four-laning of Route 211 in Rappahannock County.

Mrs. Eleanor Deway, of McLean Citisens Association, presented a five-point program:

- Route 193 to be retained as a two-lane road, with detailed recommendations to be submitted at a subsequent time.
- Improvement of Int. 7 and 123 and Int. 7 and 495'
 bottlenecks.
- 3. No additional lanes: Old Dominion Drive
 Dolley Madison Boulevard
 Route 7.
- 4. Existing two lames of Old Dominion Drive outside of segment between Pinmit Run and Dolley Madison Boulevard to be maintained in good condition with culverts to handle storm drainage.
- 5. Provisions be made for pedestrians and cyclists.

'Mr. Ton Faulkner, of Fairfax County, presented a letter from Dr. George J.Kelley, Jr., County Executive, Fairfax County.

Mr. C. A. Stoneburner, Transportation Director, Arlington County, requested improvement of Route 50 in Arlington and Fairfax Counties.

SUFFOLK DISTRICT

Senator Elmon Gray requested bridge at Jamestown be moved ahead on schedule.

Mr. C. C. Miller, of Isle of Wight County, urged allocation for new bridge over the James River from Isle of Wight to Newport News.

Honorable Ray Ashworth, Member of House of Delegates, and Mr. Robert McCord, City Manager of Emporia, urged construction of Route 58 Bypass at Emporia.

The hearing was adjourned at 10:40.4. M.
