MINUTES OF THE MEETING OF THE STATE HIGHWAY COMMISSION OF VIRGINIA, HELD RICHMOND, VIRGINIA,
JULY 16th, 1926.

The State Highway Commission of Virginia, consisting of Messrs. H. G. Shirley, Chairman, Wade H. Massie, Secretary, I. Walko Truxton, and H. G. Gilmer, met at their office, State Office Building, Richmond, Virginia, on the morning of July 16, 1926, and the meeting was called to order by the Chairman.

The minutes of the meeting of the Commission held June 2, 1926, were read, and it was moved by Mr. Truxton, seconded by Mr. Massie, that they be approved. Motion carried.

Moved by Mr. Massie, seconded by Mr. Truxton, that the Commission confirm the award of the contract for the construction of Route 13, Project 419A, 1.44 Miles West of Warren to the Rappahannock River, to the low bidder, V. E. Cornett and Company, at their bid of \$62,143.02, and that 10% additional be set aside to cover the cost of contingencies and engineering and \$10,517.76 for guard rail, making a total of approximately \$79,000.00 chargeable to this Project, with the understanding that this work is to be pushed to completion within the time specified in the contract. Motion carried.

Moved by Mr. Massie, seconded by Mr. Truxton, that the Commission confirm the award of contract for the construction of Project 434A, Route 12, Streets of Emporia, to the low bidder, Ford and Harvey, Lynchburg, Virginia, at their bid of \$71,549.93 with 10% additional set aside to cover the cost of contingencies and engineering, and \$2500.00 for detours, making a total of approximately \$88,000.00 chargeable to this Project. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Massie, that the Commission confirm the award of contract for the construction of Project 3440, Route 11, Coeburn-Bruce Siding, to the low bidder, W. H. Meadows, Coeburn, Virginia, at his bid of \$26,943.78 and that 10% additional be set aside to cover the cost of contingencies and engineering and \$200.00 for detours, making a total of approximately \$30,000.00 chargeable to this Project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Gilmer, that the Commission confirm the award of contract for the construction of Project 2734, Route 10, Streets of Crews, to the low bidder, Southern Construction Corp., Petersburg, Virginia, at their bid of \$45,865.68, with 10% additional set aside to cover the cost of contingencies and engineering, and \$200.00 for detours, making a approximately \$54,000.00 chargeable to this Project. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Massie, that the Commission confirm the award of contract for the construction of Project 217B, Route 114, Intersection Route 114A-Clinwood, to the low bidder, W. H. Meadows, Coeburn, Virginia, at his unit prices for grading and draining the entire project for a distance of 1.912 miles, and surfacing between Stations 54 and 95, setting aside 10% additional to cover the cost of contingencies and engineering, making a total of approximately \$41,000.00 chargeable to this project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Shirley, that the Commission confirm the award of contract for the construction of Project 204, Route 211, Manassas - Millford Mills, to the low bidder, Rhodes and Walters, Culpeper, Virginia, at their bid of \$88,620.25, setting aside 10% additional to cover the cost of contingencies and engineering, and \$1,809.50 for detours, making a total of approximately \$100,000.00 chargeable against the general allocation of \$50,000.00 for this work. Motion carried.

Moved by Mr. Massie, seconded by Mr. Truxton, that the Commission confirm the award of the contract for the construction of Project 420B, Route 31, Bridge over Stony Creek, to the low bidder, Hankins and Collins, Richmond, Virginia, at their bid of \$16,974.21, setting aside 10% additional to cover the cost of contingencies and engineering, making a total of approximately \$19,000.00 chargeable to this Project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Shirley, that all bids be rejected on Project 367, Route 10, Bridge over Cypress Creek at Smithfield, Va., as in the opinion of the Commission they are too high, and that the same be readvertised asking for alternate bids on swing and bascule spans. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Massie, that contract for the construction of Projects 447A and 447B, Route 30, Streets of Belvedere, be awarded to the low bidder, J. G. Daysport, Lancaster, Virginia, at his unit prices, cutting off 1000 ft. on one end and 500 ft. on the other, as per recommendation of Chief Engineer Mallon, thereby reducing the cost approximately \$10,000.00, and making a total of approximately \$50,000.00 chargeable to this Project, provided the contractor can give assurance of his ability to handle this work. Motion carried.

Moved by Mr. Massie, seconded by Mr. Shirley, that the contract for the construction of Project 443, Route 13, in the Town of Cumberland, be awarded to the low bidder, C. R. Sanderson, Cartersville, Virginia, at his bid of \$39,144.50, and that 10% additional be set aside to cover the cost of contingencies and engineering, making a total of approximately \$44,000.00 chargeable to this project, with the understanding, however, that this contract is not to be signed or work started, until the rights of way have been cleared up. Motion carried.

Moved by Mr. Truxton, seconded by Mr. Shirley, that the contract for the construction of Project 28300, Route 34, South of the Maryland State Line to .86 Miles North of Oak Hall, be awarded to the low bidder, Remmey - Burroughs Company, Salisbury, Maryland, at their bid of \$33,841.72, and that 10% additional be set aside to cover the cost of contingencies and engineering, and \$500.00 for detours, making a total of approximately \$36,000.00 chargeable to this Project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Gilmer, that the contract for the construction of Project 1322, Route 10, Bridge over South Fork Roanoke River, be awarded to the low bidder, Roanoke Iron and Bridge Works, Roanoke, Virginia, at their bid of \$23,843.97, and that 10% additional be set aside to cover the cost of contingencies and engineering, making a total of approximately \$27,000.00 chargeable to this Project. Motion carried.

Moved by Mr. Truxton, seconded by Mr. Massie, that the contract for the construction of Project 4400, Route 31, Pohick Church - Occoquan, inclusive of Bridge over Pohick Creek near Lorton, be awarded to the bidder Baker-Royer Company, Richmond, Virginia, at their bid of \$145,603.09 being next to the low bid, and that 10% additional be set aside to cover the cost of contingencies and engineering and \$4299.00 for detours, making a total of approximately \$165,000.00 chargeable to this Project, and that the low bid of the Jenkins Construction Company, be rejected as they are behind time on their Project #14, and the Commission is of the opinion they could not complete this work in the time specified. Motion carried.

Moved by Mr. Massie, seconded by Mr. Truxton, that the allocation of \$25,000.00 made to the bridges over the Potomac River on Route 32 at Point of Rocks and the \$10,000.00 for making improvements on Route 32 at

Lucketts, be transferred to Route 211, Manassas - Millford Mills, and also that the \$55,000.00 transferred from the Maintenance Fund to Construction to various Projects in the Culpeper District, be transferred to Routes 32 and 21. Motion carried.

Moved by Mr. Massie, seconded by Mr. Shirley, that Permit #901, issued May 7, 1926, to the Oak Ridge Telephone Company, Oak Ridge, Virginia, to erect telephone poles along State Highway No. 18 in Nelson County, be cancelled as this work was never done and has been abandoned. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Massie, that Permit #720, issued on May 17, 1926, to Joseph Rothwell, Quantico, Virginia, to construct a concrete approach in front of lunch room on Route 31, Prince William County, be cancelled as this work was never done and has been abandoned. Motion carried.

Moved by Mr. Massie, seconded by Mr. Shirley, that Permit #4693, issued on February 4, 1926, to Mr. Pettit Penberth, Palmyra, Virginia, to move a double school house, 16x18 Ft. along Route 32 about $1\frac{1}{2}$ miles in Fluvanna County, be cancelled as work was never done and has been abandoned. Motion carried.

Moved by Mr. Truxton, seconded by Mr. Massie, that the following Permits be granted under the usual Rules and Regulations of the Commission:

To Amelia Light & Power Company, Amelia, Virginia, to place a $1\frac{1}{2}$ " conduit under State Highway No. 20 for an electric wire;

To Appalachian Electric Power Company, Roanoke, Virginia, to erect and maintain an electric transmission line along Route 18 in Appomattox County;

To Town of Ashland, Board of Water Commissioners, to repair sewer on England Street in the Town of Ashland, Route 39;

To D. M. Barrett, Elliston, Virginia, to lay a 1" water line under State Highway No. 10 at Station 195.

Motion carried.

Moved by Mr. Truxton, seconded by Mr. Gilmer, that the application of the Appalachian Electric Power Company, Roanoke, Virginia, for a permit to erect poles along State Highway No. 18 in Nelson County, be disapproved as the Commission is of the opinion that it would be unsafe for the traveling public to have these high power lines so close to the traveled portion of the highway and until the Commission has secured a width of right of way of at least 40 to 50 feet they cannot grant this permission. Motion carried.

Moved by Mr. Truxton, seconded by Mr. Masie, that whereas under Chapter 212, Acts 1926, the Chairman of the State Highway Commission having petitioned the Commission to relocate sections of State Highway No. 10 between Petersburg and Blackstone in the Counties of Dinwiddie and Nottoway to avoid dangerous railroad grade crossings, be it ordered that the following public notice be given:

"THE STATE HIGHWAY COMMISSION OF VIRGINIA, hereby gives notice, in accordance with Chapter 212, Acts approved March 19, 1926, that the Chairman of the Commission having petitioned that the following changes in State Highway No. 10 be made so as to avoid a number of grade crossings of the Norfolk and Western Railway Company's tracks in the Counties of Dinwiddie and Nottoway;

Move Back Road No. 6-7
Sweet Valley Co.

First, Passing State Highway No. 10 from the south side of the N.W. tracks to the north side by an underpass near Mile Post 94 and to close the now existing grade crossing at Mile Post 94+515 as soon as the underpass has been constructed and opened for traffic;

Second, To construct an underpass at M.P. 99+116 carrying State Highway No. 10 from the north side back again to the south side of the tracks and close the grade crossing as soon as the underpass has been completed and opened to traffic at M.P. 99+410;

Third, To remodel the present overhead bridge at Hebrew between M.P. 105 and 106 in such a way as to eliminate the dangerous curves approaching thereto;

Fourth, To relocate the section of road between M.P. 109 and 112 so as to throw State Highway No. 10 on the north side of the N.W. tracks and to close grade crossing at M.P. 111+812;

Fifth, To relocate the section of State Highway No. 10 throwing it on the north side of the tracks between M.P. 112 and 114, and to close grade crossing at M.P. 113+221;

Sixth, To erect an overhead bridge near M.P. 116 and to eliminate grade crossing at M.P. 116+500, removing the overhead bridge now located at M.P. 117+318 and relocating County road leading from Denaro and bringing it to the proposed overhead bridge at M.P. 116 and to construct section of county road necessary to make this connection.

NOTICE IS HEREBY GIVEN, that the proposed changes will be made unless there are objections thereto filed in writing in the office of the State Highway Commission, State Office Building, Richmond, Virginia, on or before noon August 25th, 1926". Motion carried.

State Highway No. 10
Appomattox Co.

Moved by Mr. Massie, seconded by Mr. Gilmer, that whereas the Chairman of the State Highway Commission, having petitioned the Commission to relocate State Highway No. 10 in Appomattox County between the Prince Edward-Appomattox County Line and Appomattox Court House, under Chapter 212, Acts of 1926, the following public notice is hereby given:

"THE STATE HIGHWAY COMMISSION OF VIRGINIA, hereby gives notice, in accordance with Chapter 212, Acts approved March 19, 1926, that the Chairman of the Commission having petitioned that the following changes be made in sections of State Highway No. 10 so as to eliminate a number of dangerous grade crossings of the Norfolk & Western Railway Company's tracks in the County of Appomattox, by locating the road on the north side of the tracks and closing the following crossings as public crossings, but to remain open as farm crossings:

- 1st - At Railroad Mile Post 171+1364 feet;
- 2nd - at Railroad Mile Post 172+2149 feet;
- 3rd - At Railroad Mile Post 175+ 4 $\frac{1}{2}$ feet;
- 4th - That a spur be built from the proposed new location of State Highway No. 10 to Evergreen Station.

NOTICE IS HEREBY GIVEN, that the proposed changes will be made unless there are objections thereto filed in writing at the office of the state Highway Commission, State Office Building, Richmond, Virginia, on or before noon, August 25, 1926. Motion carried.

Moved by Mr. Truxton, seconded by Mr. Massie, that the Chairman be authorized to change the contract for widening the Virginia Beach Boulevard at the same unit prices from a 4 $\frac{1}{2}$ '6" slab to a 9'0" slab, so far as the money will go. Motion carried.

Black Rock Chas M. P.
Brown Valley Co.

Moved by Mr. Massie, seconded by Mr. Truxton, that whereas the Board of Supervisors of Sussex County having put in acceptable condition the 3.15 miles of road added to the State Highway System under the 2nd Clause of the Law, in Sussex County between Wakefield and the Surry County Line, the State Highway Commission hereby confirms the mileage so added and orders same to be maintained hereafter and to be known as State Highway No. 351. Motion carried.

Moved by Mr. Truxton, seconded by Mr. Massie, that the options covering a 100 foot right of way from Lynnhaven Inlet to East Ocean View, along the water front, be received and filed, these including the entire right of way except that through the Ocean View Park and the Pennsylvania Railroad Company's property. Motion carried.

Moved by Mr. Truxton, seconded by Mr. Massie, that the Commission adopt what is known as the straight line route between Williamsburg and Jamestown, and that the Chairman be instructed to immediately put the convict forces in this District on grading this road. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Massie, that:

Death having claimed Atwell J. Huff of Washington County, a member of the State Highway Commission; and,

Whereas, Mr. Huff typified in his life and character a sturdy and undying devotion to the State, and his fellow men; and,

Whereas, in the arduous duties imposed by such office he gave unselfishly of his time and strength; Now Therefore,

Be It Resolved, that we, the State Highway Commission, greatly deplore his death and will sadly miss his wise counsel in our deliberations; and,
