# MINUTES OF MEETING OF STATE HIGHWAY AND TRANSPORTATION COMMISSION

#### Richmond, Virginia

July 19, 1984

The monthly meeting of the State Highway and Transportation Commission was held in the Central Office in Richmond, Virginia, on July 19, 1984, at 10:30 a.m. The chairman, Mr. Harold C. King, presided.

NOW, THEREFORE, BE IT RESOLVED that \$150,000 of the 1984-85 Industrial Access Fund be allocated to provide adequate access to the proposed facility of Southeastern Adhesives Company by the improvement of Route 689 from Route 220 to 0.094 mile west in Henry County, Projects 0689-044-221, M-501, and 0689-044-S21, FS718, contingent upon 1) the necessary right of way and utility adjustments being provided at no cost to the industrial access fund; 2) all costs for construction in excess of \$150,000 to be borne by the Secondary Road Improvement Fund; and 3) satisfactory evidence that Southeastern Adhesives Company is under firm contract to construct and operate a facility, the capital outlay of which is \$1,500,000 or more.

WHEREAS, the Committee on Parks and Recreation and the State Highway and Transportation Commission have adopted a joint policy to govern the use of recreational access funds pursuant to Section 33.1-223 of the Code of Virginia; and

WHEREAS, the Board of Supervisors of James City County has, by resolution, requested the use of recreational access funds to provide adequate access to the Upper County District Park in James City County, estimated to cost \$170,000; and

WHEREAS, this request has been considered by the Committee on Parks and Recreation and has been found to comply fully with the provision of Section 33.1-223; and

WHEREAS, the Committee on Parks and Recreation has recommended the construction of the aforementioned access.

NOW, THEREFORE, BE IT RESOLVED, that \$170,000 from the 1984-85 Recreational Access Fund be allocated to assist in providing access to the Upper County District Park in James City County, Project 0674-047-135, M-501, contingent upon the necessary right of way and utility adjustments being provided at no cost to the Commonwealth.

WHEREAS, Section 33.1-223 of the Code of Virginia sets forth that the General Assembly of Virginia has found and declared that it is "... in the public interest that access roads to public recreational areas and historical sites be provided by using highway funds ...."; provides highway funds for such purpose; and further provides that "The State Highway and Transportation Commission and the Division of Parks and Recreation are hereby authorized to make regulations to carry out the provisions of this section."; and

WHEREAS, the Division of Parks and Recreation and the State Highway and Transportation Commission have adopted a joint policy to govern the use of recreational access funds pursuant to Section 33.1-223 of the Code of Virginia; and
