

Minutes of the Meeting of the State Highway  
Commission of Virginia, Held in  
Richmond, August 5, 1939.

On the morning of August 5, 1939, the State Highway Commission, consisting of Messrs. E. G. Shirley, Wade H. Massie, Secretary, E. W. Rawls, J. F. Wycor and Kenneth H. Gilpin, met in their office, State Office Building, Richmond, Virginia.

The meeting was called to order by the Chairman.

Moved by Mr. Wycor, seconded by Mr. Rawls, that the minutes of the meeting of July 15th be approved. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wycor, that the minutes of the meeting of July 27th be approved. Motion carried.

Moved by Mr. Gilpin, seconded by Mr. Massie, that the Commission allocate to the City of Martinsville for the year 1939-40 the \$500.00 per mile construction funds to be expended in widening Starling Street from Forrest Street to the south city limits, Route 220. Motion carried.

Moved by Mr. Wycor, seconded by Mr. Rawls, that the Commission allocate to the City of Vinton for the year 1939-40 the \$500.00 per mile construction funds to be expended on Route 24 for construction of curb and gutter. Motion carried.

Moved by Mr. Gilpin, seconded by Mr. Massie, that as provided by Chapter 415, Act approved March 31, 1932, and upon recommendation of the Commissioner, the following sections of Route 614 in Frederick County being no longer necessary for uses as a highway, the same be abandoned upon opening of new sections in lieu thereof: Sections 1, 4 and 6 as shown on plat dated July 15, 1939. That sections 2, 3 and 5 also shown be added to the system, all on Project 1393 K. Motion carried.

Moved by Mr. Massie, seconded by Mr. Wycor, that the request of Blackwell Engineering and Construction Co., Warrenton, Va., for an extension of time on Project PA 1180 DB3,4, Route 29, 0.98 Mi. S. of Rixeyville-1.55 Mi. S. Rixeyville, be granted for 10 days and the return of \$190.00 liquidated damages, as recommended by the Chief Engineer. Motion carried.

#### RESOLUTION AWARING CONTRACT

WHEREAS, Carnuel, Johnston & Wright, Consulting Architects and Engineers, pursuant to a Resolution heretofore adopted, have tabulated and considered all bids heretofore received for the construction of tunnel from the Central Highway Office Building to the State Library Building and have duly made their recommendations to this Commission, and it appearing from said recommendations and report that C. M. Henley, Richmond, Virginia, is the lowest and best Bidder for the construction of the tunnel from the Central Highway Office Building to the State Library Building, in the sum of \$22,852.50; and that this Commission, after considering said report and recommendations and all bids heretofore filed, finds that the bid of C. M. Henley is the lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED BY THE STATE HIGHWAY COMMISSION OF VIRGINIA AS FOLLOWS:

Section 1. That the bid of C. M. Henley, for the construction of tunnel from the Central Highway Office Building to the State Library Building, in the sum of \$22,852.50; is hereby accepted, determined and declared to be the lowest and best bid, however, this award shall not be effective until the awardee shall have been notified in writing by the Architects of the State Highway Commission of such award. That upon the awardee being so notified

in writing a contract for the construction of said work, as heretofore prescribed by the plans, specifications and contract documents, shall be forthwith executed for said construction.
