

Minutes of the Meeting of the State Highway
Commission of Virginia, Held in
Richmond, September 7, 1938.

On the morning of September 7, 1938, the State Highway Commission, consisting of Messrs. E. G. Shirley, Wade H. Massie, Secretary, Wm. H. East, S. W. Rawls and J. F. Wycor, met in their office, State Office Building, Richmond, Virginia.

The meeting was called to order by the Chairman.

Moved by Mr. Wycor, seconded by Mr. Rawls, that the minutes of the meeting of July 29th, be approved. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that Mr. D. N. Huddle, Resident Engineer at Chester, be appointed traffic officer. Motion carried.

Moved by Mr. Rawls, seconded by Mr. East, that there be transferred from Route 16, Louisa-North, \$15,000.00 and from Route 55, Louisa-Trevilians, \$4,000.00- to Route 85, Louisa-East. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Rawls, that the Commission accept the ordinance of the Town Council of Haysi turning over for maintenance 2.31 miles of highway having a width of 30 ft. on Routes 59 and 80 in the Town, 0.2 mile of less than 30 ft. width not to be accepted. Motion carried.

Moved by Mr. East, seconded by Mr. Rawls, that the Commission accept as full and final payment from the C&O Railway Company \$18,884.00, including \$11,440.00 for work between mile posts 250 and 251, and \$7,444.00 for work between mile posts 250 and 265, on Project 380 AC, Route 42, Craigsville to Goshen, due to the relocation of Route 17 and the closing of two grade crossings, one just east of Belle Valley and the other just east of Goshen. Motion carried.

Moved by Mr. East, seconded by Mr. Rawls, that \$500.00 per mile construction funds for 1938-39 be allocated to the City of Waynesboro to be expended for work on Routes 250 and 12 in the City. Motion carried.

Moved by Mr. East, seconded by Mr. Rawls, that the work within the grounds of V.M.I., amounting to \$1890.00 be approved and undertaken, and charged to balance in Works Progress Highway funds. Motion carried.

Moved by Mr. Wycor, seconded by Mr. East, that the following permit be approved under the usual rules and regulations:
