

Minutes of the Meeting of the State Highway  
Commission of Virginia, Held in  
Richmond, September 14, 1939.

On the morning of September 14th, 1939, the State Highway Commission, consisting of Messrs. H. G. Shirley, Wade H. Massie, Secretary, S. W. Rawls, J. F. Wyszor and Kenneth N. Gilpin, met in their office, State Office Building, Richmond, Virginia.

The meeting was called to order by the Chairman.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the minutes of the meeting of August 5th be approved. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the annual report be approved and forwarded to the Governor. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Shirley, that the restriction on vehicles carrying over 8 tons gross load, heretofore effective on Route 55 between Suffolk and Alexander's Corner, be removed, as such restriction is considered no longer necessary due to the widening of the surface to three tracks. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the Commission allocate the \$500.00 per mile construction funds to the City of Bristol to be expended on the resurfacing of State Street in the City, Route 11-55. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that in the cases of arrests for stealing, where there is a conviction and jail sentences of sixty days or more, to pay the \$50.00 reward; where no sentence is served the amount of fine plus the cost is to be paid. Motion carried.

Mr. Houston, City Manager of Fredericksburg, Mr. Clark, Mr. Gouldman and Mr. Gibson, appeared before the Commission with further reference to the proposed bridge at Fredericksburg. The Commission explained just what they were willing to do and await further action by the City Council.

Moved by Mr. Massie, seconded by Mr. Gilpin, that the request of the Town of Orange to improve Main Street, Route 16, at a cost of \$1200.00 to the State, under a WPA project, be approved, and the amount transferred from Route 16. Motion carried.

RESOLUTION AWARDING CONTRACT

WHEREAS, Carneal, Johnston & Wright, Consulting Architects and Engineers, pursuant to a Resolution heretofore adopted, have tabulated and considered all bids heretofore received for the construction of drinking water cooling system in the Central Highway Office Building and have duly made their recommendations to this Commission, and it appearing from said recommendations and report that Carle-Boshling Co., Inc., Richmond, Va., is the lowest and best Bidder for the construction of the drinking water cooling system in the Central Highway Office Building, in the sum of \$810.00, and that the Commission, after considering said report and recommendations and all bids heretofore filed, finds that the bid of Carle-Boshling Co., Inc., is the lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED BY THE STATE HIGHWAY COMMISSION OF VIRGINIA, AS FOLLOWS:

Section 1. That the bid of Carle-Boshling Co., Inc., for the construction of drinking water cooling system in the Central Highway Office Building, in the sum of \$810.00; is hereby accepted, determined and declared to be the

lowest and best bid, however, this award shall not be effective until the awardee shall have been notified in writing by the Architects of the State Highway Commission of such award. That upon the awardee being so notified in writing a contract for the construction of said work, as heretofore prescribed by the plans, specifications and contract documents, shall be forthwith executed for said construction.

That section 2 also shown be added to the system as new location. Motion carried.
