The chairman shared with the Commission a copy of a letter dated September 11, 1984, from Ray A. Barnhart, Federal Highway Administrator, responding to Mr. King's letter of August 24, 1984, to Secretary of Transportation Elizabeth H. Dole wherein the Commission expressed its opposition to the practice of the Congress and the Department of Transportation to advance federal policies through the threatened cut off of federal highway entitlements.

As a result of a meeting Mr. Brydges attended with the Virginia Beach Expressway Study Commission, he asked that noise readings be taken near the collection booths on the Expressway. These readings will be taken and discussed with Mr. Brydges.

Mr. Brydges expressed the concern of residents in the area regarding the grass along the Expressway. It was decided that machine cuttings will be done more frequently in the future, as necessary. Also, the Department will look into the possible use of Bermuda grass for this location.

Mr. David Grochmal, Assistant City Manager of Virginia Beach, welcomed the Commission to Virginia Beach.
