

WHEREAS, in order to more fully develop the adjacent lands, the adjoining landowner has requested that a portion of old Route 57 be conveyed to him; and

WHEREAS, inasmuch as the Property Company of America (PCA) is the contract purchaser of a tract of land containing 4.7 acres, more or less, to be developed as an office site, lying between the proposed relocated section of Random Hills Road and the existing location, PCA has proferred the dedication and construction of

WHEREAS, Wayne a Whitham served with distinction and honor as the Commonwealth's first Secretary of Transportation from 1972 to 1978; and

WHEREAS, Virginians have benefited from the commitment of his time and many talents toward effective highway and transportation programs and a responsive state government; and

WHEREAS, as a public servant, businessman, and civic leader, he exemplified in every respect the highest qualities of dedicated public service; and

WHEREAS, Wayne A. Whitham passed away on June 7, 1982, after an extended illness; and

WHEREAS, this Commission considers it a fitting tribute to name the welcome center and rest area on Interstate 81 in Frederick County in honor of this renowned adopted Virginian and proud resident of Winchester:

NOW, THEREFORE, BE IT RESOLVED, that the Virginia Highway and Transportation Commission hereby declares that the welcome center and rest area be dedicated to the memory of Wayne A. Whitham; and

BE IT FURTHER RESOLVED, that appropriate markers, as directed by the Department's Engineers, shall be placed calling attention to its designation.

Moved by Mr. Humphreys, seconded by Mr. Dayidson, that

WHEREAS, the Virginia General Assembly in 1973 dissolved the Richmond-Petersburg Turnpike Authority and transferred the Authority's powers, properties, covenants, obligations, and agreements to the State Highway Commission; and

WHEREAS, on December 4, 1973, \$103,000,000 in Commonwealth of Virginia Transportation Facilities Bonds, Series 1973, were issued subject to the provisions of Section 9(c) of Article X of the Constitution of Virginia, with such remaining bonds in the amount of \$47,000,000 to mature on June 1, 1993; and

WHEREAS, the Virginia General Assembly and this Commission recognized that the continuance of the tolls on the Richmond-Petersburg Turnpike would provide funds to finance several critical highway projects in the Greater Richmond Area; and

WHEREAS, the 1983 session of the Virginia General Assembly enacted Senate Bill 304 which authorized the extension of the tolls on the Richmond-Petersburg Turnpike to coincide with the completion and opening to traffic of Interstate 295 between U. S. Route 60 in Henrico County, east of the City of Richmond, and Interstate Route 95 in Prince George County, south of the City of Petersburg, and

WHEREAS, federal approval of such action was obtained in H. R. 6441 enacted during the second session of the 98th Congress of the United States of America;

NOW, THEREFORE, BE IT RESOLVED, that the State Highway and Transportation Commission hereby authorizes the State Treasury Board to proceed with the defeasance of the remaining Commonwealth of Virginia Transportation Facilities Bonds, Series 1973, issued for the widening of the Richmond-Petersburg Turnpike.

Motion carried.
