

Minutes of the Meeting of the State Highway Commission
of Virginia, Held in Roanoke on the 8th, Staunton
on the 10th and Richmond on the 11th of
December 1937.

Commissioners Massie, Rawls and Shirley, on the afternoon of December 8th, drove to Roanoke from Richmond, where they spent the night. On the 9th they were joined by Commissioners East and Wycor and gave a public hearing on the tentative allocation of funds to the citizens of the Salem and Bristol Districts. After the meeting the Commission proceeded to Lexington where they spent the night. The following morning, proceeded to Staunton where public hearings were given on the allocations to the Staunton and Lynchburg Districts.

After these hearings a further hearing was given to Mr. Stuart Moore and others on the location of Route 11 from Lexington-South.

The Commission then proceeded to Richmond where the night was spent and on the 11th hearings were continued for the Richmond, Fredericksburg, Culpeper and Suffolk Districts. After the hearings a special meeting was called and the following business transacted.

Moved by Mr. Massie, seconded by Mr. Rawls, that the Commission having carefully considered the request of the citizens living along the present U. S. Route 11 south of Lexington, and others represented by Mr. Stuart Moore, not to change the location of this route, find that for public convenience this section should be relocated and constructed on the location heretofore adopted; Further, the Chairman is hereby instructed to place the construction forces again on the adopted location, unless in his judgment after investigating such action should not be taken, and this fact to be immediately reported to the Commission. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that the minutes of the meeting of November 9th be approved. Motion carried.

Moved by Mr. Massie, seconded by Mr. Wycor, that the \$500.00 per mile additional funds for construction be approved for the City of Bedford for 1937-38, to be expended for resurfacing on Route 48, Peaks Street from the NCL of Bedford to 1700 ft. South of the NCL, and section of Main Street from alley between the Court House and Post Office to South Street. Motion carried.
