

Minutes of the Meeting of the State Highway  
Commission of Virginia, Held in  
Richmond, December 16, 1938.

On the morning of December 16th, 1938, the State Highway Commission met in their office, State Office Building, Richmond, Virginia, there being present Messrs. Wade H. Massie, E. W. Rawls and J. F. Wyszor.

The meeting was called to order by the Acting Chairman, Mr. Wade H. Massie.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the minutes of the meeting of October 31st and November 1, 2, and 3, be approved. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that under Chapter 173, Section 5B, Act approved March 17, 1938, there be added to the State highway system in the City of Buena Vista, 0.04 Mile as one leg of a "Y" connection between Routes 60 and 501. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the request of the City of Charlottesville for additional State highway mileage within the City, due to annexation, amounting to - 0.50 mile on Route 250; 1.88 miles on Route 29 and 0.51 mile on Route 239, a total of 2.89 miles, be approved, thereby making a total mileage in the City of 8.31 miles. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the State Highway Commission of Virginia extend to the American Association of State Highway Officials a cordial invitation to hold the 25th anniversary meeting of the Association in Richmond, during the second week of October 1939. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the matter referred to in letter of November 21st to Governor James H. Price, from Mr. George F. Browning, relative to right of way costs on Route 3, through Flint Hill, be fully investigated and report made to the Commission. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the Town of Duffield having passed proper ordinance requesting the Highway Commission to take over Route 23 in the Town for maintenance, the same be accepted. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that if the Town of Pamington Gap will put the proposed change in routing through the Town of No. 66 in a condition satisfactory to the Highway Department, that the change be made as requested and the Department accept it for future maintenance and improvement. Motion carried.

RESOLUTION AWARDING CONTRACT

WHEREAS, Carneal, Johnston & Wright, Consulting Architects and Engineers, pursuant to a Resolution heretofore adopted, have tabulated and considered all bids heretofore received for the construction of Central Highway Office Building, and have duly made their recommendations to this Commission, and it appearing from said recommendations and report that Virginia Engineering Company, Inc., is the lowest and best Bidder for the construction of the Central Highway Office Building, in the sum of \$548,000.00; and that this Commission, after considering said report and recommendations and all bids heretofore filed, finds that the bid of Virginia Engineering Company, Inc. is the lowest and best bid;

NOW, THEREFORE, BE IT RESOLVED BY THE State Highway Commission of Virginia, AS FOLLOWS:

Section 1. That the bid of Virginia Engineering Company, Inc. for the construction of Central Highway Office Building, in the sum of \$548,000.00, is hereby accepted, determined and declared to be the lowest and best bid; however, this award shall not be effective until the awardee shall have been notified in writing by the Architects of the State Highway Commission of such

award. That upon the awardee being so notified in writing a contract for the construction of said work, as heretofore prescribed by the plans, specification and contract documents, shall be forthwith executed for said construction.

Section 2. That C. S. Mullen, Acting Commissioner, is hereby authorized and directed to execute said contract in the name of and for and on behalf of the State Highway Commission of Virginia.

Intersection Route 244 at Amundale-Intersection Route 237 in Fairfax, to the low bidder, B. W. Jackson, Inc., Richmond, Va., at his bid of \$61,820.57, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$68,000.00 chargeable to this project. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the Commission confirm award of contract for the construction of Project S 139 JM, Route 6, 1.4 MI. N. Riner-0.58 MI. N. SCL Christiansburg, to the low bidder, Perkins-Barnes Construction Co., Inc., Blackstone, Va., at their bid of \$94,135.46, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$103,000.00 chargeable to this project. Motion carried.

West (Gibson Station) to the low bidder, R. H. Moved by Mr. Massie, seconded by Mr. Rawls, that the Commission award contract for the construction of Project FA 439 BW1, Route 1, Bridge over Hunting Creek at Alexandria, to the low bidder, Bowers Construction Company, Whiteville, N. C., at their bid of \$16,505.50, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$17,900.00 chargeable to this project. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the Commission award contract for the construction of Project S 1177 B1, Route 166, Bridge over Queen Creek, to the low bidder, Bowers Construction Company, Whiteville, N. C., at their bid of \$13,452.45 and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$14,700.00 chargeable to this project. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the Commission award contract for the construction of Project FASH 1318 E, Route 803, 0.6 MI. S. SCL Radford-0.9 MI. S. SCL Radford, to the low bidder, M. S. Hudgins, Roanoke, Va., at his bid of \$7,878.75, and that 10% additional be set aside to cover the cost

of engineering and additional work, making a total of approximately \$8,400.00 chargeable to this project. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Massie, that the Commission award contract for the construction of Project PA 320 B2W, Route 58, Bridge over Thalia Creek, to the low bidder, Bowers Construction Company, Whiteville, N.C., at their bid of \$19,881.00 and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$21,800.00 chargeable to this project; the \$5,800.00 additional needed to be supplied from unprogrammed balances of the 1939 Federal Aid program. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyzor, that the Commission award contract for the construction of Project S 794 EB2, Route 5, Chickahominy River Bridge and Approaches at Barretts Ferry, to the low bidder, Tidewater Construction Corporation, Norfolk, Va., at their bid of \$243,317.76, and that 5% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$256,000.00 chargeable to this project; transferring from Route 2, Pamunkey River Bridge-Richmond District, and Route 315, Tasley-North, Suffolk District, \$15,000.00 each or a total of \$30,000.00 to this project. Motion carried.

Moved by Mr. Wyzor, seconded by Mr. Rawls, that the Commission award contract for the construction of Project S 1216 AB1, Route 100, 1.7 Mi. S. Newbern- 1 Mi. N. Madam, to the low bidder, Albert Bros., Contractors, Inc., Salem, Va., at their bid of \$43,662.82, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$48,000.00 chargeable to this project; portion of cost to be paid by the Appalachian Electric Power Company to be decided on by agreement, and balance to be transferred from Route 41, Callands-North and Route 24, Stewartsville-East. Motion carried.

old Route 7 in Frederick County being no longer necessary for use as a highway, the same be abandoned upon opening of new section in lieu thereof: Sections 1, 2 and 5 as shown on plat dated November 9, 1938, Project 1065 H. That sections 4 and 5 shown on the plat referred to be added to the secondary system as connections. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that as provided by Chapter 212, Section 1, Act approved March 19, 1926, and upon recommendation of the Acting Commissioner, the following sections of old Route 108 in Henry County being no longer necessary for use as a highway, the same be abandoned upon opening of new section in lieu thereof: Sections 1, 2, 4 and 5 as shown on plat dated November 18, 1938, Project 1170A. Motion carried.

Moved by Mr. Massie, seconded by Mr. Wyszor, that as provided by Chapter 212, Section 1, Act approved March 19, 1926, and upon recommendation of the Acting Commissioner, the following sections of old Route 18 in Cumberland County being no longer necessary for use as a highway, the same be abandoned upon opening of new section in lieu thereof: Sections 1, 2, 3, 6, 7 and 8 as shown on plat dated November 17, 1938, Project 1072 G. That as provided by Chapter 415, Section 8, Act approved March 31, 1932, section 4 shown on the plat referred to be abandoned as a section of the secondary system and section 5 also shown on the plat be added to the secondary system as a connection. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that as provided by Chapter 212, Section 1, Act approved March 19, 1926, and upon recommendation of the Acting Commissioner, the following sections of old Route 156 in Hottoway County being no longer necessary for use as a highway, the same be abandoned upon opening of new section in lieu thereof: Sections 1, 3, 4, 6, 7 and 8 as shown on plat dated November 25, 1938, Project 758 E. That sections 2 and 5 also shown on the plat referred to be abandoned as sections of the primary system and revert to the secondary system. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that as provided by Chapter 212, Section 1, Act approved March 19, 1928, and upon recommendation of the Acting Commissioner, the following sections of old Route 250 in Augusta County being no longer necessary for uses as a State highway the same be abandoned upon opening of new section in lieu thereof: Sections 1, 3, 6, 7, 8, 9, 10 and 11 as shown on plat dated November 29, 1938, Project 598 D1, 2. That section 2 shown on the plat referred to revert to the secondary system. That as provided by Chapter 415, Section 8, Act approved March 31, 1932, section 5 shown on the plat be abandoned and section 4 also shown be added to the secondary system as a connection. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Massie, that as provided by Chapter 212, Section 1, Act approved March 19, 1928, and upon recommendation of the Acting Commissioner, the following section of old Route 84 in Tazewell County being no longer necessary for uses as a State highway, the same be abandoned upon opening of new section in lieu thereof: Section 1 as shown on plat dated December 7, 1938, Project 251 A, R, 1. That section 2 also shown on the plat referred to be dropped from the highway system but revert to the town of Cedar Bluff as a street. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the matter of a vocation program for high school juniors, brought to the attention of the Commission by Dr. B. E. VanDot, of the State Board of Education, be brought up at a future date for consideration. Motion carried.

A delegation headed by Mr. John Bashara, representing the Navy Yard Metal Trades Council, the employees and laborers of the Norfolk Navy Yard, Portsmouth and the surrounding neighborhood, appeared before the Commission and requested them to purchase the Jordan Bridge and make it free. Mr. Moore, of the Naval Operating Base, and Mr. Grubbs, Master Mechanic of the Navy Yard, also spoke in behalf of the request.

Moved by Mr. Rawls, seconded by Mr. Massie that an investigation be made of the conditions connected with request to purchase the Jordan Bridge and all facts pertaining thereto presented to the Commission, and Mr. Bashara so notified. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the following permits be approved under the usual rules and regulations:

Altavista, Town of, to replace 1" water service line on 9th St. on Route 43 between Broad Street and Bedford Avenue.

CHAPTER 333.- An Act to regulate outdoor advertising outside of the corporate limits of cities and incorporated towns in sight of public highways; to provide for licensing persons engaged in the business of outdoor advertising and for the issuance of permits for advertisements and advertising structures; to prohibit certain advertisements and advertising structures and to provide for the removal of advertisements and advertising structures illegally posted, displayed, erected, used or maintained; to prescribe the powers and duties of certain officers relating thereto; and to prescribe penalties for violations of this act.

(H B 83)

Approved March 31, 1938.

1. Be it enacted by the General Assembly of Virginia as follows:

Definitions.- The following terms, wherever used or referred to in this act, shall have the following meanings unless a different meaning clearly appears from the context;

"Advertisement" means any writing, printing, picture, painting, display, emblem, drawing, sign, or similar device intended to invite or draw the attention of the public to any goods, merchandise, property, real or personal, business, services, entertainment or amusement, manufactured, produced, bought, sold, conducted, furnished or dealt in by any person, which is posted or displayed outdoors, on real property and shall include any part of an advertisement recognizable as such;

"Advertising structure" means any rigid or semi-rigid material, with or without any advertisement displayed thereon, situated upon or attached to real property outdoors, primarily or principally for the purpose of furnishing a background or base or support upon which an advertisement may be posted or displayed;

"Business of outdoor advertising" means the erection, use or maintenance of advertising structures, or the posting or display of outdoor advertisements, by any person who receives profit gained from rentals or any other compensation from any other person for the use or maintenance of such advertising structures or the posting or display of such advertisements, except reasonable compensation for materials and labor used or furnished in the actual erection of advertising structures or the actual posting of advertisements;

"Commissioner" means the State Highway Commissioner;

"Commonwealth" means the Commonwealth of Virginia;

"Highway" means every way or place of whatever nature open to the use of the public for purposes of vehicular travel in this State, outside of cities and incorporated towns;

"Person" includes an individual, partnership, association or corporation;

"Post" means post, display, print, paint, burn, mail, paste or otherwise attach;

"Real Property" includes any property physically attached or annexed to real property in any manner whatsoever;

"State" means the Commonwealth of Virginia;

"Town" means an incorporated town.

Rules and Regulations Made and Adopted as of December 15, 1938, by the State Highway Commission of Virginia for the Administration and Enforcement of Outdoor Advertising under Provisions of Chapter 333, Acts of Assembly, 1938, to Become Effective as of January 1, 1939.

## ARTICLE I

### ENFORCEMENT

Section 1. "It shall be the function and duty of the Commissioner to administer and enforce the provisions of the Act."

Section 2. The Commissioner will appoint a Director of Outdoor Advertising to administer the provisions of the act under his direction.

Section 3. The Director will appoint such regional supervisors, and district inspectors, subject to the approval of the Commissioner, as may be required to properly carry out the provisions of the Act under his direction.

Section 4. The Director, regional supervisors, and district inspectors will be furnished with such badges, certificates of appointments or other credentials as may be deemed necessary for the performance of their functions and duties to permit them to enter into or upon any land upon which advertising matter coming within the terms of the Act is displayed, and make such examinations as may be relevant.

## ARTICLE II

### TERRITORY

"The territory under the jurisdiction of the Commissioner for the purpose of this Act shall include all of the State outside of the corporate limits of any city or town."

## ARTICLE III

### LICENSES

Section 1. Licenses to engage or continue in the business of outdoor advertising in this state outside of the corporate limits of any city or incorporated town, will be issued by the Director.

Section 2. Applications for licenses or renewals of licenses, will be received only on forms furnished by the Director.

Section 3. Applications must be accompanied by certified check for the annual fee of \$25.00. Licenses may be revoked by the Commissioner after thirty(30)days' notice in writing to the licensee, upon the repayment of a proportionate part of the license fee in any case where the information required to be given in the application for the license, is knowingly false or misleading, or that the licensee has violated the provisions of this Act, unless such licensee shall before the expiration of said thirty(30)days correct such false or misleading information and comply with the provisions of the Act. (See Section 4 of the Act regarding appeal from the decisions of the Commissioner.)

Section 4. No license will be granted to any person having his principal place of business outside of the State, or which is incorporated outside of the State, until such person furnishes and files with the Commissioner a bond payable to the Commonwealth with surety approved by the Commissioner, and in form approved by the Attorney General, in the sum of \$1,000.00, conditioned that such licensee shall fulfill all requirements of laws and regulations, and orders of the Commissioner relating to displays of advertisements or erection of advertising structures. "Such bond shall remain in full force and effect so long as any obligations of such licensee to the State shall remain unsatisfied."

#### ARTICLE IV

##### PERMITS

Section 1. Except as otherwise provided for, a permit is required for each advertisement, or advertising structure outside the corporate limits of any city or town.

Section 2. Permits may be obtained from regional supervisors or district inspectors, or other agents duly authorized to issue same.

Section 3. Except as otherwise provided for, an application for a permit must be filed on approved form furnished for the same. A separate application is required for each advertisement and/or advertising structure. The application must be signed by the applicant or his representative duly authorized in writing to act for him, and shall describe and set forth the size, shape, and nature of the advertisement and/or advertising structure it is proposed to post, display, erect or maintain, and its actual or proposed location with sufficient accuracy to identify it, and find its actual or proposed location.

Section 4. Each application must be accompanied by prescribed fee for same, as follows:

(a)-For each advertisement or advertising structure containing:

1. 50 square feet or less - a fee of 50¢ .
2. More than 50 square feet - a fee of \$2.00

(b)-"The written consent, or in lieu thereof a copy certified by an officer authorized to take acknowledgment to deeds in this State, of the owner of the real property upon which such advertisement or advertising structure is to be created, used, maintained, posted or displayed, or of such other person having the legal right to grant such consent, or of the duly authorized agent of such owner or other person." In the event of change of ownership which would modify the above agreement, the Director must be notified immediately and revised data in legal form substituted for the original documents.

(c)-"Application shall be made in like manner for a permit to use, maintain, or display any existing advertisement or advertising structure."

(d)-Where more than one side of an advertising structure is used for advertising, an application fee for an advertising structure for each such side shall be required.

(e)-Each portion or section of an advertising structure upon which an advertisement is posted or displayed shall constitute a separate advertising structure, and a separate fee for each such section shall be required in accordance with its size.

(f)-Advertisements sculptured in the round shall be treated as using three sides and will require separate fees for advertising structures commensurate with their size.

(g)-Where a series of not more than six signs intended to carry attention from one sign or device to another, and containing in the aggregate less than fifty square feet, only one application shall be required and one permit fee of 50¢, provided they do not extend beyond a reasonable distance and are all visible from a point on the road at the beginning of the series.

Section 5. "Permits issued hereunder shall run for the calendar year, and may be renewed upon the payment of the same fee required to be paid upon application for a permit." No formal application shall be required for the renewal of the permit but a letter denoting the identification number or permit number, with a brief description of the sign and location must accompany said fee.

Section 6. Once a permit has been issued for an advertising structure, the permittee may post or display any advertising, other than those excepted by the provisions of the Act, on the same during the

current calendar year or for renewals of the same unless said permit has been revoked. In all such cases, the advertising structure must be identified as prescribed hereafter (Article V.)

Section 7. The Commissioner may, after thirty(30)days' notice in writing to the permittee, revoke any permit issued by him upon the repayment of a proportionate part of the fee in any case where it shall appear that the application for the permit contains knowingly false or misleading information, or that the permittee has violated any of the provisions of the Act, unless such permittee shall, before the expiration of said thirty(30)days, correct such false or misleading information and comply with the provisions of the Act. Where a permit is issued and the permit fee has been paid, and it is found to be invalidated and prevented by any zoning board, commission, or other public agencies which also have jurisdiction over the proposed advertisement and/or advertising structure, or its site, the application fee will be returned and the permit revoked.

Section 8. "One-half the application fee shall be deemed to have accrued upon the erection of an advertising structure or the display of an advertisement followed by an inspection."

Section 9. Where an applicant for a permit certifies that he is unable to state the actual or proposed location of the advertisement and/or advertising structure, or to file the written consent of the landowner or other persons having the legal right to the real estate upon which same is to be erected or used, a temporary permit shall be issued together with the proper identification number to be attached to same, which temporary permit shall expire sixty(60)days from date of issue. If the applicant files an application setting forth all the information required, the permit will be issued for same.

Section 10. Any person aggrieved by any action in refusing to grant, or in revoking, a permit, may within thirty(30)days from date of such refusal or revocation, appeal from the decision of the Commissioner to the Circuit Court as prescribed in Section 6 of Chapter 335, Acts of the Assembly, 1938.

## ARTICLE V

### IDENTIFICATION

Section 1. Each advertising structure and/or advertisement not posted or displayed on an advertising structure, shall bear an identification number furnished by the Director, and if same is erected, maintained, or displayed by a licensed outdoor advertiser shall also bear his name.

Section 2. Identification plates bearing the number of the permit as furnished by the Director must be posted only on the structures or advertisements for which permits have been issued. The permittee must attach the identification plates to the advertisements or structures in a conspicuous place on the face of the same and maintain these in a legible manner at all times. The identification plates are not to be repainted except in the original colors or as may be further prescribed by the Director.

Section 3. One identification plate embossed on metal will be supplied with each permit issued. Additional plates will be supplied to the permittee at twenty-five cents (25¢) each. Fee must accompany order for same. Rates subject to change.

#### ARTICLE VI

##### REMOVALS

"All outdoor advertisements and advertising structures shall be removed by the permittee within ninety(90)days from date of expiration or revocation of the permit for the same." In the case of default of removal, the permittee will be given at least thirty(30) days' notice of the date of expiration of such ninety-day period. Mailing of notices by the Director will constitute necessary legality in the premises.

"Any permittee failing to remove any such advertisement or advertising structure within said ninety days, shall be deemed guilty of misdemeanor." (Chapter 333 Acts of 1938, Section 8.)

(This article only applies to cases where permits have heretofore been issued.)

#### ARTICLE VII

##### CERTAIN OUTDOOR ADVERTISING PROHIBITED

Section 9. Chapter 333 Acts of 1938: "No advertisement or advertising structure shall be created or maintained;

- (a)-Within five hundred feet of the Blue Ridge Parkway, the Colonial National Parkway, or the Mount Vernon Boulevard or within five hundred feet of any public cemetery, public park, reservation, public playground or State forest, outside the limits of any city or town;
- (b)-Which involves motion or rotation of any part of the structure or displays intermittent lights;

(c)-Which uses the word "stop" or "danger" prominently displayed, or presents or implies the need or requirement of stopping or the existence of danger, or which is a copy or imitation of official signs;

(d)-In such manner or place as to constitute a hazard to traffic."

#### ARTICLE VIII

##### OUTDOOR ADVERTISING ON HIGHWAYS

Section 10. Chapter 338 Acts of 1938: "Any person who wilfully or maliciously displaces, removes, destroys or injures a mileboard, milestone, danger-sign, signal, guide-sign, guide-post, highway sign, or historical marker or any inscription thereon, lawfully within a highway, or who in any manner paints, prints, places, puts or affixes any advertisement upon or to any rock, stone, tree, fence, stump, pole, mileboard, milestone, danger-sign, guide-sign, guide-post, highway sign, historical marker, building or other object lawfully within the limits of any highway, shall be guilty of a misdemeanor and shall be punished accordingly."

The term "within the limits of the highway" means the full width of the prescribed right of way. This section applies to the roads of the secondary as well as the primary system.

#### ARTICLE IX

##### DISPOSITION OF FEES

Section 11. Chapter 338 Acts of 1938: "All monies received by the Commissioner under the provisions of this Act shall be paid by him into the State treasury, and allocated to the State Highway Commission for use in the construction and maintenance of highways."

#### ARTICLE X

##### HARMONY OF REGULATIONS

Section 12. Chapter 338 Acts of 1938: "No zoning board or commission nor any other public officer or agency, shall permit any advertisement or advertising structure which is prohibited under the provisions of this Act, nor shall the Commissioner permit any advertisement or advertising structure which is prohibited by any other public board, officer or agency in the lawful exercise of its or their powers."

ARTICLE XI

CERTAIN ADVERTISEMENTS EXCEPTED

Section 18. Chapter 353 Acts of 1938: "The following advertisements and advertising structures, or parts thereof, upon which they are posted or displayed, are excepted from all the provisions of the Act, save those enumerated in Article VII, sub-section (b), (c), and (d):

(a)-Signs erected or maintained, or caused to be erected or maintained, by the owner or lessee of a place of business or residence within five hundred feet of such place of business or residence and relating solely to merchandise, services or entertainment sold, produced, manufactured or furnished at such place of business or residence;

(a-1)-Signs erected or maintained, or caused to be erected or maintained, on any farm by the owner or lessee of such farm and relating solely to farm produce, merchandise, services or entertainment sold, produced, manufactured or furnished on such farm;

(b)-Signs upon real property posted or displayed by the owner, or by the authority of the owner, stating that the property, or a part thereof, is for sale or rent;

(c)-Official notices or advertisements posted or displayed by or under the direction of any public or court officer in the performance of his official or directed duties, or by trustees under deeds of trust, deeds of assignment or other similar instruments.

(d)-Danger or precautionary signs relating to the premises or signs warning of the condition of or dangers of travel on a highway, erected or authorized by the Commissioner; or forest fire warning signs erected under authority of the State Commission on Conservation and Development, and signs, notices or symbols erected by the United States Government under the direction of the United States Forest Service;

(e)-Signs relating solely to any city, town, village or historic place or shrine.\*

(This applies to signs erected or maintained solely by the corporate authorities of the city, town or village, and by authority of the owner or owners of such historical place or shrine).

\*(f)-Notices of any railroad, bridges, ferries or other transportation or transmission company necessary for the direction or safety of the public.\*

(Such notices or directional signs are not to exceed two square feet).

**(g)**-Signs, notices or symbols for the information of aviators as to location, direction and landings and conditions affecting safety in aviation erected or authorized by the commissioner;

**(h)**-Signs containing sixteen square feet or less and bearing an announcement of any town, village or city advertising itself or local industries, meetings, buildings, or attractions, provided the same is maintained wholly at public expense;

**(i)**-Advertisements or advertising structures not visible from any highway or other public place;

**(j)**-Signs or notices containing two square feet or less, placed at a junction of two or more roads in the State highway system denoting only the distance or direction of a residence or place of business, provided such signs or notices do not exceed reasonable number in the discretion of the commissioner;

**(k)**-Signs or notices erected or maintained upon property giving the name of the owner, lessee or occupant of the premises;

**(l)**-Advertisements and advertising structures within the corporate limits of cities and towns;

**(m)**-Historical markers erected by duly constituted and authorized public authorities;

**(n)**-Highway markers and signs erected, or caused to be erected by the commissioner or the State Highway Commission;

**(o)**-Signs erected upon property warning the public against hunting, fishing or trespassing thereon;

**(p)**-Signs erected by Red Cross authorities relating to Red Cross Emergency Stations. And authority is hereby expressly given for the erection and maintenance of such signs upon the right of way of all highways in this State at such locations as may be approved by the commissioner;

**(q)**-Signs advertising agricultural products and horticultural products, or either, when such products are produced by the person who erects and maintains the said signs; provided, however, that the location and number of said signs shall be in the sole discretion of the State Highway Commissioner;

**(r)**-Signs advertising bona fide agricultural county, district or State fairs."

## ARTICLE XII

### VIOLATION A NUISANCE

Section 14. Chapter 588 Acts of 1938: "Any advertisement, or advertising structure, which is erected, used, maintained, posted, or displayed in violation of this act, is hereby declared to be a public and private nuisance and shall be forthwith removed, obliterated or abated by the commissioner or his representatives, after ten days' notice in writing mailed to the last known address of the licensee or permittee or if there be no licensee or permittee then to the person erecting, maintaining, using, posting or displaying the same."

The cost incurred by the Commonwealth for said removal shall be borne by the licensee or permittee or by the person erecting, maintaining, using, posting or displaying the same, and the Director shall collect the same.

## ARTICLE XIII

### FINES AND VIOLATIONS

Section 15. Chapter 588 Acts of 1938: "Any person, firm or corporation violating any provision of this act for which violation no other penalty is prescribed by this act, shall be guilty of a misdemeanor and upon conviction thereof, shall be fined not less than ten dollars nor more than fifty dollars; each day during which such violation is continued after conviction may be treated for all purposes as a separate offense."

## ARTICLE XIV

These rules and regulations are intended to clarify the provisions of the act for the purpose of administration and enforcement thereof by the State Highway Commission.

Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that a 30 day extension of sick leave with pay be granted Mr. E. L. Beadles, Carpenter, from August 24th, 1938. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Massie, that a 30 day extension of sick leave with pay be granted Mr. L. W. Seyler, Senior Highway Equipment Repairman, from September 30th. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that a 30 day extension of sick leave with pay be granted Mr. W. E. Bradshaw, Junior Highway Superintendent, from October 31st. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the sick leave of Mr. F. R. Sorrell, Junior Highway Superintendent, be extended from December 16th to 31st inclusive, with pay. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Massie, that a 30 day extension of sick leave with pay be granted Mr. E. A. Midkiff, Senior Highway Equipment Operator, from November 25th. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that the sick leave of Mr. L. J. Allison, Jr., Highway Equipment Repairman, be extended thirty days with pay, from November 7th. Motion carried.

Moved by Mr. Massie, seconded by Mr. Wyszor, that permit No. 8253, Route 50, Arlington County, issued April 26th, 1938 to the Arlington County Board, be cancelled as requested. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that permit No. 1719, Route 170, Warwick County, issued August 19th, 1938, to the C and P Telephone Co. of Va., Newport News, Va., be cancelled as requested. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Massie, that permit No. 8629, Route 33 in Henrico County, issued October 11th, 1938, to Leslie G. Marr, Richmond, Va., be cancelled as requested. Motion carried.

Moved by Mr. Massie, seconded by Mr. Wyszor, that permit No. 6821, Route 1, Chesterfield County, issued March 29, 1938, to the Virginia Electric and Power Co., be cancelled as requested. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wyszor, that the Commission allocate the \$500.00 per mile construction funds for the year 1938-39 to the City of Portsmouth, to be spent on Routes 17 and 460 in the City. Motion carried.

Moved by Mr. Wyszor, seconded by Mr. Rawls, that the Commission allocate the \$500.00 per mile construction funds for the year 1938-39 to the City of Norfolk, to be applied against the construction of the Bridge over Southern Branch of Elizabeth River on Route 13. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that the Commission allocate the \$500.00 per mile construction funds for the year 1938-39 to the City of Staunton, to be expended on the completion of the south end of Route 11 in the City. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that the Commission allocate the \$500.00 per mile construction funds for the year 1938-39 to the City of Buena Vista, to be expended for the improvement of Routes 501 and 60 in the City. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wycor, that the request of Sanderson and Son and F. L. Houser, Cartersville, Va., for an extension of time on Project PAS 1329-D, Route C 615, 3.68 Mi. E. Int. Route 26-Int. Route 39, Charlotte County, be not granted, as recommended by the Chief Engineer. Motion carried.

Moved by Mr. Wycor, seconded by Mr. Massie, that the request of the Haynes Construction Company, Chatham, Va., for an extension of time on Project PAS 1323 F, Route 624, 0.8 Mi. E. ECL Bedford-3.1 Mi. E. ECL Bedford, be not granted, as recommended by the Chief Engineer. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that the request of the Hofheimer Construction Corporation, Norfolk, Va., for an extension of time on Project WPG6 1155 AEL, Route 644, 0.18 Mi. S. Norfolk-Southern RR--0.28 Mi. N. Norfolk-Southern RR., be granted for 20 days and return \$200.00 liquidated damages, as recommended by the Chief Engineer. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wycor, that the request of the Carpenter Construction Corporation, Norfolk, Va., for an extension of time on Project PA 1115 EL, Route 299, Bridge over Southern Branch Elizabeth River, be granted for 101 days, and return \$1010.00 liquidated damages, as recommended by the Chief Engineer. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Wycor, that the request of E. E. Bolling, Norton, Va., for an extension of time on Project WPGH 513 DE4, Route 25, Southern RR Underpass and Approaches at Big Stone Gap, be granted for 30 days and return \$300.00 liquidated damages, as recommended by the Chief Engineer. Motion carried.

Moved by Mr. Wycor, seconded by Mr. Rawls, that easement be granted to the City of Richmond for 1.654 sq. ft. on the northwest corner of the lot to be occupied by the new State Highway Commission office building, for the purpose only of widening the alley between the Memorial Hospital and the proposed site of the new Highway Commission Office Building. Motion carried.

A delegation appeared before the Commission concerning the construction of a bridge over New River and other permanent improvements leading to the proposed Celanese Corporation plant site in Giles County. Senator A. E. Shumate acted as spokesman; Mr. A. Schwartz represented the Celanese Corporation and stated that they would be ready to advertise for bids for the first unit by March, and that unit would employ approximately 1000 people. Mr. Carl Susholtz, President of the Virginian Railway Company, gave a brief outline of what his company planned to do in this connection and Mr. B. F. Moomaw of Roanoke, spoke at length relative to the benefits to be derived by such a plant being placed in the State.

Moved by Mr. Wycor, seconded by Mr. Massie, that prior to the next allocation of funds by the Highway Commission, a complete analysis of the anticipated traffic situation due to establishing the Celanese plant in Giles County will be made and that at its meeting to make allocations in the fall of 1939 careful consideration will be given by the Commission to provide adequate traffic facilities as far as it is consistent with funds available and traffic demands. Motion carried.

A delegation headed by Mr. W. T. Broadus of Dutton, appeared before the Commission relative to the location of Route 198, between Cash and Glenns, and bitterly opposed any plan that would change it to run between Cash and Owltrap. The Commission instructed Mr. Millem to notify Mr. Broadus that it being impossible to do any work on Route 198 within sixty to ninety days, the matter was postponed for the time being.


In connection with letter of November 16th from Mr. E. M. Evans, Regional Forester, United States Department of Agriculture, Washington, D.C., in regard to the closing of a section of State Route 43 which involves a portion of two cooperative Forest Highway projects, designated as NR 23 A1 and NR23 A2, for which there exists agreements in which the cooperator, which in this case is the Department of Highways, agrees to insure proper and permanent maintenance of these projects, it appears that pending further settlement of this matter it is the duty of the Highway Department to comply with these agreements; therefore it is moved by Mr. Rawls, and seconded by Mr. Massie, that the Department arrange for carrying out the agreements and continue maintenance on these sections covered under the two projects. Motion carried.

There being no further business, the meeting adjourned.
