a deed, without warranty, conveying same to Tom Johnson as consideration for the lands acquired, subject to such restrictions and conditions as may be deemed requisite.

WHEREAS, under Project 0083-025-110, RW-201, Route 83 was relocated in a northern direction and the new location serves the same citizens as the old location and has been approved by the State Highway and Transportation Commissioner; and

WHEREAS, the excess right of way was acquired in order to prevent a nuisance parcel lying between old Route 83 and new Route 83; and

WHEREAS, in order to more fully develop the adjacent lands, the adjoining landowner has requested that the Commonwealth convey to him the excess right of way so acquired; and

WHEREAS, the State Highway and Transportation Commissioner has certified in writing that the land containing 0.50 acre, more or less, and lying south of the south normal right of way limits of present Route 83, from a point approximately 105 feet opposite approximate Station 348+40 (office revised median centerline) to a point approximately 82 feet opposite approximate Station 352+40 (office revised median centerline) does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the State Highway System.
